## For An Act To Be Entitled

8 AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
9 IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF  
10 HUMAN SERVICES; AND FOR OTHER PURPOSES.

13 AN ACT FOR THE DEPARTMENT OF HUMAN  
14 SERVICES REAPPROPRIATION.

16  
17

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
19

20 SECTION 1. REAPPROPRIATION - DEPARTMENT OF HUMAN SERVICES - GENERAL  
21 IMPROVEMENT FUND. There is hereby appropriated, to the Department of Human  
22 Services, to be payable from the General Improvement Fund or its successor  
23 fund or fund accounts, for the Department of Human Services the following:

24 (A) Effective July 1, 2013, the balance of the appropriation provided  
25 in Item (A) Section 1 of Act 82 of 2012, for a grant to an organization for  
26 training, job readiness, and adult literacy services of former prisoners to  
27 be re-introduced into society, in a sum not to exceed.....\$3,750.

28 (B) Effective July 1, 2013, the balance of the appropriation provided  
29 in Item (B) Section 1 of Act 82 of 2012, for a grant to an organization for  
30 youth summer employment programs for tutoring, mentoring, educational,  
31 social, recreational, personal services and operating expenses, in a sum not  
32 to exceed.....\$3,750.

33 (C) Effective July 1, 2013, the balance of the appropriation provided  
34 in Item (D) Section 1 of Act 82 of 2012, for grants for operating expenses,  
35 equipment, maintenance and construction for Health Clinics, in a sum not to  
36 exceed.....\$25,857.

SECTION 2. REAPPROPRIATION - DIVISION OF ADMINISTRATIVE SERVICES -  
GENERAL IMPROVEMENT FUND. There is hereby appropriated, to the Department of  
Human Services - Division of Administrative Services, to be payable from the  
General Improvement Fund or its successor fund or fund accounts, for the  
Department of Human Services - Division of Administrative Services the  
following:

(A) Effective July 1, 2013, the balance of the appropriation provided  
in Item (A) Section 2 of Act 82 of 2012, for various maintenance, renovation,  
equipping, construction, acquisition, improvement, upgrade, and repair  
projects for all state-owned real property and facilities department-wide, in  
a sum not to exceed.....\$118,123.

(B) Effective July 1, 2013, the balance of the appropriation provided  
in Item (B) Section 2 of Act 82 of 2012, for grants and assistance to  
community organizations for maintenance and general operations, personal  
services, and construction expenses, in a sum not to exceed.....\$500.

(C) Effective July 1, 2013, the balance of the appropriation provided  
in Item (C) Section 2 of Act 82 of 2012, for various maintenance, renovation,  
equipping, construction, acquisition, improvement, upgrade and repair of real  
property and facilities department-wide, in a sum not to exceed  
.....\$10,000,000.

SECTION 3. REAPPROPRIATION - DIVISION OF BEHAVIORAL HEALTH SERVICES -  
GENERAL IMPROVEMENT FUND. There is hereby appropriated, to the Department of  
Human Services - Division of Behavioral Health, to be payable from the  
General Improvement Fund or its successor fund or fund accounts, for the  
Department of Human Services - Division of Behavioral Health the following:

(A) Effective July 1, 2013, the balance of the appropriation provided  
in Item (A) Section 5 of Act 82 of 2012, for the research, training,  
development for mental health, and operating expenses of mental health  
centers, in a sum not to exceed.....\$16,429.

(B) Effective July 1, 2013, the balance of the appropriation provided  
in Item (B) Section 5 of Act 82 of 2012, for a grant for Community Mental  
Health Centers for uncompensated care, in a sum not to exceed.....\$7,766.

(C) Effective July 1, 2013, the balance of the appropriation provided  
in Item (C) Section 5 of Act 82 of 2012, for maintenance, personal services

1 and operating expenses for grants for prevention and treatment programs,  
 2 community programs serving disabled individuals, and other community  
 3 development programs, in a sum not to exceed.....\$2,500.

4 (D) Effective July 1, 2013, the balance of the appropriation provided  
 5 in Item (D) Section 5 of Act 82 of 2012, for grants to Alcohol and Substance  
 6 Abuse Prevention and Treatment Programs and Prevention Resource Centers for  
 7 personal services and operating expenses, construction, improvements,  
 8 equipment, renovation and maintenance expenses, in a sum not to exceed  
 9 .....\$581.

10 (E) Effective July 1, 2013, the balance of the appropriation provided  
 11 in Item (F) Section 5 of Act 82 of 2012, for the construction, renovation and  
 12 equipping of a 30 bed Intensive Care Unit at the Arkansas Health Center, in a  
 13 sum not to exceed.....\$2,449,800.

14 (F) Effective July 1, 2013, the balance of the appropriation provided  
 15 in Item (G) Section 5 of Act 82 of 2012, for the construction, renovation and  
 16 equipping of Home-Style Residential Facilities at the Arkansas Health Center,  
 17 in a sum not to exceed.....\$1,088,800.

18 (G) Effective July 1, 2013, the balance of the appropriation provided  
 19 in Item (H) Section 5 of Act 82 of 2012, for the maintenance, renovation,  
 20 repair and equipping of shower rooms to accommodate new whirlpools for the  
 21 nursing units of Building 80 at the Arkansas Health Center, in a sum not to  
 22 exceed.....\$40,830.

23 (H) Effective July 1, 2013, the balance of the appropriation provided  
 24 in Item (I) Section 5 of Act 82 of 2012, for equipment and installation of a  
 25 wireless nurse call system at the Arkansas Health Center, in a sum not to  
 26 exceed.....\$40,830.

27 (I) Effective July 1, 2013, the balance of the appropriation provided  
 28 in Item (J) Section 5 of Act 82 of 2012, for the construction, renovation and  
 29 equipping of a storage facility at the Arkansas Health Center, in a sum not  
 30 to exceed.....\$190,540.

31 (J) Effective July 1, 2013, the balance of the appropriation provided  
 32 in Item (K) Section 5 of Act 82 of 2012, for the construction, renovation and  
 33 equipping of a laundry complex at the Arkansas Health Center, in a sum not to  
 34 exceed.....\$544,400.

35 (K) Effective July 1, 2013, the balance of the appropriation provided  
 36 in Item (U) Section 5 of Act 82 of 2012, for grants for Treatment Programs

1 for personal services and operating expenses, construction, improvements,  
2 equipment, renovation and maintenance expenses, in a sum not to exceed  
3 .....\$10,000.

5 SECTION 4. REAPPROPRIATION - DIVISION OF BEHAVIORAL HEALTH SERVICES -  
6 PAYING ACCOUNT. There is hereby appropriated, to the Department of Human  
7 Services - Division of Behavioral Health, to be payable from the paying  
8 account as determined by the Chief Fiscal Officer of the State, for the  
9 Department of Human Services - Division of Behavioral Health the following:

10 (A) Effective July 1, 2013, the balance of the appropriation provided  
11 in Item (A) Section 6 of Act 82 of 2012, for the construction, renovation and  
12 equipping of a 30 bed Intensive Care Unit at the Arkansas Health Center, in a  
13 sum not to exceed.....\$6,550,200.

14 (B) Effective July 1, 2013, the balance of the appropriation provided  
15 in Item (B) Section 6 of Act 82 of 2012, for the construction, renovation and  
16 equipping of Home-Style Residential Facilities at the Arkansas Health Center,  
17 in a sum not to exceed.....\$2,911,200.

18 (C) Effective July 1, 2013, the balance of the appropriation provided  
19 in Item (C) Section 6 of Act 82 of 2012, for the maintenance, renovation,  
20 repair and equipping of shower rooms to accommodate new whirlpools for the  
21 nursing units of Building 80 at the Arkansas Health Center, in a sum not to  
22 exceed.....\$109,170.

23 (D) Effective July 1, 2013, the balance of the appropriation provided  
24 in Item (D) Section 6 of Act 82 of 2012, for equipment and installation of a  
25 wireless nurse call system at the Arkansas Health Center, in a sum not to  
26 exceed.....\$109,170.

27 (E) Effective July 1, 2013, the balance of the appropriation provided  
28 in Item (E) Section 6 of Act 82 of 2012, for the construction, renovation and  
29 equipping of a storage facility at the Arkansas Health Center, in a sum not  
30 to exceed.....\$509,460.

31 (F) Effective July 1, 2013, the balance of the appropriation provided  
32 in Item (F) Section 6 of Act 82 of 2012, for the construction, renovation and  
33 equipping of a laundry complex at the Arkansas Health Center, in a sum not to  
34 exceed.....\$1,455,600.

36 SECTION 5. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor

1 obligations otherwise incurred in relation to the project or projects  
2 described herein in excess of the State Treasury funds actually available  
3 therefor as provided by law. Provided, however, that institutions and  
4 agencies listed herein shall have the authority to accept and use grants and  
5 donations including Federal funds, and to use its unobligated cash income or  
6 funds, or both available to it, for the purpose of supplementing the State  
7 Treasury funds for financing the entire costs of the project or projects  
8 enumerated herein. Provided further, that the appropriations and funds  
9 otherwise provided by the General Assembly for Maintenance and General  
10 Operations of the agency or institutions receiving appropriation herein shall  
11 not be used for any of the purposes as appropriated in this act.

12 (B) The restrictions of any applicable provisions of the State Purchasing  
13 Law, the General Accounting and Budgetary Procedures Law, the Revenue  
14 Stabilization Law and any other applicable fiscal control laws of this State  
15 and regulations promulgated by the Department of Finance and Administration,  
16 as authorized by law, shall be strictly complied with in disbursement of any  
17 funds provided by this act unless specifically provided otherwise by law.

18  
19 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General  
20 Assembly that any funds disbursed under the authority of the appropriations  
21 contained in this act shall be in compliance with the stated reasons for  
22 which this act was adopted, as evidenced by the Agency Requests, Executive  
23 Recommendations and Legislative Recommendations contained in the budget  
24 manuals prepared by the Department of Finance and Administration, letters, or  
25 summarized oral testimony in the official minutes of the Arkansas Legislative  
26 Council or Joint Budget Committee which relate to its passage and adoption.

27  
28 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General  
29 Assembly, that the Constitution of the State of Arkansas prohibits the  
30 appropriation of funds for more than a one (1) year period; that the  
31 effectiveness of this Act on July 1, 2013 is essential to the operation of  
32 the agency for which the appropriations in this Act are provided, and that in  
33 the event of an extension of the legislative session, the delay in the  
34 effective date of this Act beyond July 1, 2013 could work irreparable harm  
35 upon the proper administration and provision of essential governmental  
36 programs. Therefore, an emergency is hereby declared to exist and this Act

1 being necessary for the immediate preservation of the public peace, health  
2 and safety shall be in full force and effect from and after July 1, 2013.
