20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 6-19-102(d), concerning authority to
23 transport public school students, is amended to read as follows:

24 (d) A bus or other vehicle used in transporting pupils in one (1)
25 district shall not be used to transport pupils in another district without
26 the consent of the Department of Education, except as specifically allowed by
27 law.
28

29 SECTION 2. Arkansas Code § 6-19-110(a)(2)(A), concerning school bus
30 drivers, is amended to read as follows:

31 (2)(A) "School bus" means a motor vehicle designed to carry ~~more~~
32 ~~than~~ ten (10) or more passengers that is:

33 (i) Owned by a public or a governmental agency or a
34 private school and operated for the transportation of students to or from
35 school or school-sponsored activities; or

36 (ii) Privately owned and operated for compensation



1 for the transportation of students to or from school or school-sponsored
 2 activities.

 4 SECTION 3. Arkansas Code § 6-19-111(a), concerning school bus
 5 regulations, is amended to read as follows:

6 (a) ~~The State Board of Education by and with the advice of the State~~
 7 ~~Highway Commission~~ Commission for Arkansas Public School Academic Facilities
 8 and Transportation shall adopt and enforce regulations ~~not inconsistent with~~
 9 ~~this act~~ to govern the design and operation of all school buses used for the
 10 transportation of school children when the buses are owned and operated by
 11 ~~any~~ a school district or privately owned and operated under contract with ~~any~~
 12 a school district in this state.

13
 14 SECTION 4. Arkansas Code § 6-19-117(a)(1), concerning school bus
 15 safety equipment, is amended to read as follows:

16 (a) As used in this section, "school bus" means:

17 (1) A motor vehicle designed to carry ~~more than~~ ten (10) or more
 18 passengers that is:

19 (A) Owned by a public or a governmental agency or a
 20 private school and operated for the transportation of students to or from
 21 school or school-sponsored activities; or

22 (B) Privately owned and operated for compensation for the
 23 transportation of students to or from school or school-sponsored activities;
 24 and

 26 SECTION 5. Arkansas Code § 6-19-119(a)(1), concerning school bus
 27 passengers required to be seated, is amended to read as follows:

28 (a) As used in this section, "school bus" means:

29 (1) A motor vehicle designed to carry ~~more than~~ ten (10) or more
 30 passengers that is:

31 (A) Owned by a public or a governmental agency or a
 32 private school and operated for the transportation of students to or from
 33 school or school-sponsored activities; or

34 (B) Privately owned and operated for compensation for the
 35 transportation of students to or from school or school-sponsored activities;
 36 and

2 SECTION 6. Arkansas Code § 6-20-2305(b)(5)(C)(iv), concerning school
3 funding, is amended to read as follows:

4 (iv) Provide training for school bus drivers as
5 outlined in rules promulgated by the ~~State Board of Education~~ Commission for
6 Arkansas Public School Academic Facilities and Transportation.

7
8 SECTION 7. Arkansas Code § 6-21-116(b), concerning tornado shelter
9 construction, is amended to add an additional subdivision to read as follows:

10 (3) In calculating the amount of state financial participation
11 in a facilities project that includes a tornado shelter or designated
12 reinforced area, the Division of Public School Academic Facilities and
13 Transportation shall deduct from the project cost the total amount of grant
14 funds received by the school district for the shelter or area.
