14 TO ESTABLISH THE ARKANSAS COURT APPOINTED
15 SPECIAL ADVOCATES LICENSE PLATE.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14, is
22 amended to add an additional section to read as follows:

23 27-24-1411. Support of Court Appointed Special Advocates.

24 (a) The Director of the Department of Finance and Administration shall
25 issue a special license plate for support of the Arkansas Court Appointed
26 Special Advocates program in the manner and subject to the conditions
27 provided for under this subchapter.

28 (b) The special motor vehicle license plate shall be:

29 (1)(A) Designed by the Arkansas State CASA Association.

30 (B) The design shall be submitted for design approval by
31 the director under rules promulgated by the director; and

32 (2) Numbered consecutively.

33 (c) The director shall determine the amount of the costs for the
34 issuance of the special license plate under this section as follows:

35 (1) The fee for the cost of initial orders of the new design,
36 which shall be based on the cost of the initial order;



1 (2) The number of applications that must be received to cover
 2 the cost of the initial order of the new design; or

3 (3) The combination of subdivisions (c)(1) and (2) of this
 4 section that must be received to cover the cost of the initial order of the
 5 new design.

6 (d) The Department of Finance and Administration shall issue a special
 7 license plate under this section upon payment of:

8 (1) The fee required by law for registration of the motor
 9 vehicle;

10 (2)(A) Twenty-five dollars (\$25.00) to cover the design-use
 11 contribution.

12 (B) The design-use contribution shall be remitted monthly
 13 to the Arkansas Court Appointed Special Advocates Program Fund to be used for
 14 fund purposes; and

15 (3)(A) A handling and administrative fee of ten dollars
 16 (\$10.00).

17 (B) The handling and administrative fee shall be:

18 (i) Deposited into the State Central Services Fund
 19 for the benefit of the Revenue Division of the Department of Finance and
 20 Administration; and

21 (ii) Credited to the division as supplemental and in
 22 addition to all other funds that may be deposited for the benefit of the
 23 division.

24 (C) The handling and administrative fee shall not be
 25 considered or credited to the division as direct revenue.

26 (e)(1) A special license plate issued under this section may be
 27 renewed annually or replaced under the procedures set out in § 27-24-1405.

28 (2) However, the division shall remit the fees collected under §
 29 27-24-1405(b)(2) on a monthly basis to the fund.

31 SECTION 2. Arkansas Code Title 19, Chapter 6, Subchapter 8, is
 32 amended to add an additional section to read as follows:

33 19-6-819. Arkansas Court Appointed Special Advocates Program
 34 Fund.

35 (a) There is created on the books of the Treasurer of State, the
 36 Auditor of State, and the Chief Fiscal Officer of the State a special revenue

1 fund to be known as the "Arkansas Court Appointed Special Advocates Program
2 Fund".

3 (b) The fund shall consist of such revenues as may be authorized by
4 law.

5 (c) The fund shall be used for providing program support for local
6 offices of the Arkansas Court Appointed Special Advocates program.

7
8 SECTION 3. EFFECTIVE DATE. This act is effective on and after January
9 1, 2014.
