15 TO ALLOW A COUNTY TO ABOLISH THE POSITION
16 OF SCHOOL DISTRICT COORDINATOR; AND TO
17 AMEND PROVISIONS OF LAW CONCERNING COUNTY
18 FUNDS FOR THE EXECUTIVE COUNCIL AND
19 SCHOOL COORDINATOR POSITION.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. Arkansas Code § 6-12-315, concerning school district
26 coordinators, is amended to add an additional subsection to read as follows:

27 (d) A county in which there has not been a school district coordinator
28 under this section for five (5) years or more may abolish the position.
29

30 SECTION 2. Arkansas Code Title 14, Chapter 21, Subchapter 1, is
31 amended to add an additional section to read as follows:

32 14-21-109. Transfer of funds designated for abolished positions.
33 If county funds are designated for a specific position in the county
34 and the position is subsequently abolished, the county court, by appropriate
35 order, may transfer any remaining balance of county funds designated for that
36 purpose to the county general revenue fund to be used for all purposes for



1 which the county general revenue fund may be used.

3 SECTION 3. Arkansas Code § 26-36-209(c)(2), concerning the
4 distribution of penalties collected on delinquent personal property taxes, is
5 amended to read as follows:

6 (2) All penalties shall be deposited as county revenues in the
7 county general fund unless a county has a functioning executive council and
8 full-time school district coordinator established under § 6-12-315, in which
9 case the penalties shall be divided fifty percent (50%) to the county general
10 fund and fifty percent (50%) to the county common school fund ~~if that~~
11 ~~county's common school fund was getting fifty percent (50%) at the time of~~
12 ~~the enactment of this subsection.~~
