14 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

16 RESTRICTIONS ON FUNDS APPROPRIATED TO THE COMMUNITY INVESTMENT INITIATIVE.

17 Funds appropriated for Community Investment Funds from the Temporary
 18 Assistance for Needy Families (TANF) Block Grant for the fiscal years ~~2011-~~
 19 ~~2012~~ 2013-2014 and ~~2012-2013~~ 2014-2015 (combined) shall be subject to these
 20 restrictions in their use for the specified statutory purposes to the extent
 21 the funds are available:

- 22 (1) improving outcomes for youth (at least \$1,000,000),
- 23 (2) parenting and family functioning (at least \$500,000),
- 24 (3) marriage and relationship skills (at least \$500,000),
- 25 (4) fatherhood programs (at least \$500,000),
- 26 (5) family and employment services for ex-offenders (at least
 27 \$500,000), and
- 28 (6) services to child-only TEA cases (at least \$500,000).

30 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

32 SUSPENSION OR REDUCTION OF FUNDS APPROPRIATED TO THE COMMUNITY INVESTMENT

33 INITIATIVE. Spending for the Community Investment Initiative can be
 34 suspended or reduced if the Director of the Department of Workforce Services
 35 and the Transitional Employment Board certify that

- 36 a) Funding from the Temporary Assistance for Needy Families block grant

1 is needed to support a critical economic development initiative,

2 b) Other funds from the Temporary Assistance for Needy Families block
3 grant are not available beyond those needed for the operation of the TEA,
4 Work Pays and High Wage Education and Training Programs and for an adequate
5 reserve for possible increases in cash assistance during the current fiscal
6 year, and

7 c) Spending for the economic development initiative is allowable within
8 the federal rules governing the Temporary Assistance for Needy Families Block
9 Grant.

10 Certification of these conditions shall be made to the Governor and the Chief
11 Fiscal Officer of the State and notification shall be made to the Legislative
12 Council and the Senate and House Public Health and Welfare Committees.

13 If spending on the Community Investment Initiative is reduced, these
14 reductions shall be assessed proportionately to the funds designated by the
15 TEA Board for each of the six statutory purposes of the Community Investment
16 Initiative.

17 The provisions of this section shall be in effect only from July 1, ~~2012~~
18 2013 through June 30, ~~2013~~ 2014.

19
20 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
22 FORWARD - NEW HIRE REGISTRY. Any balance in the funds made available by this
23 Act for the New Hire Registry which remain on June 30, ~~2013~~ 2014, may be
24 carried forward into the next fiscal year, to be used for the same purpose.

25 Any carry forward of unexpended balance of funding as authorized herein,
26 may be carried forward under the following conditions:

27 (1) Prior to June 30, ~~2013~~ 2014 the Agency shall by written statement
28 set forth its reason(s) for the need to carry forward said funding to the
29 Department of Finance and Administration Office of Budget;

30 (2) The Department of Finance and Administration Office of Budget shall
31 report to the Arkansas Legislative Council all amounts carried forward by the
32 September Arkansas Legislative Council or Joint Budget Committee meeting
33 which report shall include the name of the Agency, Board, Commission or
34 Institution and the amount of the funding carried forward, the program name
35 or line item, the funding source of that appropriation and a copy of the
36 written request set forth in (1) above;

1 (3) Each Agency, Board, Commission or Institution shall provide a
 2 written report to the Arkansas Legislative Council or Joint Budget Committee
 3 containing all information set forth in item (2) above, along with a written
 4 statement as to the current status of the project, contract, purpose etc. for
 5 which the carry forward was originally requested no later than thirty (30)
 6 days prior to the time the Agency, Board, Commission or Institution presents
 7 its budget request to the Arkansas Legislative Council/Joint Budget
 8 Committee; and

9 (4) Thereupon, the Department of Finance and Administration shall
 10 include all information obtained in item (3) above in the budget manuals
 11 and/or a statement of non-compliance by the Agency, Board, Commission or
 12 Institution.

13
 14 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 16 HELP. There is hereby authorized, for the Department of Workforce Services
 17 for the ~~2012-2013~~ 2013-2014 fiscal year, the following maximum number of
 18 part-time or temporary employees, to be known as "Extra Help", payable from
 19 funds appropriated herein for such purposes: three hundred eighty-four (384)
 20 temporary or part-time employees, when needed, at rates of pay not to exceed
 21 those provided in the Uniform Classification and Compensation Act, or its
 22 successor, for the appropriate classification. Any of these positions
 23 utilized in a manner which are funded by federal sources are specifically
 24 exempt from limitation of hours, either by Act or Regulation.

25 In order to comply with the timeliness requirements set forth by the
 26 Social Security Act, the Chairman of the Board of Review is authorized to
 27 utilize part-time or temporary employees from the pool of positions provided
 28 to the Department of Workforce Services in any occurrence where the number of
 29 appeals to the Board of Review or Appeal Tribunal increases above a level
 30 that can be resolved by the permanent staff in a timely manner. The
 31 Department of Workforce services will determine the appropriate funding
 32 source within the Department for said positions.

33 The provisions of this section shall be in effect only from July 1, ~~2012~~
 34 2013 through June 30, ~~2013~~ 2014.

35
 36 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. "REED ACT
2 FUNDS". Funds received by the State may be used as specified in 903 of the
3 Social Security Act, for the purpose of construction and improvement of
4 buildings, rent/lease costs, acquisition of land, the payment of salaries and
5 related benefits of central and local office staff, maintenance and operation
6 of central and local offices, payment of unemployment insurance benefits, or
7 as otherwise prescribed in Section 903 of the Social Security Act, as
8 amended.

9 The amount obligated pursuant to this Act shall not exceed the amount by
10 which (a) the aggregate of the amounts transferred to the account of this
11 State pursuant to Section 903 of the Social Security Act exceeds (b) the
12 aggregate of the amounts used by this State and charged against the amounts
13 transferred to the account of this State.

14 The provisions of this section shall be in effect only from July 1, ~~2012~~
15 2013 through June 30, ~~2013~~ 2014.

16
17 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
19 ADDITIONAL POSITIONS. The Director of the Department of Workforce Services,
20 after receiving the approval of the Office of Personnel Management, and after
21 seeking the prior review by the Arkansas Legislative Council, shall have the
22 authority to establish such new or additional full time positions as may
23 become necessary to carry out the objectives of the program and/or to meet
24 Federal requirements of new and/or expanded programs where such needs are
25 financed by federal funds; provided that not more than two hundred persons
26 may be employed in addition to those authorized in the salary schedule and
27 that the rate of pay shall not exceed those set out in the salary schedule
28 for comparable positions as authorized under the provisions of Section 1 of
29 this Act.

30 If the agency requests continuation of a "Growth Pool" position(s) as
31 established herein, the position(s) must be requested as a new position(s) in
32 the agency's budget request.

33 The provisions of this section shall be in effect only from July 1, ~~2012~~
34 2013 through June 30, ~~2013~~ 2014.

35
36 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
2 OF APPROPRIATION. Subject to such rules and regulations as may be
3 implemented by the Chief Fiscal Officer of the State and after having sought
4 the prior approval by the Arkansas Legislative Council or Joint Budget
5 Committee, the Director of the Department of Workforce Services is hereby
6 authorized to make transfers from any appropriation made by this Act to any
7 other appropriation made by this Act with the exception of the "Reed Act
8 Funds" appropriations set forth in Section 8 of this Act, and of the
9 appropriation made for Regular Salaries or Maintenance and General Operation.
10 Such transfers may be made whenever it appears, by projecting the
11 expenditures of any of the appropriations in this Act, that there will be a
12 deficiency of appropriation in one item and that there will be a
13 corresponding excess of appropriation in another item or items which may be
14 transferred. The transfer of appropriation shall be effected only on
15 approval of the Chief Fiscal Officer of the State. Provided, however, that no
16 transfer of appropriations may be authorized to increase the total amount
17 appropriated for Regular Salaries, or Maintenance and General Operations,
18 except as may be authorized elsewhere by law.

19 Determining the maximum number of employees and the maximum amount of
20 appropriation and general revenue funding for a state agency each fiscal year
21 is the prerogative of the General Assembly. This is usually accomplished by
22 delineating such maximums in the appropriation act(s) for a state agency and
23 the general revenue allocations authorized for each fund and fund account by
24 amendment to the Revenue Stabilization law. Further, the General Assembly
25 has determined that the Department of Workforce Services may operate more
26 efficiently if some flexibility is provided to the Department of Workforce
27 Services authorizing broad powers under this Section. Therefore, it is both
28 necessary and appropriate that the General Assembly maintain oversight by
29 requiring prior approval of the Legislative Council or Joint Budget Committee
30 as provided by this section. The requirement of approval by the Legislative
31 Council or Joint Budget Committee is not a severable part of this section.
32 If the requirement of approval by the Legislative Council or Joint Budget
33 Committee is ruled unconstitutional by a court of competent jurisdiction,
34 this entire section is void.

35 The provisions of this section shall be in effect only from July 1, ~~2012~~
36 2013 through June 30, ~~2013~~ 2014.

1
2 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. INTER-
4 AGENCY TRANSFER OF STATE GENERAL REVENUE FOR THE TEMPORARY ASSISTANCE FOR
5 NEEDY FAMILIES (TANF) PROGRAMS. Upon the request of the Director of the
6 Department of Human Services (DHS) and the Director of the Department of
7 Workforce Services (DWS), the Chief Fiscal Officer of the State may approve
8 up to three million six hundred forty thousand six hundred fifty dollars
9 (\$3,640,650) each fiscal year in State General Revenue appropriated to DWS
10 for the TANF program to be transferred to the DHS - Division of County
11 Operations in support of Arkansas' TANF Programs or any related separate
12 state programs.

13 The Director of the Department of Workforce Services shall provide a
14 report of all transfers made to the DHS - Division of County Operations to
15 the Performance Evaluation and Expenditure Review Committee of the Arkansas
16 Legislative Council and Joint Budget Committee. The report must include the
17 justification for and the amount of the completed transfers.

18 The provisions of this section shall be in effect only from July 1, ~~2012~~
19 2013 through June 30, ~~2013~~ 2014.

20
21 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
23 OF TANF BLOCK GRANT FUNDS. Each fiscal year, the Department of Workforce
24 Services shall transfer the sum of seven million five hundred thousand
25 dollars (\$7,500,000) from the state's federal Temporary Assistance for Needy
26 Families block grant to the Department of Education Public School Fund
27 Account to be used solely for the Arkansas Better Chance Program.

28 If the state match for the Temporary Assistance for Needy Families grant
29 or the state's Temporary Assistance for Needy Families grant is reduced, the
30 amount to be transferred may be adjusted in proportion to the percentage
31 change in the state match or the state's Temporary Assistance for Needy
32 Families grant. The amount to be transferred may also be reduced
33 proportionately if new cost requirements are imposed upon the state as a
34 result of new or revised Temporary Assistance for Needy Families regulations
35 at the federal level.

36 The provisions of this section shall be in effect only from July 1, ~~2012~~

1 2013 through June 30, ~~2013~~ 2014.

2
 3 SECTION 23. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 4 authorized by this act shall be limited to the appropriation for such agency
 5 and funds made available by law for the support of such appropriations; and
 6 the restrictions of the State Procurement Law, the General Accounting and
 7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 8 Procedures and Restrictions Act, or their successors, and other fiscal
 9 control laws of this State, where applicable, and regulations promulgated by
 10 the Department of Finance and Administration, as authorized by law, shall be
 11 strictly complied with in disbursement of said funds.

12
 13 SECTION 24. LEGISLATIVE INTENT. It is the intent of the General
 14 Assembly that any funds disbursed under the authority of the appropriations
 15 contained in this act shall be in compliance with the stated reasons for
 16 which this act was adopted, as evidenced by the Agency Requests, Executive
 17 Recommendations and Legislative Recommendations contained in the budget
 18 manuals prepared by the Department of Finance and Administration, letters, or
 19 summarized oral testimony in the official minutes of the Arkansas Legislative
 20 Council or Joint Budget Committee which relate to its passage and adoption.

21
 22 SECTION 25. EMERGENCY CLAUSE. It is found and determined by the
 23 General Assembly, that the Constitution of the State of Arkansas prohibits
 24 the appropriation of funds for more than a one (1) year period; that the
 25 effectiveness of this Act on July 1, 2013 is essential to the operation of
 26 the agency for which the appropriations in this Act are provided, and that in
 27 the event of an extension of the legislative session, the delay in the
 28 effective date of this Act beyond July 1, 2013 could work irreparable harm
 29 upon the proper administration and provision of essential governmental
 30 programs. Therefore, an emergency is hereby declared to exist and this Act
 31 being necessary for the immediate preservation of the public peace, health
 32 and safety shall be in full force and effect from and after July 1, 2013.
