20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES. There is hereby established for the

 15 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

17 PROMOTIONAL ITEMS. The Department of Arkansas State Police is hereby
 18 authorized to purchase from Maintenance & General Operations Classifications
 19 in the Operations Appropriation provided by this Act, up to an amount not to
 20 exceed \$2,500 each fiscal year, promotional items, authorized by the Director
 21 of the Department to meet requirements of the Arkansas State Police Strategic
 22 Recruitment Plan.

23 The provisions of this section shall be in effect only from July 1, ~~2013~~
 24 2014 through June 30, ~~2014~~ 2015.

25
 26 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COURT
 28 AWARDS FUND TRANSFER PROVISION. Monies deposited in the Court Awards Fund
 29 each fiscal year may be used for motor vehicle purchases and associated taxes
 30 and/or motor vehicle equipping and renovation costs, overtime, personal
 31 services matching, agency operational needs and capital improvements for the
 32 Department of Arkansas State Police. Provided however, funds received from
 33 the Special State Assets Forfeiture Fund shall be deposited into the Court
 34 Awards Fund to be used by the Department of Arkansas State Police for law
 35 enforcement purposes consistent with governing federal law. The Department
 36 of Arkansas State Police may also request a fund transfer from the Court

1 Awards Fund or the Department of Arkansas State Police Fund to the Motor
2 Vehicle Acquisition Revolving Fund. The provisions of this section shall be
3 subject to prior review and approval of the Arkansas Legislative Council or
4 Joint Budget Committee.

5 Determining the maximum number of employees and the maximum amount of
6 appropriation and general revenue funding for a state agency each fiscal year
7 is the prerogative of the General Assembly. This is usually accomplished by
8 delineating such maximums in the appropriation act(s) for a state agency and
9 the general revenue allocations authorized for each fund and fund account by
10 amendment to the Revenue Stabilization law. Further, the General Assembly
11 has determined that the Department of Arkansas State Police may operate more
12 efficiently if some flexibility is provided to the Department of Arkansas
13 State Police authorizing broad powers under this Section. Therefore, it is
14 both necessary and appropriate that the General Assembly maintain oversight
15 by requiring prior approval of the Legislative Council or Joint Budget
16 Committee as provided by this section. The requirement of approval by the
17 Legislative Council or Joint Budget Committee is not a severable part of this
18 section. If the requirement of approval by the Legislative Council or Joint
19 Budget Committee is ruled unconstitutional by a court of competent
20 jurisdiction, this entire section is void.

24 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
26 PROVISION. The Department of Arkansas State Police is hereby authorized,
27 after seeking the approval of the Chief Fiscal Officer of the State, to
28 request transfer from the appropriation made herein for "Confiscated Funds
29 Transfer" to the Overtime, Personal Services Matching, and Maintenance and
30 General Operations classifications established in the operations
31 appropriation of the Department of Arkansas State Police, and may be used for
32 overtime, personal services matching, motor vehicle purchases and associated
33 taxes and/or motor vehicle equipping/renovation costs, agency operational
34 needs and capital improvements for the Department of Arkansas State Police.
35 Fund transfers may be requested from the Court Awards Fund to the Department
36 of Arkansas State Police Fund in the same amount and for the same purposes as

1 the appropriation transfer requested under the provisions of this section.
2 The provisions of this section shall be subject to prior review and approval
3 of the Arkansas Legislative Council or Joint Budget Committee.

4 Determining the maximum number of employees and the maximum amount of
5 appropriation and general revenue funding for a state agency each fiscal year
6 is the prerogative of the General Assembly. This is usually accomplished by
7 delineating such maximums in the appropriation act(s) for a state agency and
8 the general revenue allocations authorized for each fund and fund account by
9 amendment to the Revenue Stabilization law. Further, the General Assembly
10 has determined that the Department of Arkansas State Police may operate more
11 efficiently if some flexibility is provided to the Department of Arkansas
12 State Police authorizing broad powers under this Section. Therefore, it is

23 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR
25 VEHICLE ACQUISITION REVOLVING FUND – MOTOR VEHICLE PURCHASES/RENOVATION. At
26 least fifty percent (50%) of the general revenues and/or general improvement
27 funds deposited into the Motor Vehicle Acquisition Revolving Fund shall be
28 used for motor vehicle purchases and/or motor vehicle renovation costs for
29 the Department of Arkansas State Police.

30 The provisions of this section shall be in effect only from July 1, ~~2013~~
31 2014 through June 30, ~~2014~~ 2015.

32
33 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OVERTIME.
35 The Department of Arkansas State Police is hereby authorized to make overtime
36 payments from such funds and appropriations provided for overtime payments to

1 those officers or other employees that are currently assigned or may be
2 assigned by the Director of the Department of Arkansas State Police to
3 Special Law Enforcement Task Forces and other special programs reimbursable
4 to Arkansas State Police by federal or local authorities as approved by the
5 Director of the Department of Arkansas State Police. All such overtime
6 payments shall be processed through the State Accounting System and shall be
7 in addition to the Regular Salaries and benefits accruing to the employee.

8 The provisions of this section shall be in effect only from July 1, ~~2013~~
9 2014 through June 30, ~~2014~~ 2015.

10
11 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR
13 VEHICLE PURCHASE. The Department of Arkansas State Police is hereby
14 authorized to purchase motor vehicles from the appropriations authorized for
15 Capital Outlay in the State Police Operations appropriation in this Act.
16 Motor vehicles donated to Arkansas State Police and confiscated vehicles used
17 for Arkansas State Police operations shall not be included in the maximum
18 number of authorized passenger vehicles.

19 The provisions of this section shall be in effect only from July 1, ~~2013~~
20 2014 through June 30, ~~2014~~ 2015.

21
22 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. UNIFORM
24 EMPLOYEE HEALTH INSURANCE PROGRAM REPORTING. The Department of Arkansas
25 State Police shall report monthly to the Governor, the Chief Fiscal Officer
26 of the State and to the Arkansas Legislative Council or Joint Budget
27 Committee regarding the activity and condition for the uniformed employee
28 health insurance plan. The report shall include, but not limited to, the
29 beginning reserve fund balance, contributions made during the month, claims
30 paid, and the ending fund balance of the month. In the event it is determined
31 that the cost to adequately maintain the uniform employee health insurance
32 plan is not feasible within the existing resources available to the
33 department, the 89th General Assembly shall study the feasibility and
34 desirability of discontinuing the self-insurance program and instead provide
35 medical and hospital insurance to uniform employees through the public
36 employees insurance program.

1 The provisions of this section shall be in effect only from July 1, ~~2013~~
2 2014 through June 30, ~~2014~~ 2015.

3
4 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
6 EXTRAORDINARY EXPENSES. The Department of Arkansas State Police is hereby
7 authorized to purchase from Maintenance & Operations Classifications in the
8 Operations Appropriation provided by in this Act, up to an amount not to
9 exceed two thousand five hundred dollars (\$2,500) each fiscal year, for
10 emergency purchases for food, drinks and other essential items during
11 emergency operations only when authorized by the Agency Director. During an
12 emergency, an ASP employee may be designated and authorized, by the Director,
13 to incur expenses for all deployed personnel.

14 The provisions of this section shall be in effect only from July 1, ~~2013~~
15 2014 through June 30, ~~2014~~ 2015.

16
17 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FLAGS.
19 The Department of Arkansas State Police is hereby authorized to award one (1)
20 United States flag to the family of any Arkansas State Police Commissioned
21 Officer killed in the line of duty. This provision will be effective for
22 Arkansas State Police Commissioned Officers killed in the line of duty after
23 July 1, 2011.

24 The provisions of this section shall be in effect only from July 1,
25 ~~2013~~ 2014 to June 30, ~~2014~~ 2015.

26
27 SECTION 22. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
28 authorized by this act shall be limited to the appropriation for such agency
29 and funds made available by law for the support of such appropriations; and
30 the restrictions of the State Procurement Law, the General Accounting and
31 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
32 Procedures and Restrictions Act, or their successors, and other fiscal
33 control laws of this State, where applicable, and regulations promulgated by
34 the Department of Finance and Administration, as authorized by law, shall be
35 strictly complied with in disbursement of said funds.

36

1 SECTION 23. LEGISLATIVE INTENT. It is the intent of the General
 2 Assembly that any funds disbursed under the authority of the appropriations
 3 contained in this act shall be in compliance with the stated reasons for
 4 which this act was adopted, as evidenced by the Agency Requests, Executive
 5 Recommendations and Legislative Recommendations contained in the budget
 6 manuals prepared by the Department of Finance and Administration, letters, or
 7 summarized oral testimony in the official minutes of the Arkansas Legislative
 8 Council or Joint Budget Committee which relate to its passage and adoption.

9
 10 SECTION 24. EMERGENCY CLAUSE. It is found and determined by the
 11 General Assembly, that the Constitution of the State of Arkansas prohibits
 12 the appropriation of funds for more than a one (1) year period; that the
 13 effectiveness of this Act on July 1, 2014 is essential to the operation of
 14 the agency for which the appropriations in this Act are provided, and that in
 15 the event of an extension of the legislative session, the delay in the
 16 effective date of this Act beyond July 1, 2014 could work irreparable harm
 17 upon the proper administration and provision of essential governmental
 18 programs. Therefore, an emergency is hereby declared to exist and this Act
 19 being necessary for the immediate preservation of the public peace, health
 20 and safety shall be in full force and effect from and after July 1, 2014.
