13 AN ACT TO AMEND THE ARKANSAS REVENUE
14 STABILIZATION LAW OF ARKANSAS.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 SECTION 1. The purpose of this act is to amend the Revenue
20 Stabilization Law.
21

22 SECTION 2. Arkansas Code § 19-5-307(b) concerning revenues for the
23 Public Health Fund, is amended to read as follows:

24 (b) The Public Health Fund shall consist of:

25 (1) Those special revenues as set out in § 19-6-301(41), (65), (68),
26 (69), (80), (97), (131), (132), (133), (136), (137), (140), (141), (142),
27 (143), (144), (147), (155), (166), (177), (194), (204), ~~and~~ (205), (250), and
28 that portion of § 19-6-301(58) of the Revenue Classification Law, § 19-6-101
29 et seq.;

30 (2) General revenues as may be provided by law;

31 (3) Nonrevenue income derived from services provided by the various
32 divisions of the department;

33 (4) Federal reimbursement received on account of eligible expenditures
34 by the various divisions of the Department of Health;

35 (5) Other funds as may be provided by law;

36 (6) Moneys transferred or deposited from the State Administration of



1 Justice Fund to support alcoholism treatment programs and for use in the drug
2 abuse prevention and treatment program of the Division of Behavioral Health
3 Services; ~~and~~

4 (7) Amusement machine revenues over thirty thousand dollars (\$30,000),
5 as set out in § 26-57-407-~~r~~; and

6 (8) Criminal, civil and administrative penalties collected under the
7 Arkansas Lead-Based Paint-Hazard Act of 2011; § 20-27-2504.

8

9 SECTION 3. Arkansas Code § 19-5-993(b)(1) concerning revenues for the
10 State Administration of Justice Fund, is amended to read as follows:

11 (b)(1) The fund shall consist of court costs and filing fees under §§ 16-10-
12 305, 16-17-705, 9-15-202, 16-90-1419(b)(1) and 21-6-403, the special revenues
13 from real estate transfer taxes under § 19-6-301(117), district court
14 installment fees under § 16-13-704(b)(3)(E)(ii), and any interest earned.

15

16 SECTION 4. Arkansas Code § 19-5-1083(b) concerning revenues for the
17 Arkansas Counties Alcohol and Drug Abuse and Crime Prevention Program Fund,
18 is amended to read as follows:

19 (b) This fund shall consist of those moneys transferred or deposited from
20 the State Administration of Justice Fund, and non-refundable administrative
21 bail bond fees collected under § 17-19-301(f)(1), there to be used
22 exclusively for the establishment and operation of alcohol abuse, drug abuse,
23 and crime prevention programs, and other related purposes in the counties.

24

25 SECTION 5. Arkansas Code § 19-5-1211(b) concerning revenues for the
26 Department of Labor Special Fund, is amended to read as follows:

27 (b) This fund shall consist of:

28 (1) Those special revenues set out in § 19-6-301(25), (36), (72),
29 (112), (158), ~~and (180)-r~~, and (251); and

30

31 SECTION 6. Arkansas Code § 19-5-1241(b) concerning revenues for the
32 Trial court Administrative Assistant Fund, is amended to read as follows:

33 (b) The Trial Court Administrative Assistant Fund shall consist of those
34 moneys transferred from the State Administration of Justice Fund, the first
35 one hundred thousand dollars (\$100,000) collected annually from filing fees
36 for the office of the prosecuting attorney, and other moneys as authorized by

1 law.

3 SECTION 7. Arkansas Code Title 19, Chapter 6, Subchapter 3 is amended
4 by adding the following new subsections to reflect current Special Revenues
5 Enumerated to read as follows:

14 (252) Voice stress analysis examiner's license fees, § 17-39-305;

16 SECTION 8. Arkansas Code § 19-6-404(1) concerning the Department of
17 Arkansas State Police Fund, is amended to read as follows:

18 (1) Those special revenues as specified in § 19-6-301(1), (5), (7), (8),
19 (38)-(40), ~~(56)~~, (94), (128), (150), (168), (175), (184)-(186), (190), (202),
20 (218)-(220), (222), (226), (227), ~~and (234)~~, and (252);

21

22 SECTION 9. Arkansas Code 19-5-401 is amended to read as follows:

23 *19-5-401. Allocations for fiscal year 2014-2015 and thereafter.*

24 *Commencing with the fiscal year beginning July 1, 2014, and each fiscal year
25 thereafter, the Treasurer of State shall transfer all remaining general
26 revenues available for distribution on the last day of business in July 2014,
27 and on the last day of business in each calendar month thereafter during the
28 fiscal year to the various funds and fund accounts participating in general
29 revenues in the proportions of the maximum allocation as the individual
30 allocation to the fund or fund account bears to the total of the maximum
31 allocation as provided in § 19-5-402 (a), (b), (b)(1) and (c).*

32

33 SECTION 10. Arkansas Code 19-5-402 is amended to read as follows:

34 *19-5-402. Maximum allocations of revenues for fiscal year 2014-2015 and
35 thereafter.*

36 *(a)(i) The Treasurer of State shall first make monthly allocations in the*

1 proportions set out in this subsection to the funds and fund accounts listed
 2 below until there has been transferred a total of four billion nine hundred
 3 sixty-five million three hundred eighty thousand two hundred twenty-six
 4 dollars (\$4,965,380,226) or so much thereof as may become available;
 5 provided, that the Treasurer of State shall make such monthly allocations in
 6 accordance with each fund or fund account's proportionate part of the total
 7 of all such allocations set forth in this subsection:

25 (a)(ii) Nineteen million dollars (\$19,000,000), or so much thereof as

26 is available shall be included and added to the amount distributed in (a)(i)

27 and shall be distributed by the Treasure of State in monthly amounts with

28 each allocation's proportion of the total of both (a)(i) and (a)(ii) to

29 supplement the fund established as a set-aside in the 89th Session Projects

30 Account of the General Improvement Fund in Section 3 (a) (2) of the General

31 Improvement Distribution Act, for transfers, from time to time, to the

32 various fund and fund accounts in the Revenue Stabilization Law as amended,

33 or for transfers, from time to time, for projects in the Executive

34 Discretionary Division (d), upon approval by the Arkansas Legislative Council

35 or Joint Budget Committee. Any amount released by the Executive and approved

36 by the Arkansas Legislative Council or Joint Budget Committee for the

1 *University of Arkansas for Medical Sciences shall be included in the Base*
 2 *Level general revenue as set out in this Section for the 2015-2017 biennium.*

 4 *(b) After making the maximum annual allocations provided for in subsection*
 5 *(a) of this section, the Treasurer of State shall then make allocations from*
 6 *the remaining general revenues available for distribution, as set forth in*
 7 *this subsection, to the funds and fund accounts listed below until there has*
 8 *been transferred a total of fifty-one million sixty-nine thousand seven*
 9 *hundred seventy-four dollars (\$51,069,774) or so much thereof that may become*
 10 *available; provided, that the Treasurer of State shall make such monthly*
 11 *allocations in accordance with each fund or fund account's proportionate part*
 12 *of the total of all such allocations set forth in this subsection:*
