## For An Act To Be Entitled

8 *AN ACT TO AUTHORIZE THE ISSUANCE, RENEWAL, AND*  
9 *REPLACEMENT OF SPECIAL LICENSE PLATES TO PROMOTE AND*  
10 *SUPPORT THE ARKANSAS STATE CHAPTER OF THE NATIONAL*  
11 *WILD TURKEY FEDERATION, INC.; AND FOR OTHER PURPOSES.*

15 *TO AUTHORIZE THE ISSUANCE, RENEWAL, AND*  
16 *REPLACEMENT OF SPECIAL LICENSE PLATES TO*  
17 *PROMOTE AND SUPPORT THE ARKANSAS STATE*  
18 *CHAPTER OF THE NATIONAL WILD TURKEY*

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 *SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14, is*  
25 *amended to add an additional section to read as follows:*

26 *27-24-1423. Arkansas State Chapter of the National Wild Turkey*  
27 *Federation, Inc.*

28 *(a) The Director of the Department of Finance and Administration shall*  
29 *create and issue an Arkansas State Chapter of the National Wild Turkey*  
30 *Federation, Inc. special license plate in the manner and subject to the*  
31 *conditions provided for under this subchapter.*

32 *(b) The Arkansas State Chapter of the National Wild Turkey Federation,*  
33 *Inc. special license plate shall be:*

34 *(1) Designed by the Department of Finance and Administration, in*  
35 *consultation with the Board of Directors of the Arkansas State Chapter of the*  
36 *National Wild Turkey Federation, Inc.; and*



1 (2) Numbered consecutively.

2 (c) The procedures concerning costs for issuance under § 27-24-  
3 1404(c)(1)(A) shall apply.

4 (d) The department shall issue a special license plate under this  
5 section to a motor vehicle owner upon payment of:

6 (1) The fee required by law for registration of the motor  
7 vehicle;

8 (2)(A) Twenty-five dollars (\$25.00) to cover the design-use  
9 contribution.

10 (B) The design-use contribution shall be remitted monthly  
11 to the Board of Directors of the Arkansas State Chapter of the National Wild  
12 Turkey Federation, Inc. to be used exclusively to promote the federation's  
13 mission in Arkansas; and

14 (3)(A) A handling and administrative fee shall be:

15 (i) Deposited into the State Central Services Fund  
16 for the benefit of the Revenue Division of the Department of Finance and  
17 Administration; and

18 (ii) Credited to the division as supplemental and in  
19 addition to all other funds that may be deposited for the benefit of the  
20 division.

21 (B) The handling and administrative fee shall not be  
22 considered or credited to the division as direct revenue.

23 (e)(1) A special license plate issued under this section may be  
24 renewed annually or replaced under the procedures set out in § 27-24-1405.

25 (2) However, the division shall remit the fees collected under §  
26 27-24-1405(b)(2) on a monthly basis to the Board of Directors of the Arkansas  
27 State Chapter of the National Wild Turkey Federation, Inc.

28  
29 SECTION 2. Arkansas Code § 27-24-1421 is repealed.

30 27-24-1421. Rotary International.

31 (a) The Director of the Department of Finance and Administration shall  
32 issue a special license plate to honor Rotary International subject to the  
33 conditions provided for under this subchapter.

34 (b) The special Rotary International PolioPlus motor vehicle license  
35 plate shall be:

36 (1)(A) Designed by the Arkansas districts of Rotary

1 ~~International.~~

2 ~~(B) The design shall be submitted for design approval by~~  
3 ~~the director under rules promulgated by the director; and~~

4 ~~(2) Numbered consecutively.~~

5 ~~(c) The director shall determine the amount of the costs for the~~  
6 ~~issuance of the special license plate under this section as follows:~~

7 ~~(1) The fee for the cost of initial orders of the new design,~~  
8 ~~which shall be based on the cost of the initial order;~~

9 ~~(2) The number of applications that must be received to cover~~  
10 ~~the cost of the initial order of the new design; or~~

11 ~~(3) The combination of subdivisions (c)(1) and (2) of this~~  
12 ~~section that must be received to cover the cost of the initial order of the~~  
13 ~~new design.~~

14 ~~(d) The Department of Finance and Administration shall issue a special~~  
15 ~~license plate under this section upon payment of:~~

16 ~~(1) The fee required by law for registration of the motor~~  
17 ~~vehicle;~~

18 ~~(2)(A) Ten dollars (\$10.00) to cover the design-use~~  
19 ~~contribution.~~

20 ~~(B) The design-use contribution shall be remitted monthly~~  
21 ~~to the Rotary International to be used for fund purposes; and~~

22 ~~(3)(A) A handling and administrative fee of ten dollars~~  
23 ~~(\$10.00).~~

24 ~~(B) The handling and administrative fee shall be:~~

25 ~~(i) Deposited into the State Central Services Fund~~  
26 ~~for the benefit of the Revenue Division of the Department of Finance and~~  
27 ~~Administration; and~~

28 ~~(ii) Credited to the division as supplemental and in~~  
29 ~~addition to all other funds that may be deposited for the benefit of the~~  
30 ~~division.~~

31 ~~(C) The handling and administrative fee shall not be~~  
32 ~~considered or credited to the division as direct revenue.~~

33 ~~(e)(1) A special license plate issued under this section may be~~  
34 ~~renewed annually or replaced under the procedures set out in § 27-24-1405.~~

35 ~~(2) However, the division shall remit the fees collected under §~~  
36 ~~27-24-1405(b)(2) on a monthly basis to the Rotary International PolioPlus~~
