# A Bill

SENATE BILL 121

## For An Act To Be Entitled

8 AN ACT TO MAKE TECHNICAL CORRECTIONS TO TITLE 11 OF  
9 THE ARKANSAS CODE CONCERNING LABOR AND INDUSTRIAL  
10 RELATIONS; AND FOR OTHER PURPOSES.

### Subtitle

14 TO MAKE TECHNICAL CORRECTIONS TO TITLE 11  
15 OF THE ARKANSAS CODE CONCERNING LABOR AND  
16 INDUSTRIAL RELATIONS.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 11-10-705(b)(2), concerning employer  
22 contributions to unemployment insurance, is amended to read as follows to  
23 make stylistic changes:

24 (2)(A) Notwithstanding any other provision of this chapter, for  
25 any calendar year beginning on and after January 1, 2008, an employer that  
26 has been assigned a contribution rate of six percent (6%) ~~pursuant to~~ under  
27 this chapter and that has had such a rate for the two (2) preceding calendar  
28 years will be assigned an additional contribution assessment of two percent  
29 (2%).

30 (B) ~~Furthermore, after~~ After two (2) consecutive years of  
31 being assessed an additional contribution of two percent (2%) under  
32 subdivision (b)(2)(A) of this section, this additional contribution  
33 assessment shall increase to four percent (4%).

34 (C) ~~Furthermore, for~~ For calendar years beginning January  
35 1, 2014, and thereafter, after two (2) consecutive years of being assessed an  
36 additional contribution of four percent (4%) under subdivision (b)(2)(B) of



1 this section, the additional contribution assessment shall increase to six  
2 percent (6%).

3 (D) ~~Furthermore, for~~ For calendar years beginning January  
4 1, 2014, and thereafter, after two (2) consecutive years of being assessed an  
5 additional contribution of six percent (6%) under subdivision (b)(2)(C) of  
6 this section, the additional contribution assessment shall increase to eight  
7 percent (8%).

9 SECTION 2. DO NOT CODIFY. The enactment and adoption of this act  
10 shall not repeal, expressly or impliedly, the acts passed at the regular  
11 session of the Ninetieth General Assembly. All such acts shall have full  
12 force and effect and, so far as those acts intentionally vary from or  
13 conflict with any provision contained in this act, those acts shall have the  
14 effect of subsequent acts and as amending or repealing the appropriate parts  
15 of the Arkansas Code of 1987.
