28 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
29 General Assembly of the State of Arkansas that institutions of higher
30 education need additional vehicles to maintain efficient operation of the
31 institutions; that the number of vehicles authorized under current law is
32 insufficient; and that this act is immediately necessary to ensure that an
33 institution of higher education may access the number of vehicles that the
34 institution determines is necessary for efficient operation of the campus.
35 Therefore, an emergency is declared to exist, and this act being immediately
36 necessary for the preservation of the public peace, health, and safety shall

1 become effective on:

2 (1) The date of its approval by the Governor;

3 (2) If the bill is neither approved nor vetoed by the Governor,
4 the expiration of the period of time during which the Governor may veto the
5 bill; or

6 (3) If the bill is vetoed by the Governor and the veto is
7 overridden, the date the last house overrides the veto.
