## For An Act To Be Entitled

8 AN ACT TO REPEAL THE REQUIREMENT TO PREPARE A  
9 SUPPLEMENTAL MOTORCYCLE TRAFFIC ACCIDENT REPORT FOR A  
10 TRAFFIC ACCIDENT INVOLVING A MOTORCYCLE OR OTHER  
11 SIMILAR MOTOR-DRIVEN CYCLE; AND FOR OTHER PURPOSES.

## Subtitle

14 TO REPEAL THE REQUIREMENT TO PREPARE A  
15 SUPPLEMENTAL MOTORCYCLE TRAFFIC ACCIDENT  
16 REPORT FOR A TRAFFIC ACCIDENT INVOLVING A  
17 MOTORCYCLE OR OTHER SIMILAR MOTOR-DRIVEN  
18 CYCLE.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Arkansas Code § 27-53-202(d), concerning the requirement  
25 for the preparation of a supplemental motorcycle traffic accident report for  
26 a traffic accident involving a motorcycle, is repealed.

27 ~~(d) In all traffic accidents involving motorcycles, motor-driven~~  
28 ~~icycles, motorized bicycles, or any other two wheeled or three wheeled motor~~  
29 ~~vehicle, all written reports of the accident shall be supplemented with a~~  
30 ~~motorcycle traffic accident report.~~  
31

32 SECTION 2. Arkansas Code § 27-53-206(c), concerning creation of  
33 motorcycle traffic accident report forms by the Department of Arkansas State  
34 Police, is repealed.

35 ~~(c) The motorcycle traffic accident report shall be made upon forms~~  
36 ~~approved and supplied by the Department of Arkansas State Police, with the~~

3 SECTION 3. Arkansas Code § 27-53-304(b), concerning motorcycle traffic  
4 accident reports is repealed.

5 ~~(b) The motorcycle traffic accident report shall be made upon forms~~  
6 ~~approved and supplied by the Department of Arkansas State Police, with the~~  
7 ~~concurrence of the Arkansas State Highway and Transportation Department.~~
