21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. REGULAR SALARIES. There is hereby established for the

26 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 28 COMPREHENSIVE SYSTEM OF PERSONNEL DEVELOPMENT. Section 101(a)(7) of the
 29 Rehabilitation Act Amendments of 1992, commonly referred to as the
 30 Comprehensive System of Personnel Development (CSPD), requires State
 31 Vocational Rehabilitation (VR) agencies to establish qualified personnel
 32 standards for rehabilitation personnel, including VR counselors, that are
 33 consistent with any national or State-approved or recognized certification,
 34 licensing, or registration that apply to a particular profession. In order to
 35 comply with the Rehabilitation Act and its State Plan requirements, there is
 36 hereby authorized for the Department of Career Education-Arkansas

1 Rehabilitation Services a general waiver of the Financial Management Guide,
2 R1-19-4-522 Continuing Professional Education. This waiver allows the agency
3 to provide college level coursework in degree programs for any eligible
4 employees selected by the agency. This provision covers any and all formula
5 and discretionary grants funded by the U.S.D.O.E. Rehabilitation Services
6 Administration, now or in the future, including, but not limited to, the
7 Vocational Rehabilitation Program, Supported Employment, Independent Living,
8 and the Staff Development Grant. The waiver applies to federal financial
9 participation (FFP), state general revenue share, and program income.

10 The provisions of this section shall be in effect from July 1, ~~2014~~ 2015
11 through June 30, ~~2015~~ 2016.

12
13 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

15 FORGIVENESS OF STUDENT LOAN PROGRAM. The Forgiveness of Student Loan Program
16 shall be available to counselors employed by Arkansas Rehabilitation Services
17 that have been determined eligible by rules promulgated by Arkansas
18 Rehabilitation Services as required by Arkansas Code §25-30-206. These rules
19 shall be submitted to the Administrative Rules and Regulations Subcommittee
20 of the Arkansas Legislative Council and receive prior review. These rules
21 must include the following eligibility requirements:

22 (1) Satisfactory completion of any probationary period;

23 (2) Proof of a student loan that remains unpaid, including the name and
24 address of the creditor;

25 (3) An executed employment contract in which the counselor agrees to
26 the following:

27 (a) work for Arkansas Rehabilitation Services for a term that equals
28 two (2) years for each year that the program makes a payment on the
29 counselor's student loan and

30 (b) reimburse the program the full amount of any loan payments made
31 under this program in the event that the counselor resigns or is terminated
32 for cause before the term of the contract terminates.

33 The amount of payment to be made directly to the counselor's student
34 loan creditor may not exceed:

35 (1) Two thousand dollars (\$2,000) per year; or

36 (2) Ten thousand dollars (\$10,000) per employee.

1 The Arkansas Rehabilitation Services agency shall pay for the
2 Forgiveness of Student Loan Program from the Rehabilitation Program Grants -
3 Grants and Aid line item authorized for the appropriation entitled
4 Rehabilitation Services - Operations in an amount not to exceed eighty
5 thousand dollars (\$80,000) per fiscal year.

6 In addition, the Arkansas Rehabilitation Services agency shall provide a
7 formal, written notification to all counselors employed by Arkansas
8 Rehabilitation Services of the availability of the Forgiveness of Student
9 Loan Program by July 1 of each fiscal year. The agency shall include with the
10 notification, the promulgated rules which shall outline the eligibility
11 requirements for participation.

12 The agency shall submit a copy of this notification to the Arkansas
13 Legislative Council or Joint Budget Committee by July 1 of each fiscal year.
14 In addition, Arkansas Rehabilitation Services shall report bi-annually, by
15 the 15th day of the month following the end of each six month period, to the
16 Arkansas Legislative Council or Joint Budget Committee the number of
17 employees participating in the program.

18 The provisions of this section shall be in effect only from July 1,
19 2015 through June 30, 2016.

20

21 SECTION 12. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
22 authorized by this act shall be limited to the appropriation for such agency
23 and funds made available by law for the support of such appropriations; and
24 the restrictions of the State Procurement Law, the General Accounting and
25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
26 Procedures and Restrictions Act, or their successors, and other fiscal
27 control laws of this State, where applicable, and regulations promulgated by
28 the Department of Finance and Administration, as authorized by law, shall be
29 strictly complied with in disbursement of said funds.

30

31 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General
32 Assembly that any funds disbursed under the authority of the appropriations
33 contained in this act shall be in compliance with the stated reasons for
34 which this act was adopted, as evidenced by the Agency Requests, Executive
35 Recommendations and Legislative Recommendations contained in the budget
36 manuals prepared by the Department of Finance and Administration, letters, or

1 summarized oral testimony in the official minutes of the Arkansas Legislative
2 Council or Joint Budget Committee which relate to its passage and adoption.

3
4 SECTION 14. EMERGENCY CLAUSE. It is found and determined by the
5 General Assembly, that the Constitution of the State of Arkansas prohibits
6 the appropriation of funds for more than a one (1) year period; that the
7 effectiveness of this Act on July 1, 2015 is essential to the operation of
8 the agency for which the appropriations in this Act are provided, and that in
9 the event of an extension of the legislative session, the delay in the
10 effective date of this Act beyond July 1, 2015 could work irreparable harm
11 upon the proper administration and provision of essential governmental
12 programs. Therefore, an emergency is hereby declared to exist and this Act
13 being necessary for the immediate preservation of the public peace, health
14 and safety shall be in full force and effect from and after July 1, 2015.
