## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 AND OPERATING EXPENSES FOR THE STATE BOARD OF PRIVATE  
10 CAREER EDUCATION FOR THE FISCAL YEAR ENDING JUNE 30,  
11 2017; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT FOR THE STATE BOARD OF PRIVATE  
15 CAREER EDUCATION APPROPRIATION FOR THE  
16 2016-2017 FISCAL YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
23 for the State Board of Private Career Education for the 2016-2017 fiscal  
24 year, the following maximum number of regular employees.

36 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for



1 the State Board of Private Career Education for the 2016-2017 fiscal year,  
 2 the following maximum number of part-time or temporary employees, to be known  
 3 as "Extra Help", payable from funds appropriated herein for such purposes:  
 4 four (4) temporary or part-time employees, when needed, at rates of pay not  
 5 to exceed those provided in the Uniform Classification and Compensation Act,  
 6 or its successor, or this act for the appropriate classification.

7  
 8 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 9 to the State Board of Private Career Education, to be payable from the  
 10 Private Career Education Fund, for personal services and operating expenses  
 11 of the State Board of Private Career Education for the fiscal year ending  
 12 June 30, 2017, the following:

7 SECTION 5. APPROPRIATION - STUDENT PROTECTION TRUST. There is hereby

8 appropriated, to the State Board of Private Career Education, to be payable

9 from the Private Career School Student Protection Trust Fund, for expenses,

10 claims and fees of the State Board of Private Career Education for the fiscal

11 year ending June 30, 2017, the following:

17 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

18 authorized by this act shall be limited to the appropriation for such agency

19 and funds made available by law for the support of such appropriations; and

20 the restrictions of the State Procurement Law, the General Accounting and

21 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

22 Procedures and Restrictions Act, or their successors, and other fiscal

23 control laws of this State, where applicable, and regulations promulgated by

24 the Department of Finance and Administration, as authorized by law, shall be

25 strictly complied with in disbursement of said funds.

26

27 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General

28 Assembly that any funds disbursed under the authority of the appropriations

29 contained in this act shall be in compliance with the stated reasons for

30 which this act was adopted, as evidenced by the Agency Requests, Executive

31 Recommendations and Legislative Recommendations contained in the budget

32 manuals prepared by the Department of Finance and Administration, letters, or

33 summarized oral testimony in the official minutes of the Arkansas Legislative

34 Council or Joint Budget Committee which relate to its passage and adoption.

36 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General

1 Assembly, that the Constitution of the State of Arkansas prohibits the  
2 appropriation of funds for more than a one (1) year period; that the  
3 effectiveness of this Act on July 1, 2016 is essential to the operation of  
4 the agency for which the appropriations in this Act are provided, and that in  
5 the event of an extension of the legislative session, the delay in the  
6 effective date of this Act beyond July 1, 2016 could work irreparable harm  
7 upon the proper administration and provision of essential governmental  
8 programs. Therefore, an emergency is hereby declared to exist and this Act  
9 being necessary for the immediate preservation of the public peace, health  
10 and safety shall be in full force and effect from and after July 1, 2016.
