15 EDUCATION REAPPROPRIATION.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is
21 hereby appropriated, to the Arkansas Northeastern College, to be payable from
22 the General Improvement Fund or its successor fund or fund accounts, for the
23 Arkansas Northeastern College the following:

24 (A) Effective July 1, 2016, the balance of the appropriation provided
25 in Item (F) Section 1 of Act 207 of 2015, for construction, renovation,
26 maintenance, critical maintenance, equipment, security enhancements,
27 technology upgrades/equipment and library resources, in a sum not to
28 exceed.....\$175,000.

29 (B) Effective July 1, 2016, the balance of the appropriation provided
30 in Item (G) Section 1 of Act 207 of 2015, for construction, renovation,
31 maintenance, critical maintenance, equipment, security enhancements,
32 technology upgrades/equipment and library resources, in a sum not to

8 the SAU-Tech for construction, renovation, maintenance, critical maintenance,
9 equipment, security enhancements, technology upgrades/equipment and
10 furnishings for the Auto Body Shop Building shall be deemed to also include
11 costs of campus safety and technology upgrades and replacement.

12 (b) As referenced in Section 3(c) of Act 1518 of 2013 and Section 3(c) of Act
13 1519 of 2013, the authorized funding for the SAU-Tech for construction,
14 renovation, maintenance, critical maintenance, equipment, security
15 enhancements, technology upgrades/equipment and furnishings for the Auto Body
16 Shop Building shall be deemed to also include costs of campus safety and
17 technology upgrades and replacement.

18 (c) As referenced in Section 3(c) of Act 1096 of 2011 and Section 3(c) of Act
19 1117 of 2011, the authorized funding for the SAU-Tech for construction,
20 renovation and equipment for the Auto Body Building shall be deemed to also
21 include costs of campus safety and technology upgrades and replacement.

22
23 SECTION 26. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
24 obligations otherwise incurred in relation to the project or projects
25 described herein in excess of the State Treasury funds actually available
26 therefor as provided by law. Provided, however, that institutions and
27 agencies listed herein shall have the authority to accept and use grants and
28 donations including Federal funds, and to use its unobligated cash income or
29 funds, or both available to it, for the purpose of supplementing the State
30 Treasury funds for financing the entire costs of the project or projects
31 enumerated herein. Provided further, that the appropriations and funds
32 otherwise provided by the General Assembly for Maintenance and General
33 Operations of the agency or institutions receiving appropriation herein shall
34 not be used for any of the purposes as appropriated in this act.

35 (B) The restrictions of any applicable provisions of the State
36 Purchasing Law, the General Accounting and Budgetary Procedures Law, the

1 Revenue Stabilization Law and any other applicable fiscal control laws of
2 this State and regulations promulgated by the Department of Finance and
3 Administration, as authorized by law, shall be strictly complied with in
4 disbursement of any funds provided by this act unless specifically provided
5 otherwise by law.

6
7 SECTION 27. LEGISLATIVE INTENT. It is the intent of the General
8 Assembly that any funds disbursed under the authority of the appropriations
9 contained in this act shall be in compliance with the stated reasons for
10 which this act was adopted, as evidenced by the Agency Requests, Executive
11 Recommendations and Legislative Recommendations contained in the budget
12 manuals prepared by the Department of Finance and Administration, letters, or
13 summarized oral testimony in the official minutes of the Arkansas Legislative
14 Council or Joint Budget Committee which relate to its passage and adoption.

15
16 SECTION 28. EMERGENCY CLAUSE. It is found and determined by the
17 General Assembly, that the Constitution of the State of Arkansas prohibits
18 the appropriation of funds for more than a one (1) year period; that the
19 effectiveness of this Act on July 1, 2016 is essential to the operation of
20 the agency for which the appropriations in this Act are provided, and that in
21 the event of an extension of the legislative session, the delay in the
22 effective date of this Act beyond July 1, 2016 could work irreparable harm
23 upon the proper administration and provision of essential governmental
24 programs. Therefore, an emergency is hereby declared to exist and this Act
25 being necessary for the immediate preservation of the public peace, health
26 and safety shall be in full force and effect from and after July 1, 2016.
