11 JUNE 30, 2017; AND FOR OTHER PURPOSES.

15 AN ACT FOR THE ARKANSAS GEOGRAPHIC
16 INFORMATION SYSTEMS OFFICE APPROPRIATION
17 FOR THE 2016-2017 FISCAL YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Arkansas Geographic Information Systems Office for the 2016-2017 fiscal year,
24 the following maximum number of regular employees.

4 SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 5 to the Arkansas Geographic Information Systems Office, to be payable from the
 6 Miscellaneous Agencies Fund Account, for personal services and operating
 7 expenses of the Arkansas Geographic Information Systems Office for the fiscal
 8 year ending June 30, 2017, the following:

22 SECTION 3. APPROPRIATION - GEOSTOR AND FRAMEWORK. There is hereby
 23 appropriated, to the Arkansas Geographic Information Systems Office, to be
 24 payable from the Geographic Information Systems Fund, to carry out the
 25 duties, responsibilities and authority of the Arkansas State Land Information
 26 Board as described by Arkansas Code 15-21-504; to create, operate and
 27 maintain Geostor, the Arkansas Spatial Data Infrastructure and to create,
 28 update, maintain and disseminate framework spatial data as defined by
 29 Arkansas Code 15-21-502 for the fiscal year ending June 30, 2017, the
 30 following:

36 SECTION 4. APPROPRIATION - PARCEL MAPPING GRANT. There is hereby

1 appropriated, to the Arkansas Geographic Information Systems Office, to be
 2 payable from the Geographic Information Systems Fund, for expenses of
 3 implementing and administering the Statewide Mapping Grant Program by the
 4 Arkansas Geographic Information Systems Office for the fiscal year ending
 5 June 30, 2017, the following:

11 SECTION 5. SPECIAL LANGUAGE. TRANSFER OF CARRY FORWARD. Any unexpended
 12 balance of funds remaining on June 30 of each fiscal year in the
 13 Miscellaneous Agencies Fund Account for the Arkansas Geographic Information
 14 Office, shall be transferred to the Geographic Information Systems Fund to be
 15 used for operating and maintaining the Arkansas Spatial Data Infrastructure,
 16 creating, updating, maintaining and disseminating framework spatial data as
 17 defined by Arkansas Code §15-21-502.

18 (1) Prior to June 30, ~~2016~~ 2017 the Agency shall by written statement set
 19 forth its reason(s) for the need to carry forward said funding to the
 20 Department of Finance and Administration Office of Budget;

21 (2) The Department of Finance and Administration Office of Budget shall
 22 report to the Arkansas Legislative Council all amounts carried forward by the
 23 September Arkansas Legislative Council or Joint Budget Committee meeting
 24 which report shall include the name of the Agency, Board, Commission or
 25 Institution and the amount of the funding carried forward, the program name
 26 or line item, the funding source of that appropriation and a copy of the
 27 written request set forth in (1) above;

28 (3) Each Agency, Board, Commission or Institution shall provide a written
 29 report to the Arkansas Legislative Council or Joint Budget Committee
 30 containing all information set forth in item (2) above, along with a written
 31 statement as to the current status of the project, contract, purpose etc. for
 32 which the carry forward was originally requested no later than thirty (30)
 33 days prior to the time the Agency, Board, Commission or Institution presents
 34 its budget request to the Arkansas Legislative Council/Joint Budget
 35 Committee; and

36 (4) Thereupon, the Department of Finance and Administration shall include

1 all information obtained in item (3) above in the biennial budget manuals
2 and/or a statement of non-compliance by the Agency, Board, Commission or
3 Institution.

4 The provisions of this section shall be in effect only from July 1, ~~2015~~
5 2016 through June 30, ~~2016~~ 2017.

6
7 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
8 authorized by this act shall be limited to the appropriation for such agency
9 and funds made available by law for the support of such appropriations; and
10 the restrictions of the State Procurement Law, the General Accounting and
11 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
12 Procedures and Restrictions Act, or their successors, and other fiscal
13 control laws of this State, where applicable, and regulations promulgated by
14 the Department of Finance and Administration, as authorized by law, shall be
15 strictly complied with in disbursement of said funds.

16
17 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
18 Assembly that any funds disbursed under the authority of the appropriations
19 contained in this act shall be in compliance with the stated reasons for
20 which this act was adopted, as evidenced by the Agency Requests, Executive
21 Recommendations and Legislative Recommendations contained in the budget
22 manuals prepared by the Department of Finance and Administration, letters, or
23 summarized oral testimony in the official minutes of the Arkansas Legislative
24 Council or Joint Budget Committee which relate to its passage and adoption.

25
26 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
27 Assembly, that the Constitution of the State of Arkansas prohibits the
28 appropriation of funds for more than a one (1) year period; that the
29 effectiveness of this Act on July 1, 2016 is essential to the operation of
30 the agency for which the appropriations in this Act are provided, and that in
31 the event of an extension of the legislative session, the delay in the
32 effective date of this Act beyond July 1, 2016 could work irreparable harm
33 upon the proper administration and provision of essential governmental
34 programs. Therefore, an emergency is hereby declared to exist and this Act
35 being necessary for the immediate preservation of the public peace, health
36 and safety shall be in full force and effect from and after July 1, 2016.
