9 AN ACT TO PROMOTE EFFICIENCY AND EFFECTIVENESS IN THE
10 OPERATIONS OF STATE GOVERNMENT; TO TRANSFER THE
11 ARKANSAS HISTORY COMMISSION TO THE DEPARTMENT OF
12 ARKANSAS HERITAGE BY A TYPE 2 TRANSFER; AMENDING THE
13 MEMBERSHIP, TENURE, AND DUTIES OF CERTAIN AGENCIES,
14 TASK FORCES, COMMITTEES, AND COMMISSIONS; TO DECLARE
15 AN EMERGENCY; AND FOR OTHER PURPOSES.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. DO NOT CODIFY. LEGISLATIVE INTENT. (a) The General
27 Assembly finds:

28 (1) State government provides vital functions that impact the
29 lives of Arkansas citizens on a daily basis;

30 (2) While these functions are important, it is equally important
31 to ensure that state government operates efficiently and effectively to
32 eliminate unnecessary spending of tax dollars and provide timely and quality
33 services to Arkansas citizens; and

34 (3) Issues such as the administrative organization of a
35 governmental entity, the appointment structure of a governmental entity's
36 governing board, and extraneous duties assigned to governmental entities



1 hamper the operation of state government and result in unnecessary expenses
 2 and delays in the provision of state services.

3 (b) It is the intent of this act to amend provisions of law applicable
 4 to certain agencies, task forces, committees, and commission to promote
 5 efficiency and effectiveness in the operations of state government as a
 6 whole.

14 ~~(a) — The Arkansas Young and Beginning Farmer Advisory Board is~~
 15 ~~established to advise agriculture-related agencies of state government with~~
 16 ~~respect to the impact the agencies have on the future of agriculture and the~~
 17 ~~agricultural way of life in Arkansas and to help young Arkansas farmers~~
 18 ~~appreciate their heritage and agricultural work in relation to the history~~
 19 ~~and the economy of Arkansas.~~

20 ~~(b) — The offices of the board shall be located within the Arkansas~~
 21 ~~Agriculture Department in Little Rock, and the department shall provide~~
 22 ~~administrative staff for the board and its committees.~~

23
 24 ~~2-1-202. — Board qualifications and terms.~~

25 ~~(a) — The Arkansas Young and Beginning Farmer Advisory Board shall~~
 26 ~~consist of members appointed under § 2-1-203 who are residents and electors~~
 27 ~~of this state.~~

28 ~~(b)(1) — The membership of the board shall be made up of young persons~~
 29 ~~interested in the preservation and development of agriculture in Arkansas and~~
 30 ~~the preservation of the agricultural way of life.~~

31 ~~(2) — Each member shall be under the age of forty five (45) at the~~
 32 ~~beginning of the member's term.~~

33 ~~(3)(A) — At least sixteen (16) of the members shall be full-time~~
 34 ~~farmers having eighty percent (80%) or more of their personal incomes from~~
 35 ~~farming or agricultural activities.~~

36 ~~(B) — The remainder of the board's membership may be less—~~

1 than full-time farmers or persons employed in an agriculture-related
 2 business.

3 ~~(c)(1)(A) Except for the initial terms of the board, each member shall~~
 4 ~~serve for a term of two (2) years.~~

5 ~~(B) The term of office of each member shall begin on~~

 6 commissions and repeals other governmental entities; that these revisions and
 7 repeals of governmental entities impact the expenses and operations of state
 8 government; and that the provisions of this act should become effective as
 9 soon as possible to allow for implementation of the new provisions in advance
 10 of the upcoming fiscal year. Therefore, an emergency is declared to exist,
 11 and this act being immediately necessary for the preservation of the public
 12 peace, health, and safety shall become effective on:

13 (1) The date of its approval by the Governor;

14 (2) If the bill is neither approved nor vetoed by the Governor,
 15 the expiration of the period of time during which the Governor may veto the
 16 bill; or

17 (3) If the bill is vetoed by the Governor and the veto is
 18 overridden, the date the last house overrides the veto.
