2 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
4 PROMOTIONAL ITEMS. The Department of Arkansas State Police is hereby  
5 authorized to purchase from Maintenance & General Operations Classifications  
6 in the Operations Appropriation provided by this Act, up to an amount not to  
7 exceed \$2,500 each fiscal year, promotional items, authorized by the Director  
8 of the Department to meet requirements of the Arkansas State Police Strategic  
9 Recruitment Plan.

13 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OVERTIME.  
15 The Department of Arkansas State Police is hereby authorized to make overtime  
16 payments from such funds and appropriations provided for overtime payments to  
17 those officers or other employees that are currently assigned or may be  
18 assigned by the Director of the Department of Arkansas State Police to  
19 Special Law Enforcement Task Forces and other special programs reimbursable  
20 to Arkansas State Police by federal or local authorities as approved by the  
21 Director of the Department of Arkansas State Police. All such overtime  
22 payments shall be processed through the State Accounting System and shall be  
23 in addition to the Regular Salaries and benefits accruing to the employee.  
24 Payment of overtime is the preferred method of implementing the provisions of  
25 this section.

29 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR  
31 VEHICLE PURCHASE. The Department of Arkansas State Police is hereby  
32 authorized to purchase motor vehicles from the appropriations authorized for  
33 Capital Outlay in the State Police Operations and/or Confiscated Funds  
34 Transfer appropriation in this Act. Motor vehicles donated to Arkansas State  
35 Police and confiscated vehicles used for Arkansas State Police operations  
36 shall not be included in the maximum number of authorized passenger vehicles.

1           The provisions of this section shall be in effect only from July 1,  
2           2017 through June 30, 2018.

4           SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. UNIFORM  
6 EMPLOYEE HEALTH INSURANCE PROGRAM REPORTING. The Department of Arkansas  
7 State Police shall report monthly to the Governor, the Chief Fiscal Officer  
8 of the State and to the Arkansas Legislative Council or Joint Budget  
9 Committee regarding the activity and condition for the uniformed employee  
10 health insurance plan. The report shall include, but not limited to, the  
11 beginning reserve fund balance, contributions made during the month, claims  
12 paid, and the ending fund balance of the month. In the event it is determined  
13 that the cost to adequately maintain the uniform employee health insurance  
14 plan is not feasible within the existing resources available to the  
15 department, the ~~90<sup>th</sup>~~ 91<sup>st</sup> General Assembly shall study the feasibility and  
16 desirability of discontinuing the self-insurance program and instead provide  
17 medical and hospital insurance to uniform employees through the public  
18 employees insurance program.

19           The provisions of this section shall be in effect only from July 1, ~~2016~~  
20           2017 through June 30, ~~2017~~ 2018.

21  
22           SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
24 EXTRAORDINARY EXPENSES. The Department of Arkansas State Police is hereby  
25 authorized to purchase from Maintenance & Operations Classifications in the  
26 Operations Appropriation provided by this Act, up to an amount not to exceed  
27 two thousand five hundred dollars (\$2,500) each fiscal year, for emergency  
28 purchases for food, drinks and other essential items during emergency  
29 operations only when authorized by the Agency Director. During an emergency,  
30 an ASP employee may be designated and authorized, by the Director, to incur  
31 expenses for all deployed personnel.

32           The provisions of this section shall be in effect only from July 1, ~~2016~~  
33           2017 through June 30, ~~2017~~ 2018.

35           SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS

1 WIRELESS INFORMATION NETWORK. Once the requirements of Arkansas Code §12-8-  
2 310 are satisfied, the second ~~two million dollars (\$2,000,000)~~ two million  
3 five hundred thousand dollars (\$2,500,000) deposited into the Department of  
4 Arkansas State Police Fund generated by Arkansas Code §27-16-801(a) shall be  
5 used for the operations, maintenance, equipment and various system  
6 requirements and expenses of the Department of Arkansas State Police -  
7 Arkansas Wireless Information Network.

8 The provisions of this section shall be in effect only from July 1, ~~2016~~  
9 2017 through June 30, ~~2017~~ 2018.

10  
11 *SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*  
12 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. QUARTERLY*  
13 *REPORTING. The Department of Arkansas State Police shall on a quarterly basis*  
14 *provide to the Arkansas Legislative Council or Joint Budget Committee a*  
15 *report detailing expenditures from the Court Awards Fund of the Confiscated*  
16 *Funds Transfer appropriation of this Act. The report shall include the State*  
17 *Police division, purpose and amount of expenditures.*  
18 *The quarterly reports shall be provided no later than the 15th day of the*  
19 *month immediately following the end of each quarter.*

20 *The provisions of this section shall be in effect only from July 1, 2017*  
21 *through June 30, 2018.*

22  
23 *SECTION 21. COMPLIANCE WITH OTHER LAWS.* Disbursement of funds  
24 authorized by this act shall be limited to the appropriation for such agency  
25 and funds made available by law for the support of such appropriations; and  
26 the restrictions of the State Procurement Law, the General Accounting and  
27 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
28 Procedures and Restrictions Act, or their successors, and other fiscal  
29 control laws of this State, where applicable, and regulations promulgated by  
30 the Department of Finance and Administration, as authorized by law, shall be  
31 strictly complied with in disbursement of said funds.

32  
33 *SECTION 22. LEGISLATIVE INTENT.* It is the intent of the General  
34 Assembly that any funds disbursed under the authority of the appropriations  
35 contained in this act shall be in compliance with the stated reasons for  
36 which this act was adopted, as evidenced by the Agency Requests, Executive

1 Recommendations and Legislative Recommendations contained in the budget  
2 manuals prepared by the Department of Finance and Administration, letters, or  
3 summarized oral testimony in the official minutes of the Arkansas Legislative  
4 Council or Joint Budget Committee which relate to its passage and adoption.  
5

6 SECTION 23. EMERGENCY CLAUSE. It is found and determined by the  
7 General Assembly, that the Constitution of the State of Arkansas prohibits  
8 the appropriation of funds for more than a one (1) year period; that the  
9 effectiveness of this Act on July 1, 2017 is essential to the operation of  
10 the agency for which the appropriations in this Act are provided, and that in  
11 the event of an extension of the legislative session, the delay in the  
12 effective date of this Act beyond July 1, 2017 could work irreparable harm  
13 upon the proper administration and provision of essential governmental  
14 programs. Therefore, an emergency is hereby declared to exist and this Act  
15 being necessary for the immediate preservation of the public peace, health  
16 and safety shall be in full force and effect from and after July 1, 2017.
