19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 *SECTION 1. Arkansas Code § 17-95-412(b), as amended by Act 147 of 2017*  
22 *and concerning the requirements for an educational license for a physician,*  
23 *is amended to read as follows:*

24 *(b)(1) The physician shall:*

25 *(A) Submit an application to the board;*

26 *(B) Provide information ~~as~~ the board may by rule require;*

27 *(C) Pay a licensure fee that the board may set by rule to*  
28 *cover the costs of administering the program; and*

29 *(D) Be serving as a faculty member in the State of*

30 *Arkansas or be affiliated with and under the supervision of a faculty member*

31 *licensed by the board at an academic medical program accredited by the*

32 *Accreditation Council for Graduate Medical Education or the American*

33 *Osteopathic Association operated in the State of Arkansas and established by*

34 *and under the control of ~~a medical school in this state~~ ~~accredited by an~~*

35 *~~accrediting agency recognized by the United States Department of Education or~~*

36 *~~approved by the Arkansas Higher Education Coordinating Board to seek~~*

9 ~~administered by a medical school in this state accredited by an accrediting~~  
10 ~~agency recognized by the United States Department of Education or approved by~~  
11 ~~the Arkansas Higher Education Coordinating Board to seek accreditation by an~~  
12 ~~accrediting agency recognized by the United States Department of Education a~~  
13 ~~medical school accredited by an accrediting agency recognized by the United~~  
14 ~~States Department of Education or approved by the Arkansas Higher Education~~

18 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the  
19 General Assembly of the State of Arkansas that this act amends a portion of  
20 law previously amended by Act 147 of 2017; that Act 147 contained an  
21 emergency clause and is already in effect; and that this act should become  
22 effective at the earliest opportunity to avoid confusion and conflict in the  
23 effective date of the two (2) acts. Therefore, an emergency is declared to  
24 exist, and this act being immediately necessary for the preservation of the  
25 public peace, health, and safety shall become effective on:

26 (1) The date of its approval by the Governor;

27 (2) If the bill is neither approved nor vetoed by the Governor,  
28 the expiration of the period of time during which the Governor may veto the  
29 bill; or

30 (3) If the bill is vetoed by the Governor and the veto is  
31 overridden, the date the last house overrides the veto.
