4 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
 5 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA HELP.
 6 No employee of the Camp J.T. Robinson, or Fort Chaffee Federal Training Site
 7 Divisions of the Military Department who is employed as “extra help” may
 8 receive an amount to exceed eighty-five percent (85%) of the maximum annual
 9 salary for a comparable position as authorized under Arkansas Code 21-5-201
 10 et seq. during any fiscal year, nor shall such employee be employed for a
 11 period of time to exceed eighteen hundred (1800) hours in any single fiscal
 12 year.

13 The provisions of this section shall be in effect only from July 1, ~~2016~~
 14 2017 through June 30, ~~2017~~ 2018.

16 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CAMP
 18 ROBINSON - VARIOUS STATE MILITARY LAKES. The State Military Department is
 19 hereby authorized to stock various State Military Lakes on Camp Robinson post
 20 each year with fish for special events by using wildlife funds and rental
 21 income, no State General Revenue will be used.

22 The provisions of this section shall be in effect only from July 1, ~~2016~~

25 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GENERALS
 27 SALARY. The line item maximums for the State of Arkansas Adjutant General and
 28 Deputy Adjutant General are based on the salary grid by the United States
 29 Department of Defense. Incumbents in these positions shall be compensated in
 30 accordance with the Department of Defense Advisory Service Pay Plan and are
 31 not guaranteed placement at the maximum level. The line item maximum
 32 salaries may be adjusted on July 1 of each fiscal year to incorporate salary
 33 rate changes that have been implemented by the U.S. Department of Defense.

34 The provisions of this section shall be in effect only from July 1, ~~2016~~
 35 2017, through June 30, ~~2017~~ 2018.

1 SECTION 18. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 2 authorized by this act shall be limited to the appropriation for such agency
 3 and funds made available by law for the support of such appropriations; and
 4 the restrictions of the State Procurement Law, the General Accounting and
 5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 6 Procedures and Restrictions Act, or their successors, and other fiscal
 7 control laws of this State, where applicable, and regulations promulgated by
 8 the Department of Finance and Administration, as authorized by law, shall be
 9 strictly complied with in disbursement of said funds.

10
 11 SECTION 19. LEGISLATIVE INTENT. It is the intent of the General
 12 Assembly that any funds disbursed under the authority of the appropriations
 13 contained in this act shall be in compliance with the stated reasons for
 14 which this act was adopted, as evidenced by the Agency Requests, Executive
 15 Recommendations and Legislative Recommendations contained in the budget
 16 manuals prepared by the Department of Finance and Administration, letters, or
 17 summarized oral testimony in the official minutes of the Arkansas Legislative
 18 Council or Joint Budget Committee which relate to its passage and adoption.

19
 20 SECTION 20. EMERGENCY CLAUSE. It is found and determined by the
 21 General Assembly, that the Constitution of the State of Arkansas prohibits
 22 the appropriation of funds for more than a one (1) year period; that the
 23 effectiveness of this Act on July 1, 2017 is essential to the operation of
 24 the agency for which the appropriations in this Act are provided, and that in
 25 the event of an extension of the legislative session, the delay in the
 26 effective date of this Act beyond July 1, 2017 could work irreparable harm
 27 upon the proper administration and provision of essential governmental
 28 programs. Therefore, an emergency is hereby declared to exist and this Act
 29 being necessary for the immediate preservation of the public peace, health
 30 and safety shall be in full force and effect from and after July 1, 2017.
