## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 AND OPERATING EXPENSES FOR THE STATE BOARD OF  
10 EMBALMERS AND FUNERAL DIRECTORS FOR THE FISCAL YEAR  
11 ENDING JUNE 30, 2018; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT FOR THE STATE BOARD OF EMBALMERS  
15 AND FUNERAL DIRECTORS APPROPRIATION FOR  
16 THE 2017-2018 FISCAL YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
23 for the State Board of Embalmers and Funeral Directors for the 2017-2018  
24 fiscal year, the following maximum number of regular employees.

35 SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
36 to the State Board of Embalmers and Funeral Directors, to be payable from the



1 cash fund deposited in the State Treasury as determined by the Chief Fiscal  
 2 Officer of the State, for personal services and operating expenses of the  
 3 State Board of Embalmers and Funeral Directors for the fiscal year ending  
 4 June 30, 2018, the following:

 18 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PERSONAL  
 20 SERVICES. The Burial Association Board Executive Secretary and the Burial  
 21 Association Board Administrative Specialist III shall also be responsible for  
 22 the administrative activities of the State Board of Embalmers and Funeral  
 23 Directors. The State Board of Embalmers and Funeral Directors shall pay to  
 24 the Burial Association Board an amount equal to one-half (1/2) of the salary  
 25 of the Burial Association Board Executive Secretary, up to one-half (1/2) of  
 26 the salary of the Burial Association Board Administrative Specialist III, and  
 27 the appropriate matching. This sum shall be paid during the first quarter of  
 28 each fiscal year via fund transfer.

29 The provisions of this section shall be in effect only from July 1, ~~2016~~  
 30 2017 through June 30, ~~2017~~ 2018.

31  
 32 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 33 authorized by this act shall be limited to the appropriation for such agency  
 34 and funds made available by law for the support of such appropriations; and  
 35 the restrictions of the State Procurement Law, the General Accounting and  
 36 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

1 Procedures and Restrictions Act, or their successors, and other fiscal  
2 control laws of this State, where applicable, and regulations promulgated by  
3 the Department of Finance and Administration, as authorized by law, shall be  
4 strictly complied with in disbursement of said funds.

5  
6 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General  
7 Assembly that any funds disbursed under the authority of the appropriations  
8 contained in this act shall be in compliance with the stated reasons for  
9 which this act was adopted, as evidenced by the Agency Requests, Executive  
10 Recommendations and Legislative Recommendations contained in the budget  
11 manuals prepared by the Department of Finance and Administration, letters, or  
12 summarized oral testimony in the official minutes of the Arkansas Legislative  
13 Council or Joint Budget Committee which relate to its passage and adoption.

14  
15 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General  
16 Assembly, that the Constitution of the State of Arkansas prohibits the  
17 appropriation of funds for more than a one (1) year period; that the  
18 effectiveness of this Act on July 1, 2017 is essential to the operation of  
19 the agency for which the appropriations in this Act are provided, and that in  
20 the event of an extension of the legislative session, the delay in the  
21 effective date of this Act beyond July 1, 2017 could work irreparable harm  
22 upon the proper administration and provision of essential governmental  
23 programs. Therefore, an emergency is hereby declared to exist and this Act  
24 being necessary for the immediate preservation of the public peace, health  
25 and safety shall be in full force and effect from and after July 1, 2017.
