9 AN ACT TO AMEND PROVISIONS OF THE UNIFORM FACSIMILE  
10 SIGNATURE OF PUBLIC OFFICIALS ACT; TO AUTHORIZE THE  
11 USE OF A DIGITIZED SIGNATURE OF A COUNTY TREASURER;  
12 AND FOR OTHER PURPOSES.

## Subtitle

15 TO AMEND PROVISIONS OF THE UNIFORM  
16 FACSIMILE SIGNATURE OF PUBLIC OFFICIALS  
17 ACT; AND TO AUTHORIZE THE USE OF A  
18 DIGITIZED SIGNATURE OF A COUNTY  
19 TREASURER.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. Arkansas Code § 14-24-204(b), concerning payment generally,  
26 is amended to read as follows:

27 (b)(1) In lieu of the provisions of this section pertaining to the  
28 issuance of a check in duplicate form, if a county so chooses, the following  
29 provisions may apply:

30 ~~(1)~~(A) Once the aforementioned claim procedures have been  
31 completed, the treasurer may cause a check to be prepared in payment of  
32 claims filed with the county court;

33 ~~(2)~~(B) Each claim properly recorded and approved for  
34 payment by the county court shall be proper certification from the clerk to  
35 the treasurer that a valid claim exists; and

36 ~~(3)~~(A)~~(C)~~(i) The checks shall be prenumbered and so



1 designed that the particular fund affected out of which the check is to be  
2 paid shall be noted thereon.

3 ~~(B)(ii)~~ A county may use computer equipment for  
4 check preparation if the use of an automated software program that  
5 accomplishes the same purpose as prenumbered checks and other required  
6 denotations is in compliance with the Information Systems Best Practices  
7 Checklist provided by the Legislative Joint Auditing Committee.

8 (2) The check drawn in connection with the disbursement of  
9 county funds for which the county treasurer is responsible shall:

10 (A) Bear the manual signature of the county treasurer or  
11 his or her authorized deputy; or

12 (B)(i) Contain or bear a mechanically produced facsimile  
13 signature of the county treasurer under § 21-10-101.

14 (ii) The county treasurer may use his or her  
15 computer-generated digitized signature when the county treasurer has  
16 established adequate internal administrative procedures and controls approved  
17 by the Legislative Joint Auditing Committee.

18  
19 SECTION 2. Arkansas Code § 21-10-101(d), concerning the definition of  
20 a facsimile signature, is amended to read as follows:

21 (d) "Facsimile signature" means the reproduction of the manual  
22 signature of an authorized officer by saving electronically or by engraving,  
23 imprinting, stamping, or other means ~~of the manual signature of an authorized~~  
24 ~~officer.~~

25  
26 SECTION 3. Arkansas Code § 21-10-102 is amended to read as follows:

27 21-10-102. Use of facsimile signature authorized – Filing required.

28 Any authorized officer may, after filing with the Secretary of State  
29 his or her manual signature certified by him or her under oath, execute or  
30 cause to be executed with a facsimile signature in lieu of his manual  
31 signature:

32 (a) Any public security; and

33 (b) Any instrument of payment.

34 Upon compliance with this chapter by the authorized officer, his or her  
35 facsimile signature has the same legal effect as his or her manual signature  
36 and shall be deemed to comply with any statute requiring a manual signature.
