22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 14-15-811(a), concerning the membership of
25 the County Treasurer's Continuing Education Board, is amended to read as
26 follows:

27 (a) There is created the County Treasurer's Continuing Education
28 Board, which shall be composed of the following ~~six (6)~~ members:

29 (1) ~~Four (4)~~ Eight (8) members of the Arkansas County
30 ~~Treasurers'~~ Treasurer's Association, designated by the Arkansas County
31 ~~Treasurers'~~ Treasurer's Association;

32 (2) One (1) member designated by the Association of Arkansas
33 Counties; and

34 (3) The Auditor of State or a person designated by the Auditor
35 of State.

1 SECTION 2. Arkansas Code § 14-15-811(d), concerning the funds in the
2 County Treasurer's Continuing Education Fund, is amended to read as follows:

3 (d) The funds in the County Treasurers' Continuing Education Fund
4 shall be used exclusively for ~~the establishment and operation of:~~

5 (1) Establishing and operating a continuing education program
6 for county treasurers ~~and for paying;~~

7 (2) Paying the meals, lodging, registration fees, and mileage at
8 the rate prescribed in state travel regulations of county treasurers who
9 attend the continuing education program;

10 (3) Acquiring educational materials; and

11 (4) Paying presenter fees and expenses.

13 SECTION 3. Arkansas Code § 14-15-1001(a), concerning the membership of
14 the County Collector's Continuing Education Board, is amended to read as
15 follows:

16 (a) There is ~~hereby~~ created the County Collector's Continuing
17 Education Board, which shall be composed of the following ~~six (6)~~ members:

18 (1) ~~Four (4)~~ Eight (8) members of the Arkansas County Tax
19 ~~Collectors' Collector's~~ Association, designated by the Arkansas County Tax
20 ~~Collectors' Collector's~~ Association;

21 (2) One (1) member designated by the Association of Arkansas
22 Counties; and

23 (3) The Auditor of State or a person designated by the Auditor
24 of State.

26 SECTION 4. Arkansas Code § 14-15-1001(d), concerning the funds in the
27 County Collectors' Continuing Education Trust Fund, is amended to read as
28 follows:

29 (d) The funds in the County Collectors' Continuing Education Trust
30 Fund shall be used exclusively for ~~the establishment and operation of:~~

31 (1) Establishing and operating a continuing education program
32 for county collectors and sheriff-collectors ~~and for paying;~~

33 (2) Paying the meals, lodging, registration fees, and mileage at
34 the rate prescribed in state travel regulations of county collectors and
35 sheriff-collectors who attend the continuing education programs;
