20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
23 for the South Arkansas Community College for the 2017-2018 fiscal year, the  
24 following maximum number of regular employees.

8 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for

9 the South Arkansas Community College for the 2017-2018 fiscal year, the

10 following maximum number of part-time or temporary employees, to be known as

11 "Extra Help", payable from funds appropriated herein for such purposes: one

12 hundred seventy-five (175) temporary or part-time employees, when needed, at

13 rates of pay not to exceed those provided in the Uniform Classification and

14 Compensation Act, or its successor, or this act for the appropriate

15 classification.

17 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby

18 appropriated, to the South Arkansas Community College, to be payable from the

19 South Arkansas Community College Fund, for personal services and operating

20 expenses of the South Arkansas Community College for the fiscal year ending

21 June 30, 2018, the following:

36 SECTION 4. APPROPRIATION - CASH FUNDS. There is hereby appropriated,

1 to the South Arkansas Community College, to be payable from cash funds as  
 2 defined by Arkansas Code 19-4-801 of the South Arkansas Community College,  
 3 for personal services and operating expenses of the South Arkansas Community  
 4 College for the fiscal year ending June 30, 2018, the following:

25 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 26 authorized by this act shall be limited to the appropriation for such agency  
 27 and funds made available by law for the support of such appropriations; and  
 28 the restrictions of the State Procurement Law, the General Accounting and  
 29 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 30 Procedures and Restrictions Act, the Higher Education Expenditures  
 31 Restrictions Act, or their successors, and other fiscal control laws of this  
 32 State, where applicable, and regulations promulgated by the Department of  
 33 Finance and Administration, as authorized by law, shall be strictly complied  
 34 with in disbursement of said funds.

36 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General

1 Assembly that any funds disbursed under the authority of the appropriations  
2 contained in this act shall be in compliance with the stated reasons for  
3 which this act was adopted, as evidenced by the Agency Requests, Executive  
4 Recommendations and Legislative Recommendations contained in the budget  
5 manuals prepared by the Department of Finance and Administration, letters, or  
6 summarized oral testimony in the official minutes of the Arkansas Legislative  
7 Council or Joint Budget Committee which relate to its passage and adoption.  
8

9 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General  
10 Assembly, that the Constitution of the State of Arkansas prohibits the  
11 appropriation of funds for more than a one (1) year period; that the  
12 effectiveness of this Act on July 1, 2017 is essential to the operation of  
13 the agency for which the appropriations in this Act are provided, and that in  
14 the event of an extension of the legislative session, the delay in the  
15 effective date of this Act beyond July 1, 2017 could work irreparable harm  
16 upon the proper administration and provision of essential governmental  
17 programs. Therefore, an emergency is hereby declared to exist and this Act  
18 being necessary for the immediate preservation of the public peace, health  
19 and safety shall be in full force and effect from and after July 1, 2017.
