18        *SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*  
19 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MATCHING*  
20 *FUNDS. The funds appropriated in this Act for Department of Justice Non-*  
21 *Victim Assistance Matching Grants shall be used for matching funds for*  
22 *administering the Federal Grants provided in this Act for the Department of*

29 SECTION 24. EMERGENCY CLAUSE. It is found and determined by the

31 the appropriation of funds for more than a one (1) year period; that the  
32 effectiveness of this Act on July 1, 2017 is essential to the operation of  
33 the agency for which the appropriations in this Act are provided, and that in  
34 the event of an extension of the legislative session, the delay in the  
35 effective date of this Act beyond July 1, 2017 could work irreparable harm  
36 upon the proper administration and provision of essential governmental
