21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the
24 Department of Education - Educational Television Division for the 2017-2018
25 fiscal year, the following maximum number of regular employees.

9 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 11 HELP – STATE OPERATIONS. There is hereby authorized, for the Department of
 12 Education - Educational Television Division – State Operations for the ~~2016-~~
 13 ~~2017~~ 2017-2018 fiscal year, the following maximum number of part-time or
 14 temporary employees, to be known as "Extra Help", payable from funds
 15 appropriated herein for such purposes: five (5) temporary or part-time
 16 employees, when needed, at rates of pay not to exceed those provided in the
 17 Uniform Classification and Compensation Act, or its successor, for the
 18 appropriate classification. Many of these positions are related to specific
 19 projects, and those positions so related are specifically exempt from
 20 limitations of hours, either by act or regulation.

21 The provisions of this section shall be in effect only from July 1, ~~2016~~
 22 2017 through June 30, ~~2017~~ 2018.

24 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby
 25 appropriated, to the Department of Education - Educational Television
 26 Division, to be payable from the Educational Television Fund Account, for

 29 June 30, 2018, the following:

8 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 10 HELP – CASH OPERATIONS. There is hereby authorized, for the Department of
 11 Education - Educational Television Division - Cash Operations for the ~~2016-~~
 12 ~~2017~~ 2017-2018 fiscal year, the following maximum number of part-time or
 13 temporary employees, to be known as "Extra Help", payable from funds
 14 appropriated herein for such purposes: forty-six (46) temporary or part-time
 15 employees, when needed, at rates of pay not to exceed those provided in the
 16 Uniform Classification and Compensation Act, or its successor, for the
 17 appropriate classification. Many of these positions are related to specific
 18 projects, and those positions so related are specifically exempt from
 19 limitations of hours, either by act or regulation.

20 The provisions of this section shall be in effect only from July 1, ~~2016~~
 21 2017 through June 30, ~~2017~~ 2018.

23 SECTION 5. APPROPRIATION - CASH OPERATIONS. There is hereby
 24 appropriated, to the Department of Education - Educational Television
 25 Division, to be payable from the cash fund deposited in the State Treasury as
 26 determined by the Chief Fiscal Officer of the State, for personal services
 27 and operating expenses of the Department of Education - Educational
 28 Television Division - Cash Operations for the fiscal year ending June 30,
 29 2018, the following:

10 SECTION 6. APPROPRIATION - ARKANSAS VETERANS' INITIATIVE. There is

11 hereby appropriated, to the Department of Education - Educational Television

12 Division, to be payable from the Educational Television Fund Account, for

13 personal services and operating expenses for the "Arkansas Veterans'

14 Initiative" documentation project of the Department of Education -

15 Educational Television Division - Arkansas Veterans' Initiative for the

16 fiscal year ending June 30, 2018, the following:

22 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS

24 VETERANS' INITIATIVE. The appropriation authorized in this Act for Arkansas

25 Veterans' Initiative, Stories of Service is not intended to be carried

26 forward into the base level for the purposes of budget preparation. Any

27 appropriation request for this purpose shall be considered a new

28 appropriation request, and therefore will be considered a change level budget

29 request.

30 Notwithstanding any law pertaining to the transfer of year-end fund

31 balances or any law to the contrary, any funds provided to the Educational

32 Television Fund Account for the purpose of funding the Arkansas Veterans'

33 Initiative Appropriation which remain in the Educational Television Fund

34 Account at the end of a fiscal year shall remain in the Educational

35 Television Fund Account and shall continue to be allocated to the Arkansas

36 Veterans' Initiative Appropriation in the following fiscal year.

1 The provisions of this section shall be in effect only from July 1, 2016
2 2017 through June 30, ~~2017~~ 2018.

3
4 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
5 authorized by this act shall be limited to the appropriation for such agency
6 and funds made available by law for the support of such appropriations; and
7 the restrictions of the State Procurement Law, the General Accounting and
8 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
9 Procedures and Restrictions Act, or their successors, and other fiscal
10 control laws of this State, where applicable, and regulations promulgated by
11 the Department of Finance and Administration, as authorized by law, shall be
12 strictly complied with in disbursement of said funds.

13
14 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
15 Assembly that any funds disbursed under the authority of the appropriations
16 contained in this act shall be in compliance with the stated reasons for
17 which this act was adopted, as evidenced by the Agency Requests, Executive
18 Recommendations and Legislative Recommendations contained in the budget
19 manuals prepared by the Department of Finance and Administration, letters, or
20 summarized oral testimony in the official minutes of the Arkansas Legislative
21 Council or Joint Budget Committee which relate to its passage and adoption.

22
23 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
24 General Assembly, that the Constitution of the State of Arkansas prohibits
25 the appropriation of funds for more than a one (1) year period; that the
26 effectiveness of this Act on July 1, 2017 is essential to the operation of
27 the agency for which the appropriations in this Act are provided, and that in
28 the event of an extension of the legislative session, the delay in the
29 effective date of this Act beyond July 1, 2017 could work irreparable harm
30 upon the proper administration and provision of essential governmental
31 programs. Therefore, an emergency is hereby declared to exist and this Act
32 being necessary for the immediate preservation of the public peace, health
33 and safety shall be in full force and effect from and after July 1, 2017.
