

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
23 for the Office of Lieutenant Governor for the 2018-2019 fiscal year, the
24 following maximum number of regular employees.

35 SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated,
36 to the Office of Lieutenant Governor, to be payable from the State Central

 16 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 18 PROVISION. After receiving approval from the Chief Fiscal Officer of the
 19 State, and prior review by the Arkansas Legislative Council or Joint Budget
 20 Committee, the Office of Lieutenant Governor is authorized to transfer
 21 appropriation from any line item authorized in Operations appropriation of
 22 the Lieutenant Governor's Office in this Act to any other line item
 23 authorized in Operations appropriation.

24 The provisions of this section shall be in effect only from July 1, ~~2017~~
 25 2018 through June 30, ~~2018~~ 2019.

 27 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 28 authorized by this act shall be limited to the appropriation for such agency
 29 and funds made available by law for the support of such appropriations; and
 30 the restrictions of the State Procurement Law, the General Accounting and
 31 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 32 Procedures and Restrictions Act, or their successors, and other fiscal
 33 control laws of this State, where applicable, and regulations promulgated by
 34 the Department of Finance and Administration, as authorized by law, shall be
 35 strictly complied with in disbursement of said funds.
