20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Arkansas Public Employees Retirement System for the 2018-2019 fiscal year,

26 SECTION 2. EXTRA HELP. There is hereby authorized, for the Arkansas
 27 Public Employees Retirement System for the 2018-2019 fiscal year, the
 28 following maximum number of part-time or temporary employees, to be known as
 29 "Extra Help", payable from funds appropriated herein for such purposes: six
 30 (6) temporary or part-time employees, when needed, at rates of pay not to
 31 exceed those provided in the Uniform Classification and Compensation Act, or
 32 its successor, or this act for the appropriate classification.

34 SECTION 3. APPROPRIATION - PUBLIC EMPLOYEES RETIREMENT OPERATIONS.
 35 There is hereby appropriated, to the Arkansas Public Employees Retirement
 36 System, to be payable from the Arkansas Public Employees' Retirement System

23 relating to the development, acquisition, and implementation of a new APERS

24 Pension Administration System of the Arkansas Public Employees Retirement

25 System for the fiscal year ending June 30, 2019, the following:

31 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. JUDICIAL

33 RETIREMENT FUND TRANSFERS. A sum not to exceed \$60,050 in the ~~2017-2018~~ 2018-

34 2019 fiscal year may be transferred from the Judges Retirement Fund to the

35 Arkansas Public Employees' Retirement System Fund for costs incurred by the

36 Arkansas Public Employees Retirement System in administering the Judicial

1 Retirement System. Such transfer request shall be made to the Chief Fiscal
2 Officer of the State, and upon his approval, said transfer shall be made on
3 his books and those of the Treasurer of the State and the Auditor of the
4 State.

5 The provisions of this section shall be in effect only from July 1, ~~2017~~
6 2018 through June 30, ~~2018~~ 2019.

7
8 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE
10 POLICE RETIREMENT FUND TRANSFERS. A sum not to exceed \$110,687 in the ~~2017-~~
11 ~~2018~~ 2018-2019 fiscal year may be transferred from the State Police
12 Retirement Fund to the Arkansas Public Employees' Retirement System Fund for
13 costs incurred by the Arkansas Public Employees Retirement System in
14 administering the State Police Retirement System. Such transfer request
15 shall be made to the Chief Fiscal Officer of the State, and upon his
16 approval, said transfer shall be made on his books and those of the Treasurer
17 of the State and the Auditor of the State.

18 The provisions of this section shall be in effect only from July 1, ~~2017~~
19 2018 through June 30, ~~2018~~ 2019.

20
21 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXEMPTION
23 FROM PRIOR REVIEW. The Arkansas Public Employees Retirement System is hereby
24 exempted from seeking prior review by the Arkansas Legislative Council or
25 Joint Budget Committee with regard to transfers between the Benefits line
26 item in the Public Employees Retirement Cash appropriation section and the
27 Benefits-Non Employee line item in the Public Employees Retirement Operations
28 appropriation section which are specifically related to transfers
29 necessitated by the changes in retirees' selection of the method of payment
30 of retirement benefits. All other provisions of Arkansas Code §19-4-522
31 shall be applicable.

32 The provisions of this section shall be in effect only from July 1, ~~2017~~
33 2018 through June 30, ~~2018~~ 2019.

34
35 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL

1 STATE POLICE RETIREMENT FUND TRANSFERS. A sum not to exceed \$50,000 may be
2 transferred from the State Police Retirement Fund to the Arkansas Public
3 Employees' Retirement System Fund to share in the costs incurred by the
4 Arkansas Public Employees Retirement System in the purchase and
5 implementation of a new pension administration system, which will be utilized
6 to administer State Police pension transactions for members and retirees.
7 Said transfer shall sunset at the end of fiscal year ~~2018~~ 2019. Such
8 transfer request shall be made to the Chief Fiscal officer of the State, and
9 upon his approval, said transfer shall be made on his books and those of the
10 Treasurer of the State and the Auditor of the State.

11 The provisions of this section shall be in effect only from July 1, ~~2017~~
12 2018 through June 30, ~~2018~~ 2019.

13
14 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
16 JUDICIAL RETIREMENT FUND TRANSFERS. A sum not to exceed \$50,000 may be
17 transferred from the Judicial Retirement Fund to the Arkansas Public
18 Employees' Retirement System Fund to share in the costs incurred by the
19 Arkansas Public Employees Retirement System in the purchase and
20 implementation of a new pension administration system, which will be utilized
21 to administer Judicial pension transactions for members and retirees. Said
22 transfer shall sunset at the end of fiscal year ~~2018~~ 2019. Such transfer
23 request shall be made to the Chief Fiscal Officer of the State, and upon his
24 approval, said transfer shall be made on his books and those of the Treasurer
25 of State and the Auditor of the State.

26 The provisions of this section shall be in effect only from July 1, ~~2017~~
27 2018 through June 30, ~~2018~~ 2019.

28
29 SECTION 15. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
30 authorized by this act shall be limited to the appropriation for such agency
31 and funds made available by law for the support of such appropriations; and
32 the restrictions of the State Procurement Law, the General Accounting and
33 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
34 Procedures and Restrictions Act, or their successors, and other fiscal
35 control laws of this State, where applicable, and regulations promulgated by
36 the Department of Finance and Administration, as authorized by law, shall be

1 strictly complied with in disbursement of said funds.

2
3 SECTION 16. LEGISLATIVE INTENT. It is the intent of the General
4 Assembly that any funds disbursed under the authority of the appropriations
5 contained in this act shall be in compliance with the stated reasons for
6 which this act was adopted, as evidenced by the Agency Requests, Executive
7 Recommendations and Legislative Recommendations contained in the budget
8 manuals prepared by the Department of Finance and Administration, letters, or
9 summarized oral testimony in the official minutes of the Arkansas Legislative
10 Council or Joint Budget Committee which relate to its passage and adoption.

11
12 SECTION 17. EFFECTIVE DATE. This act is effective on and after July 1,
13 2018.
