## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 AND OPERATING EXPENSES FOR THE ARKANSAS DEVELOPMENT  
10 FINANCE AUTHORITY FOR THE FISCAL YEAR ENDING JUNE 30,  
11 2019; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT FOR THE ARKANSAS DEVELOPMENT  
15 FINANCE AUTHORITY APPROPRIATION FOR THE  
16 2018-2019 FISCAL YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the  
23 Arkansas Development Finance Authority for the 2018-2019 fiscal year, the  
24 following maximum number of regular employees.

 18 SECTION 2. EXTRA HELP. There is hereby authorized, for the Arkansas  
 19 Development Finance Authority for the 2018-2019 fiscal year, the following  
 20 maximum number of part-time or temporary employees, to be known as "Extra  
 21 Help", payable from funds appropriated herein for such purposes: five (5)  
 22 temporary or part-time employees, when needed, at rates of pay not to exceed  
 23 those provided in the Uniform Classification and Compensation Act, or its  
 24 successor, or this act for the appropriate classification.

25  
 26 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 27 to the Arkansas Development Finance Authority, to be payable from cash funds  
 28 as defined by Arkansas Code 19-4-801 of the Arkansas Development Finance  
 29 Authority, for personal services, operating expenses, data processing  
 30 services and grants and aid by the Arkansas Development Finance Authority for  
 31 the fiscal year ending June 30, 2019, the following:

 20 Housing Trust Fund Advisory Committee for the fiscal year ending June 30,

27 SECTION 5. APPROPRIATION - STUDENT LOAN AUTHORITY DIVISION. There is  
 28 hereby appropriated, to the Arkansas Development Finance Authority, to be  
 29 payable from cash funds as defined by Arkansas Code 19-4-801 of the Arkansas  
 30 Development Finance Authority, for personal services and operating expenses  
 31 of the Arkansas Development Finance Authority - Student Loan Authority  
 32 Division for the fiscal year ending June 30, 2019, the following:

10 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HUD HOME  
 12 PROGRAM DISBURSEMENTS. The disbursement of funds appropriated in the HUD Home  
 13 Program of this Act shall be in accordance with the State of Arkansas  
 14 Consolidated Plan developed and administered in part by the Arkansas  
 15 Development Finance Authority and shall be in accordance with project  
 16 requirements and regulations of the U.S. Department of Housing and Urban  
 17 Development HOME Program.

18 The provisions of this section shall be in effect only from July 1, ~~2017~~  
 19 2018 through June 30, ~~2018~~ 2019.

20

21 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 22 authorized by this act shall be limited to the appropriation for such agency  
 23 and funds made available by law for the support of such appropriations; and  
 24 the restrictions of the State Procurement Law, the General Accounting and  
 25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 26 Procedures and Restrictions Act, or their successors, and other fiscal  
 27 control laws of this State, where applicable, and regulations promulgated by  
 28 the Department of Finance and Administration, as authorized by law, shall be  
 29 strictly complied with in disbursement of said funds.

30

31 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General  
 32 Assembly that any funds disbursed under the authority of the appropriations  
 33 contained in this act shall be in compliance with the stated reasons for  
 34 which this act was adopted, as evidenced by the Agency Requests, Executive  
 35 Recommendations and Legislative Recommendations contained in the budget  
 36 manuals prepared by the Department of Finance and Administration, letters, or

1 summarized oral testimony in the official minutes of the Arkansas Legislative  
2 Council or Joint Budget Committee which relate to its passage and adoption.

3  
4 SECTION 9. EFFECTIVE DATE. This act is effective on and after July 1,  
5 2018.
