9 MATCHING FOR THE PHILLIPS COMMUNITY COLLEGE OF THE

11 AND IN ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 97
12 OF 2017; AND FOR OTHER PURPOSES.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. APPROPRIATION - STATE OPERATIONS - HELENA CAMPUS. There is
24 hereby appropriated, to the Phillips Community College of the University of
25 Arkansas, to be payable from the Phillips Community College of the University
26 of Arkansas Fund, for personal services matching of the Phillips Community
27 College of the University of Arkansas which shall be supplemental and in
28 addition to those funds appropriated in Section 5 of Act 97 of 2017, the
29 following:

35 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
36 authorized by this act shall be limited to the appropriation for such agency



1 and funds made available by law for the support of such appropriations; and
2 the restrictions of the State Procurement Law, the General Accounting and
3 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
4 Procedures and Restrictions Act, or their successors, and other fiscal
5 control laws of this State, where applicable, and regulations promulgated by
6 the Department of Finance and Administration, as authorized by law, shall be
7 strictly complied with in disbursement of said funds.

8
9 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
10 Assembly that any funds disbursed under the authority of the appropriations
11 contained in this act shall be in compliance with the stated reasons for
12 which this act was adopted, as evidenced by the Agency Requests, Executive
13 Recommendations and Legislative Recommendations contained in the budget
14 manuals prepared by the Department of Finance and Administration, letters, or
15 summarized oral testimony in the official minutes of the Arkansas Legislative
16 Council or Joint Budget Committee which relate to its passage and adoption.

18 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
19 Assembly, that funds provided by the General Assembly for the operations of
20 the Phillips Community College of the University of Arkansas are, due to
21 unforeseen circumstances, insufficient for the Phillips Community College of
22 the University of Arkansas to continue to provide essential governmental
23 services; that the provisions of this act will provide the necessary monies
24 for the Phillips Community College of the University of Arkansas to continue
25 such services; and that a delay in the effective date of this Act could work
26 irreparable harm upon the proper administration and provision of essential
27 governmental programs. Therefore, an emergency is hereby declared to exist
28 and this Act being necessary for the immediate preservation of the public
29 peace, health and safety shall be in full force and effect from and after the
30 date of its passage and approval.

31 If the bill is neither approved nor vetoed by the Governor, it shall
32 become effective on the expiration of the period of time during which the
33 Governor may veto the bill. If the bill is vetoed by the Governor and the
34 veto is overridden, it shall become effective on the date the last house
35 overrides the veto.
