19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. APPROPRIATION. There is hereby appropriated, to the
22 Department of Finance and Administration - Revenue Services Division, to be
23 payable from the Miscellaneous Revolving Fund, for the purpose of paying
24 claims against the State of Arkansas to the payee set out herein:

 12 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 13 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRYOVER
 14 OF CLAIMS. Any state agency which is affected by the allowed claim(s)
 15 provided for in this Act, and whose fund for the ~~2016-2017~~ 2017-2018 fiscal
 16 year are insufficient to allow for the payment of said claim(s) before June
 17 30, ~~2017~~ 2018, is hereby authorized, upon certification by the Chief Fiscal
 18 Officer of the State, to make payment of said claim(s) after July 1, ~~2017~~
 19 2018, from funds appropriated for the ~~2017-2018~~ 2018-2019 fiscal year.

 21 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 23 DISBURSING OFFICER. The Clerk of the State Claims Commission is hereby made
 24 the disbursing officer for the purpose of paying the claims appropriated by
 25 this Act. The Clerk of the State Claims Commission is hereby authorized to
 26 receive all warrants prepared under the provisions of this Act from the
 27 Auditor of State and to distribute same to the claimants.

 29 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
 31 DEPARTMENT OF HUMAN SERVICES CLAIMS. For any claims in this Act appropriated
 32 to the Department of Human Services, the Clerk of the State Claims Commission
 33 shall consult with the Department of Human Services and the Chief Fiscal
 34 Officer of the State to determine the division and funds to which liability
 35 should be assigned and from which the warrants shall be drawn. The Clerk of
 36 the State Claims Commission shall initiate the appropriate transfers as may

1 be required and as approved by the Chief Fiscal Officer of the State.

2
 3 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
 5 DEPARTMENT OF HEALTH CLAIMS. For any claims in this Act appropriated to the
 6 Department of Health, the Clerk of the State Claims Commission shall consult
 7 with the Department of Health and the Chief Fiscal Officer of the State to
 8 determine the division and funds to which liability should be assigned and
 9 from which the warrants shall be drawn. The Clerk of the State Claims
 10 Commission shall initiate the appropriate transfers as may be required and as
 11 approved by the Chief Fiscal Officer of the State.

12
 13 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CLAIMS
 15 FROM CASH FUNDS. In the event that any claim authorized herein is determined
 16 to be a valid claim against the State and the claim is to be paid from funds
 17 not in the State Treasury, the Clerk of the State Claims Commission shall
 18 notify the agency against which the claim is to be charged of the amount of
 19 such claims. Upon receipt of such notification, the state agency shall
 20 forth-with deliver a check to the Clerk of the State Claims Commission who
 21 shall deposit the same as a nonrevenue receipt into the Miscellaneous
 22 Revolving Fund from which he shall disburse the amount of the claim to the
 23 claimant.

24
 25 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 27 EMPLOYMENT COMPENSATION CLAIMS. The Clerk of the State Claims Commission
 28 shall not distribute any warrants prepared under the provisions of this Act
 29 for awards made by the Arkansas State Claims Commission for employment
 30 compensation claims. Upon the award by the State Claims Commission of an
 31 employment compensation claim, the Clerk of the State Claims Commission shall
 32 notify the affected state agency and the Department of Finance and
 33 Administration - Office of Personnel Management of such amounts that are due
 34 and payable. The affected state agency shall then process the award through
 35 the State Mechanized Payroll System.

1 SECTION 16. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 2 authorized by this act shall be limited to the appropriation for such agency
 3 and funds made available by law for the support of such appropriations; and
 4 the restrictions of the State Procurement Law, the General Accounting and
 5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 6 Procedures and Restrictions Act, or their successors, and other fiscal
 7 control laws of this State, where applicable, and regulations promulgated by
 8 the Department of Finance and Administration, as authorized by law, shall be
 9 strictly complied with in disbursement of said funds.

10
 11 SECTION 17. LEGISLATIVE INTENT. It is the intent of the General
 12 Assembly that any funds disbursed under the authority of the appropriations
 13 contained in this act shall be in compliance with the stated reasons for
 14 which this act was adopted, as evidenced by the Agency Requests, Executive
 15 Recommendations and Legislative Recommendations contained in the budget
 16 manuals prepared by the Department of Finance and Administration, letters, or
 17 summarized oral testimony in the official minutes of the Arkansas Legislative
 18 Council or Joint Budget Committee which relate to its passage and adoption.

19
 20 SECTION 18. EMERGENCY CLAUSE. It is found and determined by the
 21 General Assembly, that payees listed in this Act may be entitled to the sums
 22 appropriated and transferred to herein, and that they have been deprived of
 23 the use of these funds for a long period of time, and that further delay in
 24 paying these just debts of the state would do harm to the reputation of the
 25 State of Arkansas. Therefore, an emergency is hereby declared to exist and
 26 this Act being necessary for the immediate preservation of the public peace,
 27 health and safety shall be in full force and effect from and after the date
 28 of its passage and approval.
 29 If the bill is neither approved nor vetoed by the Governor, it shall become
 30 effective on the expiration of the period of time during which the Governor
 31 may veto the bill. If the bill is vetoed by the Governor and the veto is
 32 overridden, it shall become effective on the date the last house overrides
 33 the veto.
