34 but not limited to federal funds, general revenue, severance tax, acreage
35 tax, timber sales and seedlings sales.

36 d) All Arkansas Forestry Commission activities including but not limited

1 to, firefighting activities, fire prevention, and emergency response as it
2 relates to the Commission's statutory mission provided in Arkansas Code 15-
3 31-101.

4 The provisions of this section shall be in effect only from July 1, ~~2017~~
5 2018 through June 30, ~~2018~~ 2019.

6
7 SECTION 43. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

9 PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall establish
10 upon request for the Arkansas Agriculture Department a special Promotional
11 Items appropriation to be used in the acquisition of promotional items.
12 When the Arkansas Agriculture Department wishes to transfer from its
13 operating expenses to the promotional items line, the request shall be
14 forwarded by the Arkansas Agriculture Department to the Chief Fiscal Officer
15 of the State for processing and for prior approval by the Arkansas
16 Legislative Council or Joint Budget Committee. Determining the maximum
17 number of employees and the maximum amount of appropriation and general
18 revenue funding for a state agency each fiscal year is the prerogative of the
19 General Assembly. This is usually accomplished by delineating such maximums
20 in the appropriation act(s) for a state agency and the general revenue
21 allocations authorized for each fund and fund account by amendment to the
22 Revenue Stabilization law. Further, the General Assembly has determined that
23 the Arkansas Agriculture Department may operate more efficiently if some
24 flexibility is provided to the Arkansas Agriculture Department authorizing
25 broad powers under this Section. Therefore, it is both necessary and
26 appropriate that the General Assembly maintain oversight by requiring prior
27 approval of the Legislative Council or Joint Budget Committee as provided by
28 this section. The requirement of approval by the Legislative Council or
29 Joint Budget Committee is not a severable part of this section. If the
30 requirement of approval by the Legislative Council or Joint Budget Committee
31 is ruled unconstitutional by a court of competent jurisdiction, this entire
32 section is void.

33 The provisions of this section shall be in effect only from July 1, ~~2017~~
34 2018 through June 30, ~~2018~~ 2019.

35
36 SECTION 44. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SHARED
2 SERVICES. The Chief Fiscal Officer of the State shall be authorized to create
3 paying accounts, on his or her books and on the books of the Treasurer of the
4 State and Auditor of State for the payment of all personal services and
5 operating expenses of the Department, as well as grant programs as determined
6 by the Secretary of the Arkansas Agriculture Department. The Chief Fiscal
7 Officer of the state shall direct the transfer of positions, funds and
8 appropriations to the paying accounts on the books of the Treasurer of State,
9 the Auditor of State, and the Chief Fiscal Officer of the State for the
10 efficient operations of the Department.

11 The provisions of this section shall be in effect only from July 1, ~~2017~~
12 2018 through June 30, ~~2018~~ 2019.

13
14 *SECTION 45. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
15 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FAIR*
16 *WAIVER. The Arkansas Livestock and Poultry Commission shall waive the rules*
17 *under Section (2) of the Commission's Minimum Standards for Receiving Funds*
18 *for Premium and Construction Purposes to allow the Three-County Fair,*
19 *consisting of Cross, Woodruff, and Jackson counties, to hold the Three-County*
20 *Fair after the district fair while receiving the funds from the commission*
21 *that the Three-County Fair would receive if the fair were held before the*
22 *district fair.*

23 *The provisions of this section shall be in effect only from July 1, 2018*
24 *through June 30, 2019.*

25
26 *SECTION 46. COMPLIANCE WITH OTHER LAWS.* Disbursement of funds
27 authorized by this act shall be limited to the appropriation for such agency
28 and funds made available by law for the support of such appropriations; and
29 the restrictions of the State Procurement Law, the General Accounting and
30 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
31 Procedures and Restrictions Act, or their successors, and other fiscal
32 control laws of this State, where applicable, and regulations promulgated by
33 the Department of Finance and Administration, as authorized by law, shall be
34 strictly complied with in disbursement of said funds.

35
36 *SECTION 47. LEGISLATIVE INTENT.* It is the intent of the General

1 Assembly that any funds disbursed under the authority of the appropriations
2 contained in this act shall be in compliance with the stated reasons for
3 which this act was adopted, as evidenced by the Agency Requests, Executive
4 Recommendations and Legislative Recommendations contained in the budget
5 manuals prepared by the Department of Finance and Administration, letters, or
6 summarized oral testimony in the official minutes of the Arkansas Legislative
7 Council or Joint Budget Committee which relate to its passage and adoption.

8
9 SECTION 48. EFFECTIVE DATE. This act is effective on and after July 1,
10 2018.
