22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. REGULAR SALARIES. There is hereby established for the Board
25 of Examiners in Speech-Language Pathology and Audiology for the 2018-2019
26 fiscal year, the following maximum number of regular employees.

35 SECTION 2. EXTRA HELP. There is hereby authorized, for the Board of
36 Examiners in Speech-Language Pathology and Audiology for the 2018-2019 fiscal



1 year, the following maximum number of part-time or temporary employees, to be
2 known as "Extra Help", payable from funds appropriated herein for such
3 purposes: one (1) temporary or part-time employees, when needed, at rates of
4 pay not to exceed those provided in the Uniform Classification and
5 Compensation Act, or its successor, or this act for the appropriate
6 classification.

7
8 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
9 to the Board of Examiners in Speech-Language Pathology and Audiology, to be
10 payable from the cash fund deposited in the State Treasury as determined by
11 the Chief Fiscal Officer of the State, for personal services and operating
12 expenses of the Board of Examiners in Speech-Language Pathology and Audiology
13 for the fiscal year ending June 30, 2019, the following:

29 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

31 INVESTIGATOR. The Board of Examiners in Speech-Language Pathology and
32 Audiology shall contract with an outside investigator, as needed, to perform
33 investigations and conduct inspections of alleged wrongdoing. The duties of
34 the investigator hired shall include, but not be limited to, investigation
35 and inspection of all complaints as determined by the Board, to determine
36 whether or not any persons have

- 1 (1) Practiced their profession in such a way as to endanger the general
- 2 health and welfare of the public; or
- 3 (2) Otherwise violated the practice act or rules and regulations of the
- 4 Speech-Language Pathology and Audiology Board.

5 The provisions of this section shall be in effect only from July 1, ~~2017~~

6 2018 through June 30, ~~2018~~ 2019.

7

8 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

9 authorized by this act shall be limited to the appropriation for such agency

10 and funds made available by law for the support of such appropriations; and

11 the restrictions of the State Procurement Law, the General Accounting and

12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

13 Procedures and Restrictions Act, or their successors, and other fiscal

14 control laws of this State, where applicable, and regulations promulgated by

15 the Department of Finance and Administration, as authorized by law, shall be

16 strictly complied with in disbursement of said funds.

17

18 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General

19 Assembly that any funds disbursed under the authority of the appropriations

20 contained in this act shall be in compliance with the stated reasons for

21 which this act was adopted, as evidenced by the Agency Requests, Executive

22 Recommendations and Legislative Recommendations contained in the budget

23 manuals prepared by the Department of Finance and Administration, letters, or

24 summarized oral testimony in the official minutes of the Arkansas Legislative

25 Council or Joint Budget Committee which relate to its passage and adoption.

27 SECTION 7. EFFECTIVE DATE. This act is effective on and after July 1,

28 2018.
