25 *USAGE AUTHORIZED.* The Arkansas Children's Hospital President and C.E.O. may
26 request the Department of Human Services-Division of Medical Services to
27 retain in the Department of Human Services Grant Fund account an amount not
28 to exceed \$1,000,000 for funds made available by the act to be used to match
29 federal funds used for supplemental Medicaid payments to Arkansas Children's
30 Hospital.

31 The provisions of this section shall be in effect only from July 1, ~~2018~~
32 2019 through June 30, ~~2019~~ 2020.

34 *SECTION 71. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
35 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER*

36 *PROCEDURES - MEDICAL MARIJUANA IMPLEMENTATION AND REGULATION.* In the event

1 that sufficient appropriation is not provided by the General Assembly for
2 expenditures resulting from the implementation and regulation of the Arkansas
3 Medical Marijuana Amendment of 2016 for any state agency, pursuant to
4 Arkansas Code § 19-4-701 et seq., said agency shall request a transfer of
5 appropriation from the Chief Fiscal Officer of the State, stating clearly the
6 amount required. Upon approval of the Chief Fiscal Officer of the State said
7 appropriations shall be established upon the books of the Department of
8 Finance and Administration in compliance with the applicable classifications
9 of appropriations as enumerated in Arkansas Code §§ 19-4-521 through 19-4-
10 527.

11 The provisions of this section shall be in effect only from July 1, ~~2018~~
12 2019 through June 30, ~~2019~~ 2020.

13
14 *SECTION 72. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
15 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND*
16 *TRANSFER AUTHORITY. From time to time, the Chief Fiscal Officer of the State*
17 *may transfer from his or her books and those of the Treasurer of State and*
18 *the Auditor of State from the Medical Marijuana Implementation and Operations*
19 *Fund to various state agencies' funds the amounts necessary to fund the*
20 *expenses for the implementation, administration, and/or enforcement of the*
21 *Arkansas Medical Marijuana Amendment of 2016.*

22 The provisions of this section shall be in effect only from July 1, ~~2018~~
23 2019 through June 30, ~~2019~~ 2020.

24
25 *SECTION 73. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
26 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BLANKET*
27 *BOND PROGRAM. The Director of the Department of Finance and Administration*
28 *is authorized to transfer Appropriation between the Blanket Surety Bond*
29 *Program appropriations authorized for State Employees (Appropriation 2DM),*
30 *County Employees (Appropriation 2DN), Municipal Employees (Appropriation 2DP)*
31 *and Public School Employees (Appropriation 2DQ).*

32 The provisions of this section shall be in effect only from July 1,
33 2019 through June 30, 2020.

35 *SECTION 74. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS*
36 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER*

1 PROCEDURES - VARIOUS TEMPORARY APPROPRIATION FOR STATE AGENCIES AND
2 INSTITUTIONS. (i) In the event that sufficient appropriation is not provided
3 by the General Assembly for any state agency or institution, an agency or
4 institution may request a transfer of appropriation, as provided in the
5 Various Temporary Appropriation for State Agencies and Institutions
6 Appropriation Section of this Act, from the Chief Fiscal Officer of the
7 State, stating clearly the amount requested, purpose and any additional
8 information requested by the Chief Fiscal Officer of the State.
9 (ii) After reviewing a request the Chief Fiscal Officer of the State may
10 deny, modify or approve the agencies or institutions request based on the
11 estimated amount of appropriation needed and currently available, purpose,
12 estimated funding available and preferred spending priority. Upon approval
13 or modification of a request by the Chief Fiscal Officer of the State and
14 after meeting the requirements of subsection (iii) herein, the Department of
15 Finance and Administration shall establish the transfer of appropriation on
16 the books of the Department of Finance and Administration and the State
17 Auditor, in compliance with the applicable classifications of appropriations
18 as enumerated in Arkansas Code 19-4-521 through 19-4-525.
19 (iii) Any request approved as authorized in subsection (ii) herein,
20 including requests that establish a new commitment item or new appropriation
21 shall require prior approval by the Arkansas Legislative Council or if
22 meeting in Regular or Fiscal Session the Joint Budget Committee.
23 (iv) Any appropriation approved as authorized in this Section shall not be
24 carried forward to the next fiscal year and shall be identified as a change
25 level increase by the state agency or institution, if requested.
26 (v) Determining the maximum amount of appropriation for a state agency or
27 institution each fiscal year is the prerogative of the General Assembly.
28 This is usually accomplished by delineating such maximums in the
29 appropriation act(s) for a state agency or institution. Further, the General
30 Assembly has determined that a state agency or institution may operate more
31 efficiently if some flexibility is provided to the state agency or
32 institution authorizing broad powers under this section. Therefore, it is
33 both necessary and appropriate that the General Assembly maintain oversight
34 by requiring prior approval of the Legislative Council or Joint Budget
35 Committee as provided by this section. The requirement of approval by the
36 Legislative Council or Joint Budget Committee is not a severable part of this

1 section. If the requirement or approval by the Legislative Council or Joint
2 Budget Committee is ruled unconstitutional by a court of competent
3 jurisdiction, this entire section is void.

4 The provisions of this section shall be in effect only from July 1, 2019
5 through June 30, 2020.

7 *SECTION 75. CODE AMENDMENT. Arkansas Code § 14-171-215(a)(5),*
8 *concerning the payments to the Arkansas State Fair and Livestock Show*
9 *Association from the City-County Tourist Facilities Aid Fund, is amended to*
10 *read as follows:*

11 (M) Eight hundred eighty-seven thousand nine hundred eight
12 dollars (\$887,908) in the fiscal year 2021;

13 (N) Eight hundred eighty-seven thousand nine hundred eight
14 dollars (\$887,908) in the fiscal year 2022;

15 (O) Eight hundred eighty-seven thousand nine hundred eight
16 dollars (\$887,908) in the fiscal year 2023;

17 (P) Eight hundred eighty-seven thousand nine hundred eight
18 dollars (\$887,908) in the fiscal year 2024; and

19 (Q) Eight hundred eighty-seven thousand nine hundred eight
20 dollars (\$887,908) in the fiscal year 2025.

22 *SECTION 76. COMPLIANCE WITH OTHER LAWS. Disbursement of funds*
23 *authorized by this act shall be limited to the appropriation for such agency*
24 *and funds made available by law for the support of such appropriations; and*
25 *the restrictions of the State Procurement Law, the General Accounting and*
26 *Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary*
27 *Procedures and Restrictions Act, or their successors, and other fiscal*
28 *control laws of this State, where applicable, and regulations promulgated by*
29 *the Department of Finance and Administration, as authorized by law, shall be*
30 *strictly complied with in disbursement of said funds.*

31
32 *SECTION 77. LEGISLATIVE INTENT. It is the intent of the General*
33 *Assembly that any funds disbursed under the authority of the appropriations*
34 *contained in this act shall be in compliance with the stated reasons for*
35 *which this act was adopted, as evidenced by the Agency Requests, Executive*
36 *Recommendations and Legislative Recommendations contained in the budget*

1 manuals prepared by the Department of Finance and Administration, letters, or
2 summarized oral testimony in the official minutes of the Arkansas Legislative
3 Council or Joint Budget Committee which relate to its passage and adoption.
4

5 SECTION 78. EMERGENCY CLAUSE. It is found and determined by the
6 General Assembly, that the Constitution of the State of Arkansas prohibits
7 the appropriation of funds for more than a one (1) year period; that the
8 effectiveness of this Act on July 1, 2019 is essential to the operation of
9 the agency for which the appropriations in this Act are provided, and that in
10 the event of an extension of the legislative session, the delay in the
11 effective date of this Act beyond July 1, 2019 could work irreparable harm
12 upon the proper administration and provision of essential governmental
13 programs. Therefore, an emergency is hereby declared to exist and this Act
14 being necessary for the immediate preservation of the public peace, health
15 and safety shall be in full force and effect from and after July 1, 2019.
