

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established

26 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for

27 the University of Arkansas at Pine Bluff for the 2019-2020 fiscal year, the

28 following maximum number of part-time or temporary employees, to be known as

29 "Extra Help", payable from funds appropriated herein for such purposes: nine

30 hundred twenty-four (924) temporary or part-time employees, when needed, at

31 rates of pay not to exceed those provided in the Uniform Classification and

32 Compensation Act, or its successor, or this act for the appropriate

33 classification.

35 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby

36 appropriated, to the University of Arkansas at Pine Bluff, to be payable from

1 the University of Arkansas at Pine Bluff Fund, for personal services and
 2 operating expenses of the University of Arkansas at Pine Bluff for the fiscal

8 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
10 ALLOWANCES. The Board of Trustees, after seeking prior review by the
11 Arkansas Legislative Council or Joint Budget Committee, may approve the
12 employment of competent scientists with extraordinary research capabilities
13 to conduct research in the Biomedical Research Center established at the
14 University of Arkansas at Pine Bluff. Further, that the Board of Trustees of
15 the University of Arkansas be authorized to approve salaries for scientists
16 up to, but not to exceed, one and one-half of that portion of the
17 Distinguished Professor line item maximum authorized by the General Assembly
18 to be paid from University of Arkansas at Pine Bluff funds.

19 The provisions of this section shall be in effect only from July 1, ~~2018~~
20 2019 through June 30, ~~2019~~ 2020.

21

22 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. JENKINS
24 CENTER. Of the funds appropriated in the State Operations appropriation
25 section, the sum of \$252,558 for the fiscal year shall be used to provide
26 support to the Jenkins Center in Pine Bluff. Provided, however, such funds
27 shall be used to conduct and maintain a University training program in
28 cooperation with the Jenkins Center. Provided, further, any reductions in
29 funding for appropriation provided in the State Operations appropriation
30 section shall be proportionately applied to the funds set out herein for
31 support.

32 The provisions of this section shall be in effect only from July 1, ~~2018~~
33 2019 through June 30, ~~2019~~ 2020.

34

35 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FORMULA

1 COMPUTATIONS – 1890 MATCHING FUNDS. Any computations made by the Department
2 of Higher Education and the Arkansas Higher Education Coordinating Board in
3 determining levels of recommended funding for the University of Arkansas at
4 Pine Bluff shall include 100% matching funds for the 1890 Research and
5 Extension Programs in the base.

6 The provisions of this section shall be in effect only from July 1, ~~2018~~
7 2019 through June 30, ~~2019~~ 2020.

8

9 SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
11 ALLOWANCES. For the purpose of providing necessary allowances for housing and
12 other unusual expenses incurred by or in behalf of the athletic director,
13 associate/assistant athletic directors, head coaches, and assistant coaches
14 at the University of Arkansas at Pine Bluff, the Board of Trustees may make
15 special allowances available therefore in such amounts as the Board of
16 Trustees may determine as justified, an equitable allowance in view of the
17 unusual and exacting duties of said athletic director, associate/assistant
18 athletic directors, head coaches, and assistant coaches, and for the purpose
19 of providing such allowances, the Board of Trustees is authorized to expend
20 from the auxiliary income of the University of Arkansas at Pine Bluff, which
21 is derived from athletic event receipts. Provided that any such allowances
22 shall be in addition to the regular salary of such athletic director,
23 associate/assistant athletic directors, head coaches and assistant coaches,
24 as established herein provided that the amount of such allowance shall not
25 exceed ten thousand dollars (\$10,000) per annum for any one salaried
26 position. Further, if the special allowance funds authorized herein are
27 utilized the University of Arkansas at Pine Bluff shall report annually to
28 the Legislative Joint Auditing Committee the exact disposition of those
29 special allowance funds.

30 The provisions of this section shall be in effect only from July 1, ~~2018~~
31 2019 through June 30, ~~2019~~ 2020.

32

33 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
34 authorized by this act shall be limited to the appropriation for such agency
35 and funds made available by law for the support of such appropriations; and
36 the restrictions of the State Procurement Law, the General Accounting and

1 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
2 Procedures and Restrictions Act, the Higher Education Expenditures
3 Restrictions Act, or their successors, and other fiscal control laws of this
4 State, where applicable, and regulations promulgated by the Department of
5 Finance and Administration, as authorized by law, shall be strictly complied
6 with in disbursement of said funds.

7
8 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General
9 Assembly that any funds disbursed under the authority of the appropriations
10 contained in this act shall be in compliance with the stated reasons for
11 which this act was adopted, as evidenced by the Agency Requests, Executive
12 Recommendations and Legislative Recommendations contained in the budget
13 manuals prepared by the Department of Finance and Administration, letters, or
14 summarized oral testimony in the official minutes of the Arkansas Legislative
15 Council or Joint Budget Committee which relate to its passage and adoption.

16
17 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the
18 General Assembly, that the Constitution of the State of Arkansas prohibits
19 the appropriation of funds for more than a one (1) year period; that the
20 effectiveness of this Act on July 1, 2019 is essential to the operation of
21 the agency for which the appropriations in this Act are provided, and that in
22 the event of an extension of the legislative session, the delay in the
23 effective date of this Act beyond July 1, 2019 could work irreparable harm
24 upon the proper administration and provision of essential governmental
25 programs. Therefore, an emergency is hereby declared to exist and this Act
26 being necessary for the immediate preservation of the public peace, health
27 and safety shall be in full force and effect from and after July 1, 2019.
