## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR OPERATING  
9 EXPENSES FOR THE HENDERSON STATE UNIVERSITY WHICH  
10 SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
11 APPROPRIATED BY ACT 174 OF 2018; AND FOR OTHER  
12 PURPOSES.

## Subtitle

15 AN ACT FOR THE HENDERSON STATE UNIVERSITY  
16 SUPPLEMENTAL APPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby  
23 appropriated, to the Henderson State University, to be payable from the  
24 Henderson State University Fund, for operating expenses of the Henderson  
25 State University which shall be supplemental and in addition to those funds  
26 appropriated in Section 3 of Act 174 of 2018, the following:

 3 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 4 authorized by this act shall be limited to the appropriation for such agency  
 5 and funds made available by law for the support of such appropriations; and  
 6 the restrictions of the State Procurement Law, the General Accounting and  
 7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 8 Procedures and Restrictions Act, the Higher Education Expenditures  
 9 Restrictions Act or their successors, and other fiscal control laws of this  
 10 State, where applicable, and regulations promulgated by the Department of  
 11 Finance and Administration, as authorized by law, shall be strictly complied  
 12 with in disbursement of said funds.

13  
 14 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General  
 15 Assembly that any funds disbursed under the authority of the appropriations  
 16 contained in this act shall be in compliance with the stated reasons for  
 17 which this act was adopted, as evidenced by the Agency Requests, Executive  
 18 Recommendations and Legislative Recommendations contained in the budget  
 19 manuals prepared by the Department of Finance and Administration, letters, or  
 20 summarized oral testimony in the official minutes of the Arkansas Legislative  
 21 Council or Joint Budget Committee which relate to its passage and adoption.

22  
 23 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General  
 24 Assembly, that funds provided by the General Assembly for the operations of  
 25 the Henderson State University are, due to unforeseen circumstances,  
 26 insufficient for the Henderson State University to continue to provide  
 27 essential governmental services; that the provisions of this act will provide  
 28 the necessary monies for the Henderson State University to continue such  
 29 services; and that a delay in the effective date of this Act could work  
 30 irreparable harm upon the proper administration and provision of essential  
 31 governmental programs. Therefore, an emergency is hereby declared to exist  
 32 and this Act being necessary for the immediate preservation of the public  
 33 peace, health and safety shall be in full force and effect from and after the  
 34 date of its passage and approval.

35 If the bill is neither approved nor vetoed by the Governor, it shall  
 36 become effective on the expiration of the period of time during which the

1 Governor may veto the bill. If the bill is vetoed by the Governor and the  
2 veto is overridden, it shall become effective on the date the last house  
3 overrides the veto.
