8 AN ACT TO MAKE AN APPROPRIATION FOR OPERATING
9 EXPENSES FOR THE PHILLIPS COMMUNITY COLLEGE OF THE
10 UNIVERSITY OF ARKANSAS WHICH SHALL BE SUPPLEMENTAL
11 AND IN ADDITION TO THOSE FUNDS APPROPRIATED BY ACT
12 186 OF 2018; AND FOR OTHER PURPOSES.

15 AN ACT FOR THE PHILLIPS COMMUNITY COLLEGE
16 OF THE UNIVERSITY OF ARKANSAS
17 SUPPLEMENTAL APPROPRIATION.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. APPROPRIATION - STATE OPERATIONS - HELENA CAMPUS. There is
24 hereby appropriated, to the Phillips Community College of the University of
25 Arkansas, to be payable from the Phillips Community College of the University
26 of Arkansas Fund, for operating expenses of the Phillips Community College of
27 the University of Arkansas - Helena Campus which shall be supplemental and in
28 addition to those funds appropriated in Section 5 of Act 186 of 2018, the
29 following:

5 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
6 authorized by this act shall be limited to the appropriation for such agency
7 and funds made available by law for the support of such appropriations; and
8 the restrictions of the State Procurement Law, the General Accounting and
9 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
10 Procedures and Restrictions Act, the Higher Education Expenditures
11 Restrictions Act, or their successors, and other fiscal control laws of this
12 State, where applicable, and regulations promulgated by the Department of
13 Finance and Administration, as authorized by law, shall be strictly complied
14 with in disbursement of said funds.

16 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
17 Assembly that any funds disbursed under the authority of the appropriations
18 contained in this act shall be in compliance with the stated reasons for
19 which this act was adopted, as evidenced by the Agency Requests, Executive
20 Recommendations and Legislative Recommendations contained in the budget
21 manuals prepared by the Department of Finance and Administration, letters, or
22 summarized oral testimony in the official minutes of the Arkansas Legislative
23 Council or Joint Budget Committee which relate to its passage and adoption.

25 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
26 Assembly, that funds provided by the General Assembly for the operations of
27 the Phillips Community College of the University of Arkansas are, due to
28 unforeseen circumstances, insufficient for the Phillips Community College of
29 the University of Arkansas to continue to provide essential governmental
30 services; that the provisions of this act will provide the necessary monies
31 for the Phillips Community College of the University of Arkansas to continue
32 such services; and that a delay in the effective date of this Act could work
33 irreparable harm upon the proper administration and provision of essential
34 governmental programs. Therefore, an emergency is hereby declared to exist
35 and this Act being necessary for the immediate preservation of the public
36 peace, health and safety shall be in full force and effect from and after the

1 date of its passage and approval.

2 If the bill is neither approved nor vetoed by the Governor, it shall
3 become effective on the expiration of the period of time during which the
4 Governor may veto the bill. If the bill is vetoed by the Governor and the
5 veto is overridden, it shall become effective on the date the last house
6 overrides the veto.
