11 APPROPRIATED BY ACT 112 OF 2018; AND FOR OTHER

15 AN ACT FOR THE UNIVERSITY OF ARKANSAS -
16 FAYETTEVILLE SUPPLEMENTAL APPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby
23 appropriated, to the University of Arkansas, to be payable from the
24 University of Arkansas Fund, for personal services of the University of
25 Arkansas - Fayetteville which shall be supplemental and in addition to those
26 funds appropriated in Section 3 of Act 112 of 2018, the following:

32 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
33 authorized by this act shall be limited to the appropriation for such agency
34 and funds made available by law for the support of such appropriations; and
35 the restrictions of the State Procurement Law, the General Accounting and
36 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary



1 Procedures and Restrictions Act, the Higher Education Expenditures
2 Restrictions Act, or their successors, and other fiscal control laws of this
3 State, where applicable, and regulations promulgated by the Department of
4 Finance and Administration, as authorized by law, shall be strictly complied
5 with in disbursement of said funds.

7 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
8 Assembly that any funds disbursed under the authority of the appropriations
9 contained in this act shall be in compliance with the stated reasons for
10 which this act was adopted, as evidenced by the Agency Requests, Executive
11 Recommendations and Legislative Recommendations contained in the budget
12 manuals prepared by the Department of Finance and Administration, letters, or
13 summarized oral testimony in the official minutes of the Arkansas Legislative
14 Council or Joint Budget Committee which relate to its passage and adoption.

16 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
17 Assembly, that funds provided by the General Assembly for the operations of
18 the University of Arkansas - Fayetteville are, due to unforeseen
19 circumstances, insufficient for the University of Arkansas - Fayetteville to
20 continue to provide essential governmental services; that the provisions of
21 this act will provide the necessary monies for the University of Arkansas -
22 Fayetteville to continue such services; and that a delay in the effective
23 date of this Act could work irreparable harm upon the proper administration
24 and provision of essential governmental programs. Therefore, an emergency is
25 hereby declared to exist and this Act being necessary for the immediate
26 preservation of the public peace, health and safety shall be in full force
27 and effect from and after the date of its passage and approval.

28 If the bill is neither approved nor vetoed by the Governor, it shall
29 become effective on the expiration of the period of time during which the
30 Governor may veto the bill. If the bill is vetoed by the Governor and the
31 veto is overridden, it shall become effective on the date the last house
32 overrides the veto.
