

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
25 for the Department of Human Services - Division of Provider Services and
26 Quality Assurance for the 2019-2020 fiscal year, the following maximum number
27 of regular employees.

7 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for
 8 the Department of Human Services - Division of Provider Services and Quality
 9 Assurance for the 2019-2020 fiscal year, the following maximum number of
 10 part-time or temporary employees, to be known as "Extra Help", payable from
 11 funds appropriated herein for such purposes: eight (8) temporary or part-
 12 time employees, when needed, at rates of pay not to exceed those provided in
 13 the Uniform Classification and Compensation Act, or its successor, or this
 14 act for the appropriate classification.

16 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 17 to the Department of Human Services - Division of Provider Services and
 18 Quality Assurance, to be payable from the paying account as determined by the
 19 Chief Fiscal Officer of the State, for personal services and operating
 20 expenses of the Department of Human Services - Division of Provider Services
 21 and Quality Assurance for the fiscal year ending June 30, 2020, the
 22 following:

SECTION 4. APPROPRIATION - PROVIDER SERVICES GRANTS. There is hereby appropriated, to the Department of Human Services - Division of Provider Services and Quality Assurance, to be payable from the paying account as determined by the Chief Fiscal Officer of the State, for grant payments of the Department of Human Services - Division of Provider Services and Quality Assurance for the fiscal year ending June 30, 2020, the following:

SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CERTIFICATION AND LICENSURE. The Division of Provider Services and Quality Assurance of the Department of Human Services is authorized to use funds appropriated for the certification or licensure of an entity on behalf of any division of the Department of Human Services. Any entity holding a certification or license funded through an appropriation for the Division of Provider Services and Quality Assurance of the Department of Human Services shall hold its certification or license under the authority of the relevant division of the Department of Human Services. All laws that apply to a certified or licensed entity by a relevant division of the Department of Human Services shall apply to an entity certified or licensed by the Division of Provider Services and Quality Assurance on behalf of a relevant division of the Department of Human Services.

The provisions of this section shall be in effect only from July 1, ~~2018~~ 2019 through June 30, ~~2019~~ 2020.

SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by

1 the Department of Finance and Administration, as authorized by law, shall be
2 strictly complied with in disbursement of said funds.

4 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
5 Assembly that any funds disbursed under the authority of the appropriations
6 contained in this act shall be in compliance with the stated reasons for
7 which this act was adopted, as evidenced by the Agency Requests, Executive
8 Recommendations and Legislative Recommendations contained in the budget
9 manuals prepared by the Department of Finance and Administration, letters, or
10 summarized oral testimony in the official minutes of the Arkansas Legislative
11 Council or Joint Budget Committee which relate to its passage and adoption.

13 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
14 Assembly, that the Constitution of the State of Arkansas prohibits the
15 appropriation of funds for more than a one (1) year period; that the
16 effectiveness of this Act on July 1, 2019 is essential to the operation of
17 the agency for which the appropriations in this Act are provided, and that in
18 the event of an extension of the legislative session, the delay in the
19 effective date of this Act beyond July 1, 2019 could work irreparable harm
20 upon the proper administration and provision of essential governmental
21 programs. Therefore, an emergency is hereby declared to exist and this Act
22 being necessary for the immediate preservation of the public peace, health
23 and safety shall be in full force and effect from and after July 1, 2019.
