9 AND OPERATING EXPENSES FOR THE ARKANSAS STATE
10 UNIVERSITY - NEWPORT WHICH SHALL BE SUPPLEMENTAL AND
11 IN ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 128 OF
12 2020; AND FOR OTHER PURPOSES.

15 AN ACT FOR THE ARKANSAS STATE UNIVERSITY
16 - NEWPORT SUPPLEMENTAL APPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby
23 appropriated, to the Arkansas State University - Newport, to be payable from
24 the Arkansas State University - Newport Fund, for personal services and
25 operating expenses of the Arkansas State University - Newport which shall be
26 supplemental and in addition to those funds appropriated in Section 3 of Act
27 128 of 2020, the following:

6 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

7 authorized by this act shall be limited to the appropriation for such agency

8 and funds made available by law for the support of such appropriations; and

9 the restrictions of the State Procurement Law, the General Accounting and

10 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

11 Procedures and Restrictions Act, or their successors, and other fiscal

12 control laws of this State, where applicable, and regulations promulgated by

13 the Department of Finance and Administration, as authorized by law, shall be

14 strictly complied with in disbursement of said funds.

15

16 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General

17 Assembly that any funds disbursed under the authority of the appropriations

18 contained in this act shall be in compliance with the stated reasons for

19 which this act was adopted, as evidenced by the Agency Requests, Executive

20 Recommendations and Legislative Recommendations contained in the budget

21 manuals prepared by the Department of Finance and Administration, letters, or

22 summarized oral testimony in the official minutes of the Arkansas Legislative

23 Council or Joint Budget Committee which relate to its passage and adoption.

25 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General

26 Assembly, that funds provided by the General Assembly for the operations of

27 the Arkansas State University - Newport are, due to unforeseen circumstances,

28 insufficient for the Arkansas State University - Newport to continue to

29 provide essential governmental services; that the provisions of this act will

30 provide the necessary monies for the Arkansas State University - Newport to

31 continue such services; and that a delay in the effective date of this Act

32 could work irreparable harm upon the proper administration and provision of

33 essential governmental programs. Therefore, an emergency is hereby declared

34 to exist and this Act being necessary for the immediate preservation of the

35 public peace, health and safety shall be in full force and effect from and

36 after the date of its passage and approval.

1 If the bill is neither approved nor vetoed by the Governor, it shall
2 become effective on the expiration of the period of time during which the
3 Governor may veto the bill. If the bill is vetoed by the Governor and the
4 veto is overridden, it shall become effective on the date the last house
5 overrides the veto.
