20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 22-10-502(a), concerning rules promulgation
23 by the Arkansas Economic Development Commission under the Partnership for
24 Public Facilities and Infrastructure Act, is amended to read as follows to
25 correct a reference to an agency and to repeal obsolete language:

26 (a) ~~The Arkansas Economic Development Commission or the Building~~
27 ~~Authority Division~~ Department of Transformation and Shared Services shall
28 promulgate certain rules regarding the definitions and guidelines related to
29 the development of qualifying projects under this chapter within ninety (90)
30 days of August 1, 2017.
31

32 SECTION 2. The introductory language of Arkansas Code § 22-10-503(a),
33 concerning rules promulgation by the Arkansas Economic Development Commission
34 and the Arkansas Development Finance Authority under the Partnership for
35 Public Facilities and Infrastructure Act, is amended to read as follows to
36 correct a reference to an agency:



1 (a) ~~The Arkansas Economic Development Commission or the Building~~
2 ~~Authority Division~~ Department of Transformation and Shared Services and the
3 Arkansas Development Finance Authority shall jointly promulgate rules to
4 administer this chapter, including without limitation rules regarding:

6 SECTION 3. Arkansas Code § 22-10-503(b), concerning rules promulgation
7 by the Arkansas Economic Development Commission and the Arkansas Development
8 Finance Authority under the Partnership for Public Facilities and
9 Infrastructure Act, is amended to read as follows to correct a reference to
10 an agency:

11 (b) ~~The commission or division and the authority~~ Department of
12 Transformation and Shared Services and the Arkansas Development Finance
13 Authority may jointly promulgate rules that establish procurement guidelines
14 and requirements that vary depending on the type of qualifying project.
15

16 SECTION 4. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT.

17 It is the intent of the General Assembly that:

18 (1) The enactment and adoption of this act shall not expressly
19 or impliedly repeal an act passed during the regular session of the Ninety-
20 Third General Assembly;

21 (2) To the extent that a conflict exists between an act of the
22 regular session of the Ninety-Third General Assembly and this act:

23 (A) The act of the regular session of the Ninety-Third
24 General Assembly shall be treated as a subsequent act passed by the General
25 Assembly for the purposes of:

26 (i) Giving the act of the regular session of the
27 Ninety-Third General Assembly its full force and effect; and

28 (ii) Amending or repealing the appropriate parts of
29 the Arkansas Code of 1987; and

30 (B) Section 1-2-107 shall not apply; and

31 (3) This act shall make only technical, not substantive, changes
32 to the Arkansas Code of 1987.
