22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code § 6-14-102(a)(1)(A)(ii)(a) and (b),
25 concerning the annual school election date and special school elections, are
26 amended to read as follows:

27 (a) ~~First~~ Second Tuesday ~~following the first~~
28 ~~Monday~~ in November; or

29 (b) ~~Third~~ Second Tuesday in May.
30

31 SECTION 2. Arkansas Code § 6-14-102(b), concerning the annual school
32 election date and special school elections, is amended to read as follows:

33 (b) The board of directors of any school district shall have the
34 authority to hold a special school election concerning the tax rate or debt
35 issues ~~on a date other than that fixed by law under § 7-11-205~~ provided that:

36 (1) All constitutional and statutory requirements for the annual



1 school election are met, notwithstanding subsection (a) of this section;

2 ~~(2) The election is held before the date of the annual school~~
 3 ~~election; and~~

4 ~~(3) The Commissioner of Elementary and Secondary Education~~
 5 ~~approves the date of the election; and~~

6 (3) The board of directors of a school district files a document
 7 calling for the special school election with the district's domiciled county
 8 clerk not less than seventy (70) days before the date of the special school
 9 election.

10
 11 SECTION 3. Arkansas Code § 6-14-111(k), concerning candidate filing
 12 procedures, is amended to read as follows:

13 (k) The order in which the names of the respective candidates are to
 14 appear on the ballot shall be determined by lot at the public meeting of the
 15 county board of election commissioners held not later than ~~seventy-two (72)~~
 16 ~~days before the annual school election;~~

17 (1) The deadline to conduct the ballot draw for the preferential
 18 primary or general election for an annual school election held in even-
 19 numbered years;

20 (2) The seventh day of March for an annual school election held
 21 on the second Tuesday in May of an odd-numbered year; and

22 (3) Seventy-two (72) days before an annual school election held
 23 on the second Tuesday of November of an odd-numbered year.

24
 25 SECTION 4. Arkansas Code § 6-14-122(b), concerning the consolidation,
 26 annexation, or merger of school districts, is amended to read as follows:

27 (b) The boards of directors of the school districts may, by resolution
 28 duly adopted and with the approval of the Commissioner of Elementary and
 29 Secondary Education, set a date for the annual school election in that year
 30 for the school districts involved on a date ~~other than the date set in § 6-~~
 31 ~~14-102 for all school districts under § 7-11-205~~, provided only one (1)
 32 annual school election may be held in any school district in one (1) calendar
 33 year.

34
 35 SECTION 5. Arkansas Code § 6-53-602(b)(2), concerning the formation of
 36 a proposed technical college district, is amended to read as follows:

1 (2)(A) The local board or acting local board shall issue a
 2 proclamation and set a date for the election under § 7-11-201 et seq., ~~but~~
 3 ~~the date set for the election shall not be later than ninety (90) days after~~
 4 ~~the publication of the proclamation~~

5 (B) The local board or acting local board shall publish
 6 the proclamation at least ninety (90) days before the election date.

7
 8 SECTION 6. Arkansas Code § 6-53-603(a)(2), concerning a tax levy for a
 9 technical college district, is amended to read as follows:

10 (2) ~~It~~ A tax levy may be reduced or repealed, with the exception
 11 of the amount of tax required to service ~~any~~ an outstanding ~~bonds~~ bond, or
 12 the tax may be increased upon approval thereof by a majority of the qualified
 13 electors of the district voting on the issue at ~~an~~ the next election called
 14 by the local board or acting local board ~~to be held at least thirty (30)~~
 15 ~~calendar days after the local board or acting local board notifies the county~~
 16 ~~boards of election commissioners~~ under § 7-11-205.

 18 SECTION 7. Arkansas Code § 6-53-604(b), concerning the dissolution of
 19 a technical college district and reduction of millage tax, is amended to read
 20 as follows:

 25 election ~~shall~~ is to be held ~~at a time not less than thirty (30) days nor~~
 26 ~~more than one hundred eighty (180) days from the date of notification on the~~
 27 next special election date under § 7-11-205.

 29 SECTION 8. Arkansas Code § 7-11-105 is amended to read as follows:
 30 7-11-105. Special elections to be held on the second Tuesday of a
 31 month – Exceptions – Separate ballots.

32 (a)(1) Except as provided in this chapter, all special elections to
 33 fill vacancies in office and associated special primary elections shall be
 34 held on the second Tuesday of ~~any month~~:

35 (A) March, May, August, or November in a year when a
 36 presidential election is held; and

1 (B) February, May, August, or November of all other years.

2 (2) Elections called by proclamation of the Governor may be
3 called in any month.

4 (b) A special election scheduled to occur in a month in which the
5 second Tuesday of the month is a legal holiday shall be held on the third
6 Tuesday of the month.

7 (c)(1) Special elections held in months in which a preferential
8 primary election, ~~general primary election~~, or general election is scheduled
9 to occur shall be held on the date of the ~~general primary election~~,
10 preferential primary election, or general election.

11 (2) If a special election to fill a vacancy in office is held on
12 the date of the preferential primary election ~~or general primary election~~,
13 the names of the candidates in the special election shall be included on the
14 ballot of each political party, and the portion of the ballot on which the
15 special election appears shall be labeled with a heading stating "SPECIAL
16 ELECTION FOR _____" with the name of the office set out in
17 the heading.

18 (3) Separate ballots containing the names of the candidates to
19 be voted on at the special election or nonpartisan election and any other
20 measures or questions that may be presented for a vote shall be prepared and
21 made available to voters requesting a separate ballot.

22 (4)(A) A voter shall not be required to vote in a political
23 party's preferential primary election ~~or general primary election~~ in order to
24 be able to vote in the special election.

25 (B)(i) If the special election is held at the same time as
26 the general election, the names of the candidates in the special election
27 shall be included on the general election ballot, and the portion of the
28 ballot on which the special election appears shall be labeled with a heading
29 stating "SPECIAL ELECTION FOR _____" with the name of the office
30 set out in the heading.

31 (ii) The county board of election commissioners may
32 include the special election on a separate ballot if the special election is
33 held at the same time as the general election and the county board of
34 election commissioners determines that a separate ballot is necessary to
35 avoid voter confusion.

13 SECTION 9. Arkansas Code § 7-11-201 is amended to read as follows:

14 7-11-201. Calling special elections on measures or questions.

15 ~~Except for special school elections, all~~ All special elections on
16 measures or questions referred to the voters by governmental entities as
17 authorized by law shall be called by proclamation, ordinance, statute,
18 resolution, order, or other authorized document of the properly constituted
19 authority as required by law.

20
21 SECTION 10. Arkansas Code § 7-11-205 is amended to read as follows:

22 7-11-205. Dates of special elections on measures and questions -
23 Exceptions - Separate ballots.

24 (a)(1)~~(A)~~ Except as provided in subdivision ~~(a)(1)(B)~~(a)(2) of this
25 section, all special elections on measures or questions referred to the
26 voters by governmental entities as authorized by law shall be held on the
27 second Tuesday of ~~any month, except special elections held under this section~~
28 ~~in a month in which a preferential primary election, general primary~~
29 ~~election, or general election is scheduled to occur, which shall be held on~~
30 ~~the date of the preferential primary election, general primary election, or~~
31 ~~general election;~~

32 (A) March, May, August, or November in a year when a
33 presidential election is held; and

34 (B) February, May, August, or November of all other years.

35 ~~(B)(2)(A)~~ Special elections scheduled to occur in a month
36 in which the second Tuesday is a legal holiday shall be held on the third

1 Tuesday of the month.

2 (B) Special elections held in months in which a
3 preferential primary election or general election is scheduled to occur shall
4 be held on the date of the preferential primary election or general election.

5 (C) A special election on a measure or question may be
6 scheduled on the second Tuesday of a month, other than the months provided in
7 subdivision (a)(1) of this section, if necessary to comply with the
8 requirements of Arkansas Constitution, Article 5 § 1.

9 (D) An emergency special election may be held on the
10 second Tuesday of any month, other than the month following a preferential
11 primary election or general election, when two-thirds (2/3) of all the
12 members elected to the governing entity have determined that:

13 (i) An event has occurred that constitutes a
14 substantial change in circumstances; and

15 (ii) A delay of the emergency special election until
16 the next date under this section, would cause a substantial and undue
17 hardship to the governing entity or a threat to the public peace, health, and
18 safety.

19 (E)(i) A qualified elector for an emergency special
20 election may file an action in the circuit court of the county in which the
21 document calling for the emergency special election is filed to ask the court
22 to determine if circumstances exist that permit the governing entity to call
23 an emergency special election under subdivision (a)(1)(D) of this section.

24 (ii) If the court determines circumstances do not
25 exist that permit the governing entity to call an emergency special election:

26 (a) The emergency special election shall not
27 occur; or

28 (b) If the emergency special election has
29 already occurred, any measure approved in the emergency special election
30 shall be void.

31 (iii) A challenge filed under subdivision
32 (a)(1)(E)(i) of this section may not be filed more than thirty (30) days from
33 the date the document calling for the special election being challenged is
34 filed with the county clerk.

5 the election.

7 voted on at the special election and candidates for nonpartisan judicial
8 office shall be prepared and made available to voters requesting a separate
9 ballot.

10 ~~(4)~~(5) A voter shall not be required to vote in a political
11 party's preferential primary in order to be able to vote in the special
12 election.

13 (b)~~(1)~~ A special election shall be held not less than seventy (70)
14 days following the date that the proclamation, ordinance, resolution, order,
15 or other authorized document is filed with the county clerk ~~when the special~~
16 ~~election is to be held on the date of the preferential primary election or~~
17 ~~general election.~~

18 ~~(2) If the special election is not held at the same time as a~~

24 SECTION 11. Arkansas Code § 11-10-1006(a)(2), concerning elections
25 under the Unemployment Trust Fund Financing Act of 2011, is amended to read
26 as follows:

27 (2)(A) An election under this section may be ~~in conjunction with~~
28 ~~a general election, or it may be a special election.~~

29 ~~(B) A special election held under this section shall occur~~
30 ~~on the second Tuesday of any month, except as otherwise provided for in this~~
31 ~~subsection.~~

32 ~~(C) A special election that is held in months in which a~~
33 ~~presidential preferential primary election, preferential primary election,~~
34 ~~general primary election, or general election is scheduled to occur shall be~~

20 (2) Referendum. Referendum petition measures may be submitted
21 to the electors during a regular general election and shall be submitted if
22 the adequacy of the petition is determined within the time limitation
23 prescribed in this section. A referendum measure may also be referred to the
24 electors at a special election called for the expressed purpose proposed by
25 petition. However, no referendum petition certified within the time
26 limitations established for initiative measures shall be referred to a
27 special election, but shall be voted upon at the next regular election. ~~No~~ A
28 referendum election shall be held ~~less than sixty (60) days after the~~
