19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

SECTION 1. APPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO.

21 There is hereby appropriated, to the Arkansas State University, to be payable
22 from the Development and Enhancement Fund, the following:
23

24 (A) for construction, renovation, maintenance, equipment, personal
25 services and operating expenses of the various institutions and entities of
26 the Arkansas State University System, in a sum not to exceed\$15,000,000.

27 (B) for costs of construction of a College of Engineering building, in
28 a sum not to exceed\$4,364,480.

29 (C) for College of Education and Communications restrooms renovation,
30 in a sum not to exceed\$908,500.

31 (D) for Library HVAC system renovation and modernization, in a sum not
32 to exceed\$3,227,020.

33 (E) for critical maintenance, in a sum not to exceed\$710,000.

34 (F) for deferred maintenance, in a sum not to exceed\$2,870,000.

35 (G) for the purchase, replacement, and renewal of equipment and library
36 holdings, in a sum not to exceed\$2,989,855.



1 (H) for costs of implementing the ASU System Enterprise Resource
2 Program, in a sum not to exceed\$1,250,000.

3
4 SECTION 2. APPROPRIATION - ARKANSAS TECH UNIVERSITY. There is hereby
5 appropriated, to the Arkansas Tech University, to be payable from the
6 Development and Enhancement Fund, the following:

7 (A) for McEver Science Building, Dean Hall, & Tucker Coliseum
8 renovation, in a sum not to exceed\$4,765,200.

9 (B) for costs of construction of O Street closure and Campus Entrance,
10 in a sum not to exceed\$2,330,000.

11 (C) for renovation for Brown building academic utilization, in a sum
12 not to exceed\$1,180,438.

13 (D) for technology infrastructure upgrades and improvements, in a sum
14 not to exceed\$224,362.

15 (E) for critical maintenance, in a sum not to exceed\$1,210,000.

16 (F) for deferred maintenance, in a sum not to exceed\$3,780,000.

17 (G) for the purchase, replacement, and renewal of equipment and library
18 holdings, in a sum not to exceed\$1,314,122.

19 (H) for reroofing the Allied Health Building on the Ozark Campus, in a
20 sum not to exceed\$142,212.

21 (I) for costs of construction of a Technology Trade Center on the Ozark
22 Campus, in a sum not to exceed\$1,357,788.

23 (J) for critical maintenance for the Ozark Campus, in a sum not to
24 exceed\$20,000.

25 (K) for deferred maintenance for the Ozark Campus, in a sum not to
26 exceed\$210,000.

27
28 SECTION 3. APPROPRIATION - HENDERSON STATE UNIVERSITY. There is hereby
29 appropriated, to the Henderson State University, to be payable from the
30 Development and Enhancement Fund, the following:

31 (A) for technology infrastructure upgrades, in a sum not to exceed
32\$1,500,000.

33 (B) for Reynolds Labs renovation, in a sum not to exceed\$850,000.

34 (C) for roof replacement for the Library and Womack building, in a sum
35 not to exceed\$795,000.

36 (D) for renovation of the Russell Fine Arts Building, in a sum not to

- 1 exceed\$4,355,000.
- 2 (E) for critical maintenance, in a sum not to exceed\$280,000.
- 3 (F) for deferred maintenance, in a sum not to exceed\$1,900,000.
- 4 (G) for the purchase, replacement, and renewal of equipment and library
- 5 holdings, in a sum not to exceed\$597,420.

6

7 SECTION 4. APPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is

8 hereby appropriated, to the Southern Arkansas University, to be payable from

9 the Development and Enhancement Fund, the following:

- 10 (A) for costs of HVAC replacement and upgrades, in a sum not to exceed
- 11\$3,783,000.
- 12 (B) for technology infrastructure improvements and upgrades, in a sum
- 13 not to exceed\$2,500,000.
- 14 (C) for renovation of Childs Hall and ADA upgrades to create the
- 15 Science, Technology, Engineering and Mathematics Training Center, in a sum
- 16 not to exceed\$1,217,000.
- 17 (D) for critical maintenance, in a sum not to exceed\$520,000.
- 18 (E) for deferred maintenance, in a sum not to exceed\$1,910,000.
- 19 (F) for the purchase, replacement, and renewal of equipment and library
- 20 holdings, in a sum not to exceed\$712,642.

21

22 SECTION 5. APPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES.

23 There is hereby appropriated, to the University of Arkansas for Medical

24 Sciences, to be payable from the Development and Enhancement Fund, the

25 following:

- 26 (A) for renovation of the Barton Building, in a sum not to exceed
- 27\$2,500,000.
- 28 (B) for renovation of the EDII 6th Floor for the College of Pharmacy,
- 29 in a sum not to exceed\$2,000,000.
- 30 (C) for renovation of the Monroe Building, in a sum not to exceed
- 31\$2,000,000.
- 32 (D) for renovation of the Central Building - Floors 2-8, in a sum not
- 33 to exceed\$2,000,000.
- 34 (E) for critical maintenance, in a sum not to exceed\$7,080,000.
- 35 (F) for deferred maintenance, in a sum not to exceed\$11,420,000.
- 36 (G) for the purchase, replacement, and renewal of equipment and library

1 holdings, in a sum not to exceed\$1,918,925.

2

3 SECTION 6. APPROPRIATION - UNIVERSITY OF ARKANSAS. There is hereby
4 appropriated, to the University of Arkansas, to be payable from the
5 Development and Enhancement Fund, the following:

6 (A) for construction, renovation, maintenance, equipment, personal
7 services and operating expenses of the various institutions and entities of
8 the University of Arkansas System, in a sum not to exceed\$15,000,000.

9 (B) for costs of construction of the Institute for Integrative and
10 Innovative Research, in a sum not to exceed\$3,500,000.

11 (C) for renovation and restoration of the Agriculture Building, in a
12 sum not to exceed\$2,000,000.

13 (D) for renovation and restoration of the John A. White, Jr.
14 Engineering Hall, in a sum not to exceed\$2,000,000.

15 (E) for renovation of the Business Building, in a sum not to exceed
16\$2,000,000.

17 (F) for critical maintenance for the U of A - Fayetteville, in a sum
18 not to exceed\$5,630,000.

19 (G) for deferred maintenance for the U of A - Fayetteville, in a sum
20 not to exceed\$9,730,000.

21 (H) for the purchase, replacement, and renewal of equipment and library
22 holdings for the U of A - Fayetteville, in a sum not to exceed ...\$5,108,729.

23 (I) for construction costs for the expansion of office and storage
24 space at the U of A - System Office, in a sum not to exceed\$1,250,000.

25 (J) for critical maintenance for the U of A - System, in a sum not to
26 exceed\$10,000.

27 (K) for deferred maintenance for the U of A - System, in a sum not to
28 exceed\$50,000.

29 (L) for upgrades and renovations to the Agricultural Research and
30 Extension Centers and Stations of the Division of Agriculture, in a sum not
31 to exceed\$3,500,000.

32 (M) for costs of construction of the Northeast Rice Research &
33 Extension Center, in a sum not to exceed\$1,000,000.

34 (N) for critical maintenance of the U of A - Division of Agriculture,
35 in a sum not to exceed\$70,000.

36 (O) for deferred maintenance for the U of A - Division of Agriculture,

1 in a sum not to exceed\$1,650,000.

2 (P) for AREON technology infrastructure upgrades for the National
3 Center for Toxicology Research, in a sum not to exceed\$500,000.

4 (Q) for technology infrastructure upgrades for Western Arkansas rural
5 fiber development, in a sum not to exceed\$500,000.

6 (R) for technology infrastructure upgrades for Eastern Arkansas rural
7 fiber development, in a sum not to exceed\$250,000.

8 (S) for renovation of the Visual Arts and Design Building of the
9 Arkansas School for Mathematics, Sciences, and the Arts (ASMSA), in a sum not
10 to exceed\$500,000.

11 (T) for costs of campus ADA accessibility improvements for the ASMSA,
12 in a sum not to exceed\$250,000.

13 (U) for STEM Research Lab upgrades of the ASMSA, in a sum not to exceed
14\$220,000.

15 (V) for costs of construction of a Multi-Purpose Building (Wellness
16 Center) for the ASMSA, in a sum not to exceed\$280,000.

17
18 SECTION 7. APPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH. There
19 is hereby appropriated, to the University of Arkansas at Fort Smith, to be
20 payable from the Development and Enhancement Fund, the following:

21 (A) for costs of construction and renovation for the UAFS Center for
22 Workforce Development, in a sum not to exceed\$6,522,500.

23 (B) for critical maintenance, in a sum not to exceed\$550,000.

24 (C) for deferred maintenance, in a sum not to exceed\$1,640,000.

25 (D) for the purchase, replacement, and renewal of equipment and library
26 holdings, in a sum not to exceed\$704,055.

27
28 SECTION 8. APPROPRIATION - UNIVERSITY OF ARKANSAS AT LITTLE ROCK.

29 There is hereby appropriated, to the University of Arkansas at Little Rock,
30 to be payable from the Development and Enhancement Fund, the following:

31 (A) for improvements to technology infrastructure, in a sum not to
32 exceed\$4,000,000.

33 (B) for classroom technology improvements, in a sum not to exceed
34\$264,527.

35 (C) for construction costs to complete the Nanotechnology Center, in a
36 sum not to exceed\$2,000,000.

- 1 (D) for building infrastructure/critical maintenance, in a sum not to
- 2 exceed\$2,735,473.
- 3 (E) for critical maintenance, in a sum not to exceed\$6,470,000.
- 4 (F) for deferred maintenance, in a sum not to exceed\$5,580,000.
- 5 (G) for the purchase, replacement, and renewal of equipment and library
- 6 holdings, in a sum not to exceed\$1,766,974.

7

8 SECTION 9. APPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO. There

9 is hereby appropriated, to the University of Arkansas at Monticello, to be

10 payable from the Development and Enhancement Fund, the following:

- 11 (A) for costs of construction of a Math and Science Center, in a sum
- 12 not to exceed\$4,750,000.
- 13 (B) for renovation of the Fine Arts Center, in a sum not to exceed
- 14\$1,000,000.
- 15 (C) for renovation of the Music Building, in a sum not to exceed
- 16\$750,000.
- 17 (D) for costs of construction of the Workforce/Collegiate Center on the
- 18 Crossett campus, in a sum not to exceed\$1,500,000.
- 19 (E) for costs of construction of a General Education Building on the
- 20 McGehee campus, in a sum not to exceed\$1,500,000.
- 21 (F) for deferred maintenance, in a sum not to exceed\$2,390,000.
- 22 (G) for deferred maintenance at the Crossett campus, in a sum not to
- 23 exceed\$120,000.
- 24 (H) for deferred maintenance at the McGehee campus, in a sum not to
- 25 exceed\$150,000.
- 26 (I) for the purchase, replacement, and renewal of equipment and library
- 27 holdings, in a sum not to exceed\$445,592.

28

29 SECTION 10. APPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF. There

30 is hereby appropriated, to the University of Arkansas at Pine Bluff, to be

31 payable from the Development and Enhancement Fund, the following:

- 32 (A) for costs of construction of a Student Center, in a sum not to
- 33 exceed\$3,000,000.
- 34 (B) for costs of campus renovations and repair, in a sum not to exceed
- 35\$2,895,000.
- 36 (C) for technology infrastructure upgrades, in a sum not to exceed

- 1\$605,000.
- 2 (D) for critical maintenance, in a sum not to exceed\$490,000.
- 3 (E) for deferred maintenance, in a sum not to exceed\$1,600,000.
- 4 (F) for the purchase, replacement, and renewal of equipment and library
- 5 holdings, in a sum not to exceed\$383,776.

6

7 SECTION 11. APPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS. There is

8 hereby appropriated, to the University of Central Arkansas, to be payable

9 from the Development and Enhancement Fund, the following:

- 10 (A) for costs of construction for an addition to, renovation of, and
- 11 equipment for the Lewis Science Center, in a sum not to exceed ...\$3,000,000.
- 12 (B) for renovation of Mashburn Hall, in a sum not to exceed
- 13\$3,000,000.
- 14 (C) for renovation of Old Main, in a sum not to exceed\$2,500,000.
- 15 (D) for critical maintenance, in a sum not to exceed\$1,060,000.
- 16 (E) for deferred maintenance, in a sum not to exceed\$3,820,000.
- 17 (F) for the purchase, replacement, and renewal of equipment and library
- 18 holdings, in a sum not to exceed\$1,948,849.

19

20 SECTION 12. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor

21 obligations otherwise incurred in relation to the project or projects

22 described herein in excess of the State Treasury funds actually available

23 therefor as provided by law. Provided, however, that institutions and

24 agencies listed herein shall have the authority to accept and use grants and

25 donations including Federal funds, and to use its unobligated cash income or

26 funds, or both available to it, for the purpose of supplementing the State

27 Treasury funds for financing the entire costs of the project or projects

28 enumerated herein. Provided further, that the appropriations and funds

29 otherwise provided by the General Assembly for Maintenance and General

30 Operations of the agency or institutions receiving appropriation herein shall

31 not be used for any of the purposes as appropriated in this act.

32 (B) The restrictions of any applicable provisions of the State

33 Purchasing Law, the General Accounting and Budgetary Procedures Law, the

34 Revenue Stabilization Law and any other applicable fiscal control laws of

35 this State and regulations promulgated by the Department of Finance and

36 Administration, as authorized by law, shall be strictly complied with in

1 disbursement of any funds provided by this act unless specifically provided
2 otherwise by law.

3

4 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General
5 Assembly that any funds disbursed under the authority of the appropriations
6 contained in this act shall be in compliance with the stated reasons for
7 which this act was adopted, as evidenced by the Agency Requests, Executive
8 Recommendations and Legislative Recommendations contained in the budget
9 manuals prepared by the Department of Finance and Administration, letters, or
10 summarized oral testimony in the official minutes of the Arkansas Legislative
11 Council or Joint Budget Committee which relate to its passage and adoption.

12

13 SECTION 14. EMERGENCY CLAUSE. It is found and determined by the
14 General Assembly, that the Constitution of the State of Arkansas prohibits
15 the appropriation of funds for more than a one (1) year period; that the
16 effectiveness of this Act on July 1, 2021 is essential to the operation of
17 the agency for which the appropriations in this Act are provided, and that in
18 the event of an extension of the legislative session, the delay in the
19 effective date of this Act beyond July 1, 2021 could work irreparable harm
20 upon the proper administration and provision of essential governmental
21 programs. Therefore, an emergency is hereby declared to exist and this Act
22 being necessary for the immediate preservation of the public peace, health
23 and safety shall be in full force and effect from and after July 1, 2021.
