

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES - HOUSE STAFF. There is hereby established
23 for the Arkansas House of Representatives for the 2023-2024 fiscal year, the
24 following maximum number of regular employees.

 14 House of Representatives for the 2023-2024 fiscal year, the following maximum
 15 number of part-time or temporary employees, to be known as "Extra Help",
 16 payable from funds appropriated herein for such purposes: seven (7)
 17 temporary or part-time employees, when needed, at rates of pay not to exceed
 18 those provided in the Uniform Classification and Compensation Act, or its
 19 successor, or this act for the appropriate classification.

21 SECTION 3. APPROPRIATION - STAFF. There is hereby appropriated, to the
 22 Arkansas House of Representatives, to be payable from the State Central
 23 Services Fund, for personal services and operating expenses of the Arkansas

36 SECTION 11. APPROPRIATION - REAPPROPRIATION - CONSTITUTIONAL OFFICERS

1 FUND. There is hereby appropriated, to the Arkansas House of Representatives,
 2 to be payable from the Constitutional Officers Fund, for the balance
 3 remaining on June 30, 2023 in the appropriations enacted to defray any
 4 necessary expenses of the House of Representative of the Ninety-Fourth
 5 General Assembly, Section 2 of Act 1 of 2022, Sections 4 and 11 of Act 106 of
 6 2022, and HB1001 as introduced in the 2023 Regular Session, there to be used
 7 for the same purposes of the Arkansas House of Representative of the Ninety-
 8 Fourth General Assembly, the sum in the aggregate not to exceed...\$1,950,000.

9
 10 SECTION 12. APPROPRIATION - REAPPROPRIATION - STATE CENTRAL SERVICES.

11 There is hereby appropriated, to the Arkansas House of Representatives, to be
 12 payable from the State Central Services Fund, for the balance remaining on
 13 June 30, 2023 in the appropriations enacted to defray any necessary expenses
 14 of the House of Representatives of the Ninety-Fourth General Assembly,
 15 Sections 3, 5, 7, 9, 10 and 12 of Act 106 of 2022, there to be used for the
 16 same purposes of the Arkansas House of Representatives of the Ninety-Fourth
 17 General Assembly, the sum in the aggregate not to exceed.....\$2,025,000.

18
 19 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USES OF
 21 FUNDS. The funds appropriated in this Act shall be used to defray the
 22 necessary expenses of the operation of the Office of the Speaker of the House
 23 of Representatives, the Office of the Chief of Staff, the Office of the
 24 Coordinator of House Legislative Services, the Office of Parliamentarian, the
 25 Chief Clerk's Office, House Member Services Office and other reasonable and
 26 necessary expenses of the House of Representatives of the General Assembly
 27 incurred during the fiscal year ending June 30, ~~2023~~ 2024. Any balance
 28 remaining on June 30, ~~2022~~ 2023 in the funds provided by this Act shall be
 29 made available for the fiscal year ending June 30, ~~2023~~ 2024 and for the same
 30 purposes.

31
 32 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 33 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 34 AUTHORITY. If the Speaker of the House and the Chief of Staff or his
 35 designee determine that any item or portion thereof appropriation herein for
 36 a specific purpose is not needed for such purpose, they may certify such fact

1 to the State Auditor and the State Auditor shall cause a transfer to be made
2 from one item to another.

3
4 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARIES.
6 In order that exceptionally well-qualified personnel may be recruited and
7 retained, the House of Representatives may exceed the maximum salary levels
8 by no more than twenty percent (20%) for no more than one-third (1/3) of the
9 positions authorized in their operation appropriation act, may exceed the
10 maximum salary levels for the purpose of merit adjustments for all positions,
11 and may promote a maximum of two grades for no more than one-third (1/3) of
12 the classified positions authorized in its operation appropriation act.

13
14 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
16 AUDIO/VISUAL POLICY. The appropriations provided herein to produce audio or
17 video materials by or under the direction of the House of Representatives
18 shall not be used for the following:

19 (a) A person may not use audio or video materials produced by or under the
20 direction of the House of Representatives in political or campaign
21 advertising.

22 (b) A person may not use audio or video materials produced by or under
23 the direction of the House of Representatives for a commercial purpose.

24 (1) In this section, "commercial purpose" means a purpose that
25 is intended to result in a profit or other tangible benefit.

26 (c) The House Management Committee may give permission to an entity to use
27 the audio or video materials for public education governmental
28 broadcast which shall not conflict with subsection (b).

29
30 SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
31 authorized by this act shall be limited to the appropriation for such agency
32 and funds made available by law for the support of such appropriations; and
33 the restrictions of the State Procurement Law, the General Accounting and
34 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
35 Procedures and Restrictions Act, or their successors, and other fiscal
36 control laws of this State, where applicable, and regulations promulgated by

1 the Department of Finance and Administration, as authorized by law, shall be
 2 strictly complied with in disbursement of said funds.

3
 4 SECTION 18. LEGISLATIVE INTENT. It is the intent of the General
 5 Assembly that any funds disbursed under the authority of the appropriations
 6 contained in this act shall be in compliance with the stated reasons for
 7 which this act was adopted, as evidenced by the Agency Requests, Executive
 8 Recommendations and Legislative Recommendations contained in the budget
 9 manuals prepared by the Department of Finance and Administration, letters, or
 10 summarized oral testimony in the official minutes of the Arkansas Legislative
 11 Council or Joint Budget Committee which relate to its passage and adoption.

12
 13 SECTION 19. EMERGENCY CLAUSE. It is found and determined by the
 14 General Assembly, that the Constitution of the State of Arkansas prohibits
 15 the appropriation of funds for more than a one (1) year period; that the
 16 effectiveness of this Act on July 1, 2023 is essential to the operation of
 17 the agency for which the appropriations in this Act are provided, and that in
 18 the event of an extension of the legislative session, the delay in the
 19 effective date of this Act beyond July 1, 2023 could work irreparable harm
 20 upon the proper administration and provision of essential governmental
 21 programs. Therefore, an emergency is hereby declared to exist and this Act
 22 being necessary for the immediate preservation of the public peace, health
 23 and safety shall be in full force and effect from and after July 1, 2023.
