SECTION 6. Arkansas Code § 23-115-103(13)(C)(iii), concerning the exclusion of pari-mutuel wagering from the definition of "lottery" under the Arkansas Scholarship Lottery Act, is amended to read as follows: (iii) Pari-mutuel wagering on horse racing or greyhound racing governed by the Arkansas Horse Racing Law, § 23-110-101 et seq., or the Arkansas Greyhound Racing Law, § 23-111-101 et seq., whether the pari-mutuel wagering is on live racing, simulcast racing, or races conducted in the past and rebroadcast by electronic means; SECTION 7.
