Act 16 HB1007

"AN ACT TO AMEND ACT 751 OF 1987 TO PROVIDE ADDITIONAL EXTRA HELP POSITIONS FOR ARKANSAS TECH UNIVERSITY AND THE ARKANSAS MINING AND MINERAL RESOURCES RESEARCH INSTITUTE FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1989; TO AMEND ACT 957 of 1987 FOR THE UNIVERSITY OF ARKANSAS AT PINE BLUFF; AND FOR OTHER PURPOSES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Section 2 of Act 751 of 1987 is hereby amended to read as follows:

"SECTION 2. EXTRA HELP. There is hereby authorized, for Arkansas Tech University for the 1987-89 biennium, the following maximum number of parttime or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: six hundred twenty-five (625), when needed, at rates of pay not to exceed the rate of pay for comparable positions authorized by this Act, by the Uniform Classification and Compensation Act, and by the Higher Education Employee Classification and Compensation Act, or their successors, and all laws amendatory thereto."

SECTION 2. Section 3 of Act 751 of 1987 is hereby amended to read as follows:

"SECTION 3. EXTRA HELP - ARKANSAS MINING AND MINERAL RESOURCES RESEARCH INSTITUTE. There is hereby authorized, for Arkansas Tech University - Arkansas Mining and Mineral Resources Research Institute for the 1987-89 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: nine (9), when needed, at rates of pay not to exceed the rate of pay for comparable positions authorized by this Act, by the Uniform Classification and Compensation Act, and by the Higher Education Employee Classification and Compensation Act, or their successors, and all laws amendatory thereto."

SECTION 3. Item (24.1) of Section 1 of Act 957 of 1987 is hereby amended to read as follows:

"(24.1) Ass't Director of Planning and Management 1 29,170"

SECTION 4. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Sixth General Assembly, meeting in Third Extraordinary Session, that the passage of this Act is necessary for the continued operation of Arkansas Tech University and the Arkansas Mining and Mineral Resources Research Institute. Therefore an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health, and safety shall be in full force and effect from and after its passage and approval.
