HOUSE BILL 1150

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 10-3-603 TO PROVIDE FOR THE
9 SELECTION OF CO-CHAIRMEN OF THE JOINT COMMITTEE ON
10 LEGISLATIVE PRINTING REQUIREMENTS AND SPECIFICATIONS; AND
11 FOR OTHER PURPOSES."

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15 SECTION 1. Arkansas Code 10-3-603 is hereby amended to read as
16 follows:

17 "10-3-603. Meetings - Officers - Compensation.

18 The committee shall meet subsequent to the adjournment of each regular
19 session of the General Assembly, at a time to be determined jointly by the
20 Speaker of the House and the President Pro Tempore of the Senate, and shall
21 select from its membership two (2) co-chairmen, one (1) co-chairman to be a
22 member of the House of Representatives to be elected by the members of the
23 committee who are members of the House and one (1) co-chairman to be a Senator
24 to be elected by the members of the committee who are members of the Senate.
25 The Committee may elect such other officers as it deems necessary for the
26 performance of its duties.

27 The two (2) co-chairmen shall preside at each meeting of the committee
28 or may rotate from meeting to meeting as presiding officers as they determine.
29 A majority vote of the full membership of the committee shall be necessary to
30 take final action on any matter. The committee may establish rules for its
31 procedures and shall meet upon call of the co-chairmen thereof, upon call by a
32 majority of its members, or at other intervals as may be established in its
33 rules.

34 Members of the committee shall receive per diem for attending meetings
35 of the committee or other official business of the committee at the rate
36 provided by law for attendance by members of the General Assembly at meetings

1 of joint interim committees and in addition shall receive mileage for travel
2 in attending meetings or other official business of the committee at the rate
3 provided by law for state employees.

4 Per diem and mileage of members of the Joint Committee on Legislative
5 Printing Requirements and Specifications shall be paid from any appropriation
6 made for paying per diem, expenses and mileage of members of the joint interim
7 committees."

9 SECTION 2. All provisions of this act of a general and permanent nature
10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
11 Revision Commission shall incorporate the same in the Code.

13 SECTION 3. If any provision of this act or the application thereof to
14 any person or circumstance is held invalid, such invalidity shall not affect
15 other provisions or applications of the act which can be given effect without
16 the invalid provision or application, and to this end the provisions of this
17 act are declared to be severable.

18

19 SECTION 4. All laws and parts of laws in conflict with this act are
20 hereby repealed.

21

22 SECTION 5. EMERGENCY. *It is hereby found and determined by the General*
23 *Assembly that it is immediately necessary to provide for the selection of co-*
24 *chairmen of the Joint Committee on Legislative Printing Requirements and*
25 *Specifications and that until this Act becomes effective the selection cannot*
26 *occur. Therefore, an emergency is hereby declared to exist and this Act being*
27 *immediately necessary for the preservation of the public peace, health and*
28 *safety shall be in full force and effect from and after its passage and*
29 *approval.*
