The Arkansas Crime Commission created under Arkansas Code 18 19 12-7-101 is abolished; and Arkansas Code 12-7-101 through 12-7-106 is 20 repealed. 21 22 SECTION 3. (a) The Arkansas Museum and Cultural Commission created 23 under Arkansas Code 13-5-303 is abolished; and Arkansas Code 13-5-303 through 24 13-5-306 is repealed. 25 (b) Arkansas Code 13-5-321(a) is amended to read as follows: "(a) The Director of the Department of Parks and Tourism is authorized 26 27 to employ such full-time or temporary professional, technical, and other 28 consulting services as the director shall determine necessary or desirable in 29 assisting the department to carry out effectively the authorities, functions, 30 powers, and duties conferred and imposed upon it by this subchapter." 31 (a) The Board of Advisors for the Development of Research 32 33 in Higher Education created under Arkansas Code 6-61-804 is abolished; and 34 Arkansas Code 6-61-804 through 6-61-806 and 6-61-809 are repealed. (b) Arkansas Code 6-61-803 is amended to read as follows: 35 36 "6-61-803. Arkansas Research Development Program created -

The Arkansas Commission on Human Resources created under 16 Arkansas Code 20-2-101 is abolished; and Arkansas Code 20-2-101 through 20-2-17 106 and 25-17-101(b) are repealed. 18 19 The Occupational Education Advisory Committee created under SECTION 10. 20 Arkansas Code 6-61-306 is abolished; and Arkansas Code 6-61-306 is repealed. 21 22 SECTION 11. The Pea Ridge National Park Commission created under 23 Arkansas Code 22-7-218 is abolished; and Arkansas Code 22-7-218 through 22-7-24 220 are repealed. 25 SECTION 12. The Pension Review Board created under Arkansas Code 24-1-26 27 103 is abolished; and Arkansas Code 24-1-101 through 24-1-104 are repealed. 28 SECTION 13. The Teacher Career Development Commission created under 29 30 Arkansas Code 6-17-110 is abolished; and Arkansas Code 6-17-110 is repealed. 31 SECTION 14. All provisions of this act of a general and permanent 32 33 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 34 Code Revision Commission shall incorporate the same in the Code.
