Section 7 of Amendment 51 to the Arkansas Constitution, as amended, is amended to read as follows: "§ 7. Registration record files. 17 (a) In each county, the Permanent Registrar shall provide three active 18 19 Registration Record Files for all voters legally resident within that county: (1) the Permanent Registration File which shall contain, securely 20 21 fastened, all original copies of the Affidavits of Registration in 22 alphabetical order for the whole county without regard to precincts or other 23 districts; (2) a Precinct Registration File which shall contain, securely 2.4 25 fastened in binders suitable for locking, all duplicate copies of the 26 Affidavits of Registration or Supplement Record of Voting Form, arranged and 27 bound by precinct; and (3) a Precinct Registration File which shall contain, securely 28 29 fastened in binders suitable for locking, all triplicate copies of the 30 Affidavits of Registration or Supplement Record of Voting Form, arranged and 31 bound by precinct. The Permanent Registrar of each county may have made and executed an 32 33 additional copy of each Affidavit of Registration which shall be kept in 34 suitable binders and shall be used in the holding of school elections. In the 35 event any Permanent Registrar elects to keep and maintain such additional file

36 such Registrar is hereby authorized to photocopy all of the active Affidavits

- 1 of Registration heretofore executed and enter such copies in such additional
- 2 file to be used in school elections. Such additional Precinct File shall be
- 3 kept and purged in the same manner now provided by law for other registration
- 4 files.
- 5 (b) The Affidavits of Registration or Supplement Record of Voting Form
- 6 within the Precinct Registration Files shall be arranged in alphabetical
- 7 order; provided, that the Affidavits of Registration or Supplement Record of
- 8 Voting Form in all or in some of such Files may be arranged by street and
- 9 street number or on some other appropriate basis, and shall be so arranged at
- 10 the direction of the County Board of Registration.
- 11 (c) In each county, permanent registrars shall provide an inactive
- 12 registration file which shall contain all canceled original affidavits of
- 13 registration arranged in alphabetical order for the whole county without
- 14 regard to precinct or other districts. Each canceled affidavit of
- 15 registration will be maintained for a period of two (2) years, at which time,
- 16 and in accordance with instructions of the Auditor of State, it shall be
- 17 returned by the Permanent Registrar to the State Auditor. The State Auditor
- 18 will compile a record of the number of canceled affidavits of registration,
- 19 send a copy of each record to the Permanent Registrar and then destroy the
- 20 canceled affidavits of registration. (d) The appropriate Precinct
- 21 Registration File or Files containing the duplicate copies of Affidavits of
- 22 Registration or Supplement Record of Voting Form shall be delivered to the
- 23 polling places and used in all elections; provided, that the appropriate
- 24 Precinct Registration File or Files containing the duplicate copies of the
- 25 Affidavits of Registration or Supplement Record of Voting Form shall be
- 26 delivered to the polling places of the majority political party for use at
- 27 party primary elections of such party and the appropriate Precinct
- 28 Registration File or Files containing the triplicate copies of the Affidavits
- 29 of Registration or Supplement Record of Voting Form shall be delivered to the
- 30 polling places of the minority political party for use at party primary
- 31 elections of such party. Before being delivered to the appropriate County
- 32 Board of Registration or other lawfully designated election officials for use
- 33 at any election, the Affidavits of Registration or Supplement Record of Voting
- 34 Form in the Precinct Registration Files shall be securely fastened and locked.
- 35 (e) The County Board of Registration or other lawfully designated

1 election officials shall cause the appropriate Precinct Registration Files to 2 be at the polling places on the date of elections, and shall return them at 3 the close of the election to the office of the Permanent Registrar with the 4 ballot boxes. (f) If the legal residence of a voter is renamed, renumbered or annexed 6 the Permanent Registrar may change the name or number of the legal residence 7 on the voter's Affidavit of Registration and any other voting records. Within 8 fifteen (15) days after the records are changed to reflect the new name or9 number of the residence, the Permanent Registrar shall notify the voter by 10 mail that the change has been made." 11 SECTION 2. All provisions of this act of a general and permanent nature 12 13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 14 Revision Commission shall incorporate the same in the Code. 15 SECTION 3. If any provision of this act or the application thereof to 17 any person or circumstance is held invalid, such invalidity shall not affect 18 other provisions or applications of the act which can be given effect without 19 the invalid provision or application, and to this end the provisions of this 20 act are declared to be severable. 2.1 22 SECTION 4.
