INTENT. It is found and determined by the General Assembly 17 that Arkansas law provides an exemption from the Arkansas Gross Receipts Tax 18 for the gross receipts or gross proceeds derived from the sale of raw products 19 from farms, orchards and gardens, where the sale is made by the producer of 20 the raw products directly to the consumer and user; that this exemption was 21 always intended to include the sale of Christmas trees; that there has been 22 confusion over this exemption because the Christmas tree farmers were 23 erroneously classified by regulation as nurserymen; that a recent chancery 24 court decision declared Christmas tree farmers to be entitled to the 25 exemption; and that the purpose of this act is to clarify the law by stating 26 that Christmas tree farmers are not nurserymen. 27 SECTION 2. Arkansas Code 26-52-401(18)(F)(iv) is amended to read as 2.8 29 follows: 3 0 The provisions of this subdivision shall not be construed to 31 exempt sales by florists and nurserymen. As used in this subdivision, 'nurserymen' does not include Christmas tree farmers." 32 33 SECTION 3. All provisions of this act of a general and permanent 34 35 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

36 Code Revision Commission shall incorporate the same in the Code.

2	SECTION 4. If any provision of this act or the application thereof to
3	any person or circumstance is held invalid, such invalidity shall not affect
4	other provisions or applications of the act which can be given effect without
5	the invalid provision or application, and to this end the provisions of this
6	act are declared to be severable.

8	SECTION 5. All laws and parts of laws in conflict with this act are
9	hereby repealed.
