Arkansas Code 6-15-805 is hereby amended to read as follows: 18 "6-15-805. Legislative subcommittee. 19 (a) To assist the General Assembly, there is established the Joint 2.0 21 Interim Oversight Subcommittee on Educational Reform of the Joint Interim 22 Committee on Education to be composed of ten (10) members from the Joint 23 Interim Committee on Education, five (5) Senators and five (5) 24 Representatives. 25 (b) (1) The chairman of the Senate Education Committee shall appoint 26 the Senate members, and shall name the Senate's cochairman; (2) The chairman of the House Education Committee shall appoint 2.7 28 the House members, and shall name the House's cochairman. (c) The duties of the Joint Interim Oversight Subcommittee on 29 30 Educational Reform shall include, but are not limited to, the following: In consultation with the Director of the Department of Education, 31 32 review of the Office of Accountability; 33 (2) Review of policy issues affecting educational reform on or 34 before October 15 of the year preceding a regularly scheduled legislative 35 session;

(3) Sponsorship through the State Department of Education of

1 innovative education projects in conjunction with school districts, 2 cooperatives, institutions of higher education, the State Department of 3 Education, the State Board of Education, the State Department of Higher 4 Education, and the State Board of Higher Education, the Governor's Office and 5 private institutions. (d) A full-time staff person shall be provided by the Bureau of 7 Legislative Research for the subcommittee. (e) All provisions of this section shall expire on July 1, 1995." 8 9 SECTION 2. All provisions of this act of a general and permanent nature 10 11 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 12 Revision Commission shall incorporate the same in the Code. 13 14 SECTION 3. If any provision of this act or the application thereof to 15 any person or circumstance is held invalid, such invalidity shall not affect 16 other provisions or applications of the act which can be given effect without 17 the invalid provision or application, and to this end the provisions of this 18 act are declared to be severable. 19 20 SECTION 4.
